SUMMARY

Review the proposed art installation by Hampton Inn at 2355 Feather River Blvd.

DISCUSSION

The Art in Public Places/Oroville Beautification policy requires all new non-residential development projects to install public art equal to one percent (1%) of the estimated construction cost or contribute an in-lieu equivalent to the Art in Public Places/Oroville Beautification Fund.

The new Hampton Inn located at 2355 Feather River Blvd. has been constructed and has been issued a temporary use of occupancy, once the art requirement is met, they will be issued their final occupancy permit. The applicant proposed a Corten steel art display depicting Oroville's canyons.

Attached for review is the design for the artwork. Including a night view, day view and two location options.
