SUMMARY

The Oroville Arts Commission may consider the informational letter of from Ted Hanson, Frank Wilson and William Speer.

DISCUSSION

On April 13, 2021, the Oroville Arts Commission approved a NOFA request from local artists, Ted Hanson and Frank Wilson in the amount of \$40,000 for the historic Train House mural. At the August 10, 2021 meeting Arts Committee denied the request to change the original verbiage on the mural. Since that last meeting the artists have met with the building owner to discuss a compromise. The Artists and building owner have submitted a letter suggesting the wording "JORDAN CROSSING STATION" be added across the top section of the wall, centered across the vertical boards. This addition satisfies the building owner and artists.

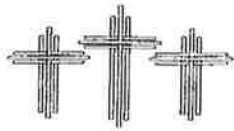

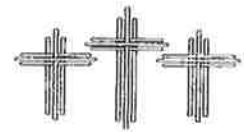

Dear City of Oroville Arts Commission Members,

Pastor Billy Spears, owner of the building at 1351 Lincoln Street that Ted Hanson and Frank Wilson are painting the Oroville Railyard mural on, has kindly suggested that he would like the wording; "JORDAN CROSSING STATION" across the top section of the wall, centered across the vertical boards, one letter per board. The lettering would be the same size, color and font as the sign at the upper portion that reads; "OROVILLE RAILYARD" which is typical of of the stenciled lettering used by the railroads that serviced Oroville.

The "OROVILLE RAILYARD" sign at the peak of the building would be left intact as is.

We are agreeable to this change and would like the Oroville City Arts Council to approve it as soon as possible so we can move forward with the design and execution of the mural.
