
THE SURREAL CREATIONS OF KAYLA GROZEA

The Oroville Arts Commission shall consider approving the request to issue a Notice of Funds Available (NOFA). This NOFA will provide funding opportunities to artists, organizations, or community groups for projects that support and enhance public art in the City of Oroville.

DISCUSSION

The City of Oroville has a longstanding commitment to promoting public art, culture, and creative expression as vital elements of our community. In line with this, the Community Development department has allocated funds to support public art initiatives for the fiscal year 2024-25.

These funds are intended to promote artistic creativity and innovation, foster cultural enrichment, and enhance the aesthetic appeal of the City through diverse art projects. The issuance of a NOFA will allow the City to solicit proposals from qualified artists and organizations, providing an open and transparent process for the distribution of funds.

The NOFA will outline the total available funding, eligibility criteria, and application procedures. The funds will be awarded through a competitive selection process.

Proposals will be reviewed and scored based on their artistic merit, community impact, feasibility, and alignment with City goals. The selection committee, comprised of representatives from the Art Commission and city staff, will make funding recommendations to the Commission.

FISCAL IMPACT

The NOFA to be issued will be in an amount not-to-exceed \$40,000.
