



## FY 2022 Budget Assumptions

- No change in millage rate
- Revitalization/Beautification strategy
- · Staffing level changes will be similar to FY 2021 level
  - Addition of an Internal Auditor (contract position)
  - Addition of two Community Service Aides (BSO)
  - Addition of part-time Administrative Specialist
- Tight cost controls
- Assumes a merit and COLA

## FY 2022 Budget Assumptions

- Potential increase in electricity costs
   FP&L recommends a 10% increase
- · Water & Sewer rate increases based on annual CPI 4.2%
- Establishment of Recreation Non-Resident Rate
- Postage rate increase of 1.6%
- Potential increases in new contracts/higher rates due to inflationary pressures (chlorine, fuel, construction materials)
- · E-Permitting implementation
