## DECLARATION OF EMERGENCY IMPLEMENTING LOCAL EMERGENCY PROTECTIVE MEASURES AND IMPLEMENTATION OF GOVERNOR'S DECLARATION OF A PUBLIC HEALTH STATE OF EMERGENCY AND ADDITIONAL PRECAUTIONARY MEASURES

WHEREAS, due to the communicable nature of the coronavirus known as COVID-19 and due to public health consequences necessitating social distancing policies and potential transmission of the virus and consistently with previous resolutions and declarations, the Mayor and Council of the City of Tybee Island resolves the following restrictions which shall be put in place as identified below:
