Monday, December 14, 2020 -5:30 p.m.

City Manager Andres Garza, Jr., declared a meeting of the City Council Finance Committee duly open for the transaction of business at 5:38 p.m.

Committee Members present were: Mayor Tim Barker, Councilmember Alice Heard and

Councilmember Russell Machann.

Committee Member absent was: None.

City Council Member present was: None.

Staff members present were: City Manager Andres Garza, Jr., Assistant to the City

Manager Brandi Jimenez, Finance Director Joan Andel and

Community Development Director Gwyn Teves.

Visitors: None.

Public Comments. There were no public comments.

The first item on the agenda was to review and consider minutes from the meeting held November 23, 2020. Councilmember Russell Machann made a motion to approve the minutes as presented. Mayor Tim Barker seconded the motion. All voted in favor.

The second item on the agenda was to review and consider Resolution: A resolution authorizing publication of Notice of Intention to issue Certificates of Obligation. Finance Director Joan Andel stated to the Committee that the City Staff had been working with Mr. James Gilley of U.S. Capital Advisors LLC, the City's financial advisor, and Tom Sage, bond counsel with Hunton Andrews Kurth LLP, regarding the intention to issue certificates of obligation for the State Infrastructure Bank (SIB) loan thru the Texas Department of Transportation (TxDOT) for the Extension of FM1301 from SH 60 to US 59 in Wharton. She stated that the notice is required to be published once a week for two (2) consecutive weeks, the date of the first publication is to be at least fortysix (46) days before the date of the passage of the ordinance authorizing the issuance of the certificates of obligation. She stated that this item was taken to the City Council for approval on September 14, 2020 and was approved but due to the TxDOT Commission not being able to complete its approval process until January 28, 2021, it is necessary that the City re-publishes the notice to meet the required responsibility. After some discussion, Councilmember Russell Machann made a motion to recommend to the City Council the authorization of publication of Notice of Intention to issue Certificates of Obligation. Mayor Tim Barker seconded the motion. All voted in favor.

The third item on the agenda was to Discuss and consider approving one or multiple firms as eligible for construction contracting, having been the lowest qualified bidder(s) for the City of Wharton's bid solicitation under the Floods Housing Assistance Program – GLO CDBG-DR Contract # 19-076-050-B70":

A. Resolution: A resolution of the Wharton City Council awarding a contract for construction for the 2016 Community Development Block Grant-Disaster Recovery (CDBG-DR) Grant Programs administered by the Texas General Land Office (GLO) and authorizing the Mayor of the City of Wharton to execute all documents related to said award.

Community Development Director stated that on August 27, 2018, the City of Wharton City Council approved resolution number 2018-66 approving the City Staff to submit an application for the CDBG-DR 2016 Floods Program. She stated that on February 4, 2019, the Mayor was notified that the City had been awarded the Community Development Block Grant - Disaster Recovery (CDBD-DR) funds in the amount of \$2 million dollars for the CDBG-DR 2016 Floods Program. She stated that this funding would assist homeowners with elevation, rehabilitation and reconstruction of homes to address existing damage and mitigate future damage. After some discussion, Councilmember Alice Heard made a motion to recommend to the City Council to award a contract for construction for the 2016 Community Development Block Grant-Disaster Recovery (CDBG-DR) Grant Programs administered by the Texas General Land Office (GLO). Councilmember Russell Machann seconded the motion. All voted in favor.

The fourth item on the agenda was to review and consider a Request from Texas Department of Transportation (TxDOT) for right-of way (ROW) for the proposed traffic signal upgrade at SH 60 and FM 102. City Manager Andres Garza, Jr. stated to the Committee that Mr. Jeffery Vinklarek, P.E., Director of Transportation Planning and Development TxDOT-Yoakum District had contacted him regarding the request of right-of-way for the proposed traffic signal upgrade at SH 60 and FM 102. He stated that in accordance with the Texas Administrative Code Title 43, Part 1, Chapter 15, Subchapter E. Federal and State and Local Participation, Section 15.55, that TxDOT was requesting from the City of Wharton, a fixed amount of the estimated cost of right-of-way acquisition and eligible utility adjustments. He stated that the estimated cost for the project is as follows:

RCSJ 0089-10-029 SH 60 City of Wharton, ROW Total Estimated cost is \$19,000.00. The City is responsible for 10% which would be \$1,900.00 and TxDOT is responsible for 90% which is \$17,100.00.

He stated that TxDOT would like to start acquiring the right of way after the new year, and they were needing the City's portion before the project starts. After some discussion, Councilmember Russell Machann made a motion to recommend to the City Council the approval of the costs in the amount \$1,900.00 to TxDOT for ROW for the proposed traffic signal upgrade at SH 60 and FM 102. Councilmember Alice Heard seconded. All voted in favor.

The fifth item on the agenda was to review and consider City of Wharton USDA Water Well – CR 222 Progress Update. The City Staff gave an update to the Committee on the City of Wharton USDA Water Well – CR 222 Progress. After some discussion, no action was taken.

The sixth item on the agenda was adjournment. Councilmember Russell Machann moved to adjourn. Councilmember Alice Heard seconded the motion. All voted in favor.

The meeting adjourned at 6:05 p.m.

City Manager Andres Garza, Jr., declared a meeting of the City Council Finance Committee duly open for the transaction of business at 5:40 p.m.

Committee Members present were: Mayor Tim Barker and Councilmember Russell Machann.

Public Comments. There were no public comments.

The first item on the agenda was to review and consider Ordinance: An ordinance approving an amendment to the City of Wharton Budget October 1, 2019 - September 30, 2020. Finance Director Joan Andel presented to the Committee the amendment to the City of Wharton Budget for the 2019-2020 Fiscal Year. After some discussion, Councilmember Russell Machann made a motion to recommend to the City Council the approval of the amendment to the City of Wharton, Texas, Budget for the 2019-2020 Fiscal Year. Mayor Tim Barker seconded the motion. All voted in favor.

The second item on the agenda was to review and consider Resolution: A resolution of the Wharton City Council implementing the second phase of City Employee Salary Adjustments and authorizing the City Manager of the City of Wharton to execute all documents related to said implementation. Finance Director Joan Andel stated to the Committee that the City Council approved in the FY2021 Budget employee salary increases. She stated that the City Staff had evaluated the revenue for the period of October 2020 thru December 2020 and that the amount received is very comparable to the same period last year. After some discussion, Mayor Tim Barker made a motion to recommend to the City Council to implement the second phase of the City Employee Salary Adjustments. Councilmember Russell Machann seconded the motion. All voted in favor.

The third item on the agenda was to review and consider Resolution: A resolution of the Wharton City Council amending City of Wharton Resolution No. 2020-39 for the continuation of the City of Wharton Temporary Policy and Procedures: HR 6201 Families First Coronavirus Response Act (FFCRA) and Emergency Paid Sick Leave (ESick) Act & Emergency Family and Medical Leav (EFMLA) Expansion Act and setting an effective date. City Secretary Paula Favors presented to

the Committee the draft policy to continue to provide guidance and instruction to employees on how to manage time away from work if a leave of absence is needed in accordance with the Emergency Paid Sick Leave Act (ESick) and the Emergency Family and Medical Leave (EFMLA). She stated that the current policy expired on December 31, 2020 and she requested that the City Council consider allowing the policy to continue until March 31, 2021. She stated that the qualifications would remain as stated in the policy that expired on December 31, 2020. They were as follows:

- 1. Employee is subject to a Federal, State or local quarantine or isolation order related to COVID-19:
- 2. Employee has been advised by a health care provider to self-quarantine due to concerns related to COVID-19;
- 3. Employee is experiencing symptoms of COVID-19 and is seeking a medical diagnosis;
- 4. Employee is caring for a family member who is subject to (1) or (2);
- 5. Employee is experiencing any other substantially similar condition specified by the Secretary of Health and Human Services in consultation with the Secretary of the Treasury and the Secretary of Labor.
- 6. Employee is caring for a son or daughter of such employee if the school or place of care of the son or daughter has been closed, or the child care provider of such son or daughter is unavailable, due to COVID-19;

She stated that since April 13, 2020, the City had paid over 1,200 hours of Esick to those employees who qualified. She requested to continue this temporary policy until March 31, 2021 to allow those employees who may be affected by the Coronavirus and that meet the qualifications to have a continuation pay up to 80 hours of pay for full time employees and up to *60 hours of paid leave for part time employees at the regular rate of pay. She stated that the time would be calculated from April 13, 2020 and those that have not used the full designated amounts of leave would still have the time available. After some discussion, Councilmember Russell Machann made a motion to recommend to the City Council to amend City of Wharton Resolution 2020-39 for the continuation of the City of Wharton Temporary Policy and Procedures: HR 6201 Families First Coronavirus Response Act (FFCRA) and Emergency Paid Sick Leave (ESick) Act & Emergency Family and Medical Leave (EFMLA) Expansion Act. Mayor Tim Barker seconded. All voted in favor.

The fourth item on the agenda was adjournment. Councilmember Russell Machann moved to adjourn. Mayor Tim Barker seconded the motion. All voted in favor.
