• 1,680 Man hours – Winter Pruning, maintenance, removal, hauling brush.

## **Horticulture Updates:**

- Grand Prairie Fire Station #1
  - On January 15<sup>th</sup>, 2021 we replace a tree that had died during the spring of 2020 in front of the Fire Station along Main St.
  - o 1 3" Cedar Elm at the cost of \$770.00
- Park & Ride (located along I30, east of Beltline rd.)
  - On January 25<sup>th</sup>, 2021 we completed Phase 1 tree replacements.
    - 7 Cedar Elm Tree's and 4 Natchez Crape Myrtles at a cost of \$4,980.00
- Mike Lewis Park Erosion Improvement (located along the Trinity River)
  - On January 26<sup>th</sup>, 2021 we completed Phase 1 Streambank Stabilization. This was funded by the Grand Prairie Utility Services Department at the cost of \$8,930.00. This planting spans 170' along the Trinity River with 72 native trees and grasses.
    - 2 Texas Red Oak, 2 Blackjack Oak, 2 Cedar Elm, 2 Texas Red Bud, 20
      Creeping Vitex, 9 Possum Holly, 35 White Honeysuckle.
- Tree City USA
  - Application has been approved by Tree City USA! We will receive the official certificate for our 37<sup>th</sup> year in the coming days.
