Safety is our Number 1 goal in the Parks Department. We do the best we can to make the parks as safe as we can.

- The large parks Hammon, Hewitt, Centennial, Sank, Bedrock, and Rotary Park are all signed consistently.
- We have and are trying to keep the bathrooms open in parks more. It is still a
 battle with people wanting to camp in them, use them for the wrong reasons, or
 camp at the park in their cars and use them as their personal wash station. If the
 park is rented the restrooms will be clean and opened. I am very hopeful we
 have success with the Portland Loos so they will become the future in the parks.
- Lighting has become a hot topic. We have increased lighting in Sank Park. We have 3 motion lights in Sank Park. We are looking at additional lighting in the park as well. Bedrock Park does not currently have electricity. Hewitt Park has no lights. This will be addressed during the renovation with lights that are vandal resistant. Rotary and Hammon Park appear to be lighted adequately. I am hesitant to introduce strobe lights without a City Attorneys blessing due to fear of liability issues. We will continue to work on lighting in the parks.
- The City has no tennis courts to light.
- Motion loitering detectors and thermal sensors seem a little extreme to me. Who would monitor them? These applications can be very expensive.
- We have had cameras in some of our parks along with the Pioneer Museum, Bolt Antique Tool Museum, and the Lott Home for quite a few years. These cameras are in need of a major upgrade. We are currently looking into cameras on the interior and exterior of the Lott Home at Sank Park. We are trying to work with a local reputable company to see if this is feasible and potentially expand it to other parks.
- Discussing private security with FRRPD and our Code Enforcement Department, neither one was in favor of private security. For an 8-hour shift to patrol a couple parks is over \$5,000 a month. This is just for them to drive around; this doesn't include them getting out of their car. FRRPD didn't feel the security presents was worth the price.

Priority 2 is also a work in progress. Lighting, benches, dog walking area, nature walks with in Hewitt Park, art, and new attractions. I feel all this is covered in the Hewitt Park design that will break ground soon. I know this is just one park out of many, but it is a start.

The City has spent a lot of resources trying to open up access and views to the river. We have had Cal Fire inmate crews, the City Works crew, City equipment, and most recently, the goats along the bike path removing vegetation to try and make the area more attractive. Again, this still a work in progress.

The City is looking at budgeting for the next fiscal year new trash cans throughout downtown and new benches. We can look into the placement of new trash cans along the levee and at Soroptimist Park along with Recology. Recology dumps all trash cans.

This is a partial response to some of the Priorities provided to Staff by the Park Commission. I feel some things can be accomplished easily, while some will take a long time or maybe not at all. There are so many entities that come in to play when you start discussing a boat ramp at the Nature Center or installing new trails along the river.

SUMMARY

The Commission will review new renderings of Hewitt Parks, phase II produced by the Project Manager Melton Design Group.

DISCUSSION

California State Parks released Round 4 of the Statewide Parks Program funding. The mission of the California Department of Parks and Recreation (DPR) is to encourage healthy communities by connecting people to parks by creating new parks and new recreation opportunities in critically underserved communities.

The City of Oroville was rewarded funding to complete Hewitt Park, Phase II, located at 2101 Baldwin Ave. Oroville, CA. Construction will include a new spray park, tot playground (2-5 yr olds), children's playground (5-12 yr olds), eight new pickleball courts, adult basketball court and one youth basketball court, multi-use pathway system with fitness stations, two picnic areas (small and large) with shade pavilions and play elements, two hill slides, fencing with two interpretive stations, a dog park, and landscaping throughout the park. Renovate the existing tot lot, meadow area, parking lot, and renovate lighting throughout the site. The City of Oroville anticipates the completion of this large project by 2024.

Two community meeting will be held to view new renderings and encourage public input for Hewitt Park. The conceptual options were formed by community input and hope to engage the public in exchanging ideas to better improve Hewitt Park. These designs will be used to guide final project design. This is an excellent time to not only provide suggestions, and voice your concerns, but to be a part of shaping the future of Parks in Oroville. Your ideas and participation are valued!



MASTER PLAN - OROVILLE




















