SUMMARY

The Commission will review new renderings of Hewitt Parks, phase II produced by the Project Manager Melton Design Group and receive community input.

DISCUSSION

California State Parks released Round 4 of the Statewide Parks Program funding. The mission of the California Department of Parks and Recreation (DPR) is to encourage healthy communities by connecting people to parks by creating new parks and new recreation opportunities in critically underserved communities.

The City of Oroville was awarded funding to complete Hewitt Park, Phase II, located at 2101 Baldwin Ave. Oroville, CA. Construction will include a new spray park, tot playground (2-5 years old), children's playground (5-12 years old), eight new pickleball courts, adult basketball court/futsal and one youth basketball court, multi-use pathway system with fitness stations, two picnic areas (small and large) with shade pavilions and play elements, two hill slides, fencing with two interpretive stations, a dog park, and landscaping throughout the park. Renovate the existing meadow area, parking lot, and renovate lighting throughout the site. The City of Oroville anticipates the completion of this large project by 2024.

Two community meetings will be held to view new renderings and encourage public input for Hewitt Park. The April 12^{th,} 2022, regular Parks Commission meeting served as the 1st meeting, and this will be the 2nd meeting scheduled to receive community input on the final design.

The conceptual options were formed by community input in 2021 by engaging the public in exchanging ideas to better improve Hewitt Park. These designs will be used to guide final project design. This is an excellent time to not only provide suggestions, and voice your concerns, but to be a part of shaping the future of Parks in Oroville. Your ideas and participation are valued!
