Additional discussion about various jurisdictions occurred and what the actual purpose of this committee would be. Chairperson Pittman suggested that because of the multi-agencies that have parks and trails within the Oroville area that this should perhaps be a function of ORAC or the future RAC committee.
- 2. Draft letters to supporting agencies: After discussion it was determined that the letters would not be sent, however a supporting letter would be prepared and sent to FERC. The intention of the SBF Steering Committee was that a draft letter would be brought back for discussion at the next quarterly SBF meeting. The letter was prepared and mailed to FERC prior to bringing it back for discussion. Vice Chairperson, DeLong was concerned that this action does not foster working together. Committee member, Brandt indicated that any letter to FERC should have included a request to renegotiate the terms of the Settlement Agreement and Appendix B.

Re: Oroville Lights project update for presentation to the SBF Steering Committee 10/25/23

Mr. Marciniak,

I am pleased to present you with this project update. Attached in the email containing this letter, you will find links to supporting materials, visuals and our latest architectural "flyby" video by Melton Design Group (MDG). There may be more than you require at this link, but please feel free to print or download any materials you wish to share with the committee.

Here are several highlights of our progress thus far:

- Fundraising is currently at \$260,000., \$290,000\* which includes a recent \$10,000 donation from the Mooretown Rancheria. Our goal remains \$500,000 for phase 1 (west side) installation.
- Over 100 lights (of 1400+) have been dedicated by personal donors.
- A grant application is currently under consideration as per a City of Oroville NOFA issued by the Arts
  Commission. The grant application asks for \*\$30,244.85 of \$40k available. We anticipate at least a
  partial funding in this round with, perhaps, additional in future. Grant has been awarded in FULL!
- We are working with Rotary District 5180 for grant funding and donations from over 40 clubs in the greater Sacramento. Rotary grants are funded in the same calendar year as completion of project.
- Our fundraising opportunities have nowhere to go but up!
- Costs associated with Phase 1 include, but is not limited to: design and engineering, marketing/ advertising, website development, permit fees, reports, studies, acquisition of lighting products and associated hardware, controllers, boxes, panels, new metered PG&E connection, brackets and attachments, labor, equipment rental, insurance and/or bonds (if required), professional fees, etc.
- Phase 1 equipment and install is planned to accommodate expanded lighting installation, specifically phase 2 & 3 (east side installation & pedestrian path overhead lighting).
- Timeline to begin constitution Q2 2024, ideally April. Completion in calendar year 2024.
- Obtained the services of Melton Design Group for architectural renderings, blueprints & engineering. They will also lead permitting processes with Butte County Public Works (for bridge installation) and City of Oroville Public Works (for city side installations).



- Preliminary drawings by MDG will be submitted to BCPW and CofOPW in the next few weeks. Both county and City of Oroville remains cooperative and helpful in the process. Will update this committee when encroachment permit(s) have been issued.
- We've met with PG&E on two occasions thus far to determine connection points and installation of a new box meter, location of which has been identified on south end.
- Fellow Rotarian, and Electrical Contractor, Williams Electric has been advising on most practical power run from meter connection points on the bridge.
- Our product supplier for LED nodes, LED floods, light controls, and connection hardware is Wunder Lighting & Controls, LLC (<a href="https://www.wunderlc.com">https://www.wunderlc.com</a>). A BOM (Bill of Materials) has been determined at an initial cost estimate in the low \$180k. Hardware specified will also accommodate future phase 2 & 3 installations (east side and overhead, respectively).
- Wunder has been onsite to demonstrate product, light placement, and spacing of LED nodes. We've settled on 12" on center, in a configuration as illustrated below.
- The potential for vandalism has been top of mind since conception and considerations are being taken in every step. Nodes will be placed out of reach of the casual passerby; floods installed in enclosed or inaccessible areas; conduits will be run overhead wherever possible, and sub panels and control boxes will be placed under the bridge wherever possible.

On behalf of the Rotary Club of Oroville, and myself personally, sincere thanks to you and the SBF steering committee for your support of this historic project. We remain dedicated to the success of this project now, and well into the future. You may reach out to me at any time with questions, concerns or ideas on the Oroville Lights project.







Dear Ms. Bose:

In March 2006, the City of Oroville, as well as more than 50 other parties, entered into a settlement agreement relating to the licensing of the Oroville Dam. We write to express our concern and disappointment with the lack of progress related to license issuance. We request FERC's immediate action to move the licensing forward, with a licensing condition upon the successful mutual renegotiation of the financial arrangement outlined by the settlement agreement.

The settlement agreement, in pertinent part, acknowledges the impact of the Oroville Dam on the recreational opportunities that were previously enjoyed by the Oroville residents prior to its construction, and it provides a funding mechanism to mitigate those impacts. It is axiomatic that the parties did not anticipate that the license would remain unissued after 17 years!

The impact of the delay on the greater Oroville area is significant. The 17 year delay has unilaterally modified the settlement agreement from a 50 year agreement to a 67 year agreement by the mere delay in license issuance. Assuming FERC issues a 50 year license, this alone reduces the valuation of the settlement by 34%!

Further, there has been no adjustment to the settlement amount to account for the actual inflation which has occurred since execution of the settlement agreement. According to the Bureau of Labor Statistics consumer price index, the dollar has experienced an average inflation rate of 2.47% per year between 2006 and today, producing a cumulative price increase of 51.34%. This means that today's prices are at least 1.51 times higher than the those in 2006.

When combined, the delay in license issuance and resulting devaluation of the value of the settlement agreement results in a significant reduction of projects that can be funded through the Supplemental Benefits Fund. This cuts against the purpose of the settlement agreement, which is to replace the recreational opportunities that were lost when the Oroville Dam was built.

As you are likely aware, the initial approval of the Oroville Dam in 1968 included promises for recreational improvements and projects, many of which did not materialize. The settlement agreement was a concerted effort among the parties to pay for, and codify a process to approve, recreational projects in the vicinity of the Oroville Dam. Given the significant delay in issuance of the license, and the attendant delay in SBF funding, the citizens of Oroville feel as this is yet another broken promise.

The Oroville Dam is operational. The Dam is storing water and providing it to the State Water Contractors. The Dam is producing electricity. Those who own and operate the Dam are receiving all of the benefits of the Oroville Dam despite the fact that a license has not been issued. This inequity is patently unfair to the Oroville citizens who are required to suffer all of the impacts of the Dam without any of the negotiated benefits contained in the settlement agreement.

As a result, the City of Oroville requests that FERC issue a 50 year license with a retroactive date to March 2006. This will provide all of the benefits to the Oroville citizens that were agreed upon through the settlement agreement. In addition, the City requests FERC's support of an adjustment of the settlement terms to account for inflation and the delay in issuance.

Thank you for your attention to these important matters. We look forward to your timely anticipated response.
