SUMMARY

The Oroville Area Chamber of Commerce (Chamber) has requested consideration for funding in the amount of \$30,000 from unallocated SBF funds.

BACKGROUND

The SBF Regional Fund Strategic Plan (RFSP) provides for annual funding to the Oroville Area Chamber of Commerce (OACC) in the amount of \$60,000 to be exclusively used for tourism and community event activities once the license for FERC Project 2100 is approved.

Pending license approval the SBF on a request basis from the (Chamber) and dependent on available advance funds has provided \$318.549.35 for tourism and community event related activities.

The request is attached it details how the funds would be utilized to continue and expand the program of work at the community's tourism and communication center. Funds would be used to promote the Historic Downtown District using multiple resources of Digital Marketing. The Chamber received an allocation of \$30,000 for this purpose in 2022 providing a quarterly report detailing the reaches and benefits of the program.

2023 CALL FOR COMMUNITY IDEAS FOR POTENTIAL PROJECTS

The Supplemental Benefits Fund (SBF) is a part of the Settlement Agreement that was signed in 2006 by fifty stakeholders in the Greater Oroville Area with the California Department of Water Resources (DWR) regarding the re-licensing of Lake Oroville (FERC Project No. 2100). ¹

The final approval of FERC Project No. 2100, based on the license years, will determine the long-term funding for projects by the Supplemental Benefits Funds. DWR, in the interim sixteen years, has provided a total of \$11,170,000 of upfront funds. \$6,070,000 has been used by the SBF for projects, marketing the region, improving tourism, studies and administration all of which have benefited the Greater Oroville Area.² Additional direct payments of \$5,100,000 were made to the Feather River Recreation & Park District for the first two phases of Riverbend Park. Final funding, per the Settlement Agreement, will only occur once the re-licensing is approved.

The SBF currently has limited funds and is allocating \$100,000 by issuing the ...

To the SBF Steering Committee:

Listed below are some ideas for small projects that would greatly enhance user experience on the Brad Freeman Trail. In addition to the improvements to the Brad Freeman Trail (BFT) under the Table Mountain Bridge, which has already been considered by this committee, these projects focus on the BFT near Downtown Oroville, up to the Thermalito Diversion Pool.

Currently, there are large sections of the BFT that are underutilized by the recreating public, due to numerous factors, some of which include: a) Deteriorating trail surface. b) Lack of signage, or misleading signage in some cases. c) Sections of the trail that are inundated with goathead thorns, which renders those sections of the trail unrideable on a bicycle due to the risk of tire punctures.

Listed below are some ideas for improving the trail. See attached photos included with this letter for reference.

1) Finish the Brad Freeman Trail (BFT) connection under the two Table Mountain Bridges, across the river from the fish hatchery (Already addressed by the SBF Steering Committee.)

Additionally, there is no signage on the Table Mountain pedestrian bridge itself to point in the direction towards the Brad Freeman Cutoff Trail (See item #4 below.)

- 2) Fill in the large potholes on the old railroad grade section of the BFT, especially at the west entrance to the old RR tunnel, where huge puddles form every winter, and makes easy access to the tunnel difficult. 3/4" or smaller crushed gravel would be ideal. We are aware of the plans for DWR to lay underground cable along this section, but apparently that project is on hold, and it would be nice to have a gravel surface similar to the Burma Road section of the BFT on this section in the meantime.
- 3) Likewise, apply a few inches of gravel to the goathead (Caltrops, puncture vine) and puddle filled "caged" section of the BFT, directly south of Cherokee Road. That hundred or so yard section is pretty much unrideable on a bicycle due to the aforementioned hazards.
- 4) The Brad Freeman Cutoff Trail, between Riverview Terrace and the west end of the bridge across the diversion canal on Cherokee Road is unsigned and hasn't been maintained in years. There are improperly placed "No Trespassing" signs on the Riverview Terrace side (it's state land), and no signage whatsoever along the trail's entire length. Additionally, there is a locked gate along the trail that needs to be climbed over.

Additionally, the BFT signage on the north side of is severely weathered, and almost unreadable, and a State of California "No Trespassing" sign is placed as to intimidate trail users on the north end of the Brad Freeman Cutoff Trail.

- 5) The end of the Burma Road section of the BFT has two imposing gates that have to be circumvented in order to continue on the BFT up to the Spillway Recreation Area. There is no signage on these gates to direct trail users to continue past the gates if they choose to continue on the trail. I (Gary) have encountered groups of hikers on two separate occasions that weren't sure if they could continue past the gates. I assured the hikers that it was okay, as long as they stayed on the BFT past that point. Some signage on these gates would be helpful.
- 6) Picnic Tables. More picnic tables would be welcome along the trails. Some ideas would be near the aforementioned tunnel entrance, at Glen Pond, and at the junction of the BFT and Dan Beebe trails, across the river at the spillway (39.5363462, 121.5050373). Additionally, a few more tables on the Burma Road side would be nice, too. Decommissioned wood tables from the LOSRA campgrounds would suffice; no need for costly concrete tables.

We are aware that maintenance and improvements to the BFT are really the responsibility of DWR and CA State Parks, but after 5 years of formal and informal requests to DWR and CA State Parks, little has been done to address these issues listed. We hope that some of the SBF funding can be directed towards the maintenance and improvements listed above.








