### Buttes Artist Mural Association: Price Guide and Rates for Mural Development

One of the biggest challenges artists have when it comes to commissioning and creating murals for clients is setting a base price for their work. Coming up with a clear-cut amount can be difficult when a mural requires a lot of time, material and communication between the artist and client. We will examine ways to create a price guide and set a consistent rate for artists for proposing and creating a mural.

### How artists price their murals:

#### 1. Sketch Drafts

Sketch drafts are drawing, sketches, and ideas for the mural proposed. Sketch drafts are important because they outline a mural's design and make the composition imaginable to the client before the project begins. The sketch draft makes it easier for a client to decide whether they'd like to continue working with the artist or choose a different artist instead. The price of a sketch draft ranges anywhere between 400\$ -1000\$ USD depending on the size and complexity of the mural proposed, with an added + 200\$ -500\$ USD for any extra changes made by the owner.

### 2. Material Costs

Murals require materials such as exterior/interior wall paint, spray paint, brushes, gloves, masks, varnishes, ladders, painting clothes, chalk, so on and so forth. Material costs usually depend on the condition and size of the wallspace. The material costs can range anywhere between 5\$ - 15\$ USD per square foot (Sacramento Area) depending on these factors. However, it is important to note that some artists prefer to simply include the material costs in the general pricing of their mural. Clients may also prefer to fix the more significant damage their walls have sustained prior to the artist working on it. Under these circumstances, the material costs should only be discussed with the client if the client has any questions about the general price of the mural.

#### 3. Labor Costs

A mural can take anywhere between a few hours to a few months depending on the size and the complexity of the work. Murals that are created by independent artists usually cost more than murals created by students or volunteers, because more work is allocated to a single person of higher skill. The cost of labor is usually calculated by price per square foot, with the price decreasing slightly the more square feet in a mural. The prices can range anywhere between 28\$ - 35\$ USD per square foot (Greater Sacramento Area), though this is subject to change based on what the going rates are in the county and state.

Stats

- When dividing the annual art commission budget of Sacramento with the number murals commissioned per square foot, Greater Sacramento Area Mural prices range a total of 30\$-60\$ USD per square foot.\* Note that most mural work commissioned by municipalities also tend to hire pre established and renowned artists, including artists from outside of the state of California.
- Greater Sacramento Area municipalities invest an average of 60% or more of their annual art commission budget on mural art alone.
- Butte County's face and tourist appeal relies heavily on its prevalence of public art, especially murals of historical or cultural relevance. After the hashing of # hiking and #wine, hashtag #mural while geotagging Chico and Oroville location garners most attention on social media platforms such as Instagram and Facebook.
- 50-60% of Butte County's murals come from independent contracts between artists and private contractors. Anywhere between 5-10% of murals in the county have been done voluntarily by artists at material cost or as community projects at material cost, far exceeding the national average.
- There is a statistical increase in all municipalities of Butte County on expenditure on public art contributing to an increase of out-of-state tourism and interest. The increase in public art expenditure coincides with the rise in real estate cost and housing prices, though there is no direct causal link between the two.

### **SUMMARY**
