Included equipment are a Cargo Mate Utility trailer, Megga Bagger and Wanco Metro Matrix message sign. This agreement with Whatcom County will transfer ownership of the equipment to the City. Councilmember Daniels made a motion to authorize the Mayor to sign the Agreement for Sale of Flood Response Property, Councilmember Postma seconded; all were in favor the motion carried.

#### 4. Voucher Approvals

The bills were presented for approval and payment. Check numbers 43112 through 43129 for \$113,706.84; EFTs in the amount \$128,824.75. Councilmember Postma made a motion to pay the bills, Councilmember Daniels seconded; all were in favor the motion carried.



Re: Engagement of Legal Services Relating to Nooksack River Adjudication

This engagement letter follows up my conversation with City Attorney Jim Wright on Thursday, March 7, 2024. He requested that I send this engagement letter to represent the City of Sumas in the upcoming Nooksack River (WRIA 1) water rights adjudication, which will be filed by the Department of Ecology in Whatcom County Superior Court in the coming months. The current boundary selected by the Department of Ecology for this adjudication includes the Sumas River basin, which is not tributary to the Nooksack.

By signing this letter below, the City is agreeing to retain my professional services to represent the City in the Nooksack adjudication. I agree not to represent another party in the adjudication which would result in a conflict of interest with the City, and to seek approval from the City for any new representation that has a potential for conflict.

My billing rate for this matter is \$390.00 per hour, which includes a discount for municipal clients. Invoices unpaid after 30 days incur interest charges at a rate of 0.75% per month. In addition to my hourly rate, I charge reimbursement for actual costs incurred, including but not limited to travel expense, if any, messenger and delivery fees, and \$0.10 per page for copies and facsimiles.

This representation may be terminated by either party, subject to court rules relating to the substitution of counsel. I will retain records pertaining to this representation for only four years from the date of termination, after which they will be destroyed at my discretion. MEMO: Proposed change for delinquent utility accounts.

#### Proposed changes:

- 1. Eliminate the hang-tag 24 hour notice that power will be shut-off due to delinquent payment. Instead, give written notice only with the mailed Utility Reminder Notice.
- 2. Require payment by 11:00 am instead of 12:30 pm on the last working day of the month to avoid a \$5 penalty.
- 3. Require payment by 11:00 am instead of 12:30 pm on shut-off days in order to avoid shut-off.

#### Reason for proposed changes:

- 1. Delivering hang tags is a time-consuming monthly task for Public Works.
- 2. Requiring payment by 11 am to avoid a penalty ensures consistency for our customers, since 11 am will also be the time payment is due to avoid shut-off.
- 3. Starting shut-offs at 11 am instead of 12:30 pm will allow our Public Works crew to shut-off electricity earlier in the day. This will then give customers more time to pay their bills and call City Hall to have electricity turned back on during normal working hours.

#### Background information – Current utility billing cycle structure:

- 1. Bills are issued the first week of the month, due on the 25<sup>th</sup> of the month.
- 2. If payment is not received by 12:30 pm on the 26<sup>th</sup>, a Utility Reminder Notice is sent out. (no penalty associated with the notice)
  - a. The notice says: Our records indicate you have a balance due. Please check your records to see if you have missed a payment. If payment is not received before the shut off date, you will receive a disconnection notice. Shut off will occur 24 hours later. The balance due plus a \$30.00 reconnect fee must be paid prior to reconnection of services. Please call 988-5711 with any questions.
- 3. If payment is not received before 12:30pm on the shut off date listed on the Notice, a \$5 penalty is added to the account, and a hang tag is hung on the door.
- 4. If payment is then not received before 12:30pm 24 hours after the hang tag is hung on the door, service is discontinued.

#### Proposed Updated utility billing cycle structure:

- 1. Bills issued the first week of the month, due on the 25<sup>th</sup> of the month (no change)
- 2. If payment is not received by 11:00am on the 26<sup>th</sup>, a Utility Reminder Notice will be sent out. (No penalty associated with the notice)
  - a. The notice would be changed to say: Our records indicate you have a balance due. Please check your records to see if you have missed a payment. If payment is not received before 11:00 am on the last working day of this month, a \$5 penalty will be added to this account. Shut off will occur on the second working Tuesday of next month. This is the only disconnection notice you will receive. The balance due plus a \$30.00 reconnect fee must be paid prior to reconnection of services. Please call 360-988-5711 with any questions.

## 12.08.050 Delinquent accounts.

If any residential consumer's account is not paid in full on or before the due date, and the consumer has not called to make arrangements to pay by the last working day of the month in which the payment was due by eleven a.m., the utility billing clerk shall add a five dollar penalty to the amount of the bill, and notify the consumer by written notice.

If any commercial or industrial consumer's account is not paid in full on the last date due, the utility billing clerk shall add a five dollar penalty to the amount of the bill, and notify the consumer by written notice.

The utility billing clerk shall have discretion regarding crediting accounts for mischarged penalties.

Twenty-four hours after the penalty date, the utility billing clerk shall furnish the names of all delinquent accounts to the electrical linemen and service shall be discontinued immediately. Service shall not be reconnected until the delinquent account, the penalty, and the reconnection charge are paid in full.

Any person having a delinquent account shall not receive service at any subsequent location, nor shall they receive service through use of the name of another until such delinquent account is paid in full. #### ORDINANCE NO. 1813

## AN ORDINANCE OF THE CITY OF SUMAS, WHATCOM COUNTY, WASHINGTON, AMENDING SECTION 12.08.050 OF THE SUMAS MUNICIPAL CODE REGARDING DELINQUENT ACCOUNTS

WHEREAS, the City of Sumas owns and operates its own electrical utility for the distribution and furnishing of electric energy within the City; and

WHEREAS, the City regularly reviews the operation of its electrical utility; and

WHEREAS, the City of Sumas has established certain procedures related to the operation of its electrical utility; and

WHEREAS, the City periodically reviews, updates and clarifies the procedures it has established; and

WHEREAS, the City Council has determined that the procedures set forth in section 12.08.050 of the Sumas Municipal Code regarding delinquent accounts of electrical utility consumers should be updated and improved as set forth in this ordinance; NOW, THEREFORE,

## THE CITY COUNCIL OF THE CITY OF SUMAS, WASHINGTON, DO ORDAIN AS FOLLOWS:

<u>Section -1.</u> Section 12.08.050 of the Sumas Municipal Code is amended to read in its entirety as follows:

#### 12.08.050 Delinquent Accounts.

If any residential consumer's account is not paid in full on or before the due date, the utility billing clerk shall notify the consumer by written notice that a five dollar penalty will be added to the amount of the bill at eleven a.m. on the last business day of the month in which the payment was due, and that if payment in full of the past due balance including the penalty, is still not received by the second Tuesday after the penalty date, by eleven a.m., the electrical service shall be discontinued. Service shall not be reconnected until the delinquent account, the penalty, and the reconnection charge are paid in full. If the consumer has not called to make arrangements to pay by eleven a.m. on the last business day of the month in which the payment was due, the utility billing clerk shall add the five dollar penalty to the amount of the bill.

If any commercial or industrial consumer's account is not paid in full on or before the due date, the utility billing clerk shall notify the consumer by written notice that a five dollar penalty will be added to the bill at eleven a.m. on the last business day of the month that the payment was due. The utility billing clerk will then add a five dollar penalty to the amount of the bill on the last day of the month that the bill was due if the delinquent amount has not been paid.

The utility billing clerk shall have discretion regarding crediting accounts for mischarged penalties.

If the account past due balance is not paid in full by the second Tuesday after the penalty date, at eleven a.m., the utility billing clerk shall furnish the names of all delinquent accounts to the electrical linemen and service shall be discontinued immediately. Service shall not be reconnected until the delinquent account, the penalty, and the reconnection charge are paid in full.

Any person having a delinquent account shall not receive service at any subsequent location, nor shall they receive service through use of the name of another until such delinquent account is paid in full.

<u>Section - 2 – Savings Clause</u>. The amendment of existing Section 12.08.050 of the Sumas Municipal Code does not affect any pending or existing litigation and does not operate as an abatement or bar an action or proceeding under or by virtue of the amended code section.

<u>Section -3 – Severability Clause</u>. Should any provision of this Ordinance or its application to any person or circumstances be held invalid, the remainder of the Ordinance or the application of provisions to other persons or circumstances are not affected.

<u>Section -4 - Effective Date</u>. This Ordinance shall take affect from and after the 5<sup>th</sup> date after the date of its publication.



#### **Federal Permitting Strategies**

The City of Sumas has multiple FEMA PA projects which will require environmental permit strategies to efficiently go through the federal consultation and permitting processes. These projects can be separated into four categories, culvert/bridge repairs to fish passage standards, roadway repair to local and federal standards, and utility repairs to local and federal standards. For the projects within water work prior to preliminary designs Widener & Associates will reach out to the local Tribes, USFW and NOAA to discuss repair and replacement options which work with the FEMA PA program and that the agencies will support through the Section 106 and Section 7 consultation processes. FEMA will then be contacted to ensure agency comments can be addressed for each project and the design team can move forward on the 40% design plans. Once 40% design plans are completed (as required by FEMA), Widener & Associates will begin on the proper analysis and applications needed for each project to submit to the USACE, DOE, USFW, NOAA, WDFW and the local Tribes. For the Guemes Channel Trail project we expect the following studies and permit applications:

- JARPA
- Biological Assessment
- HPA Application
- Mitigation and Monitoring Plan
- Cultural Resource Report

#### **FEMA Project Management**

The City of Sumas has multiple roadways, culverts, bridges and utility repair to current codes and standards projects whose current function and value need to be restored. Widener & Associates will assist the City in working through the FEMA PA process to become obligated not only for A&E funding (phase 0) but also construction funding (phase 1). This will include tracking invoices and documenting changes during construction per FEMA requirements.

The City of Sumas also has the W Second St Culvert & Headwall project which has the potential to be submitted as Alternate Project through the FEMA PA program. Meaning once a fixed-cost estimate for the project is completed, FEMA will transmit the estimate as a fixed-cost offer to the Applicant for consideration. When the Applicant accepts a fixed cost offer FEMA considers it an Alternative Procedures Project and the Applicant is able to purchase capital equipment that has a useful life of at least 1 year and is equal to, or greater than \$5,000 per unit. Widener & Associates will work with the City and FEMA to ensure the City receives the best fixed cost price for the alternate projects and will document this process in GrantsPortal through the EEI and Scope Survey questions.
