## ADOPTION OF RESOLUTIONS

- 5. ADOPTION of T.P. Resolution No. R24-18 A Resolution granting approval to Recreation District No. 3 of the Parish of Tangipahoa, State of Louisiana, for the issue, sale and delivery of not to exceed Three Million Six Hundred Thousand Dollars (\$3,600,000) limited tax revenue refunding bonds, in one or more series; and further providing for other matters in connection therewith Jim Ryan notified the council that the goal is to lower interest rate and save them money at no risk to the Rec District.
  - WHEREAS, the Board of Commissioners (the "Board"), acting as the governing authority, of Recreation District No. 3 of the Parish of Tangipahoa, State of Louisiana (the "District"), by resolution adopted May 14, 2024, has authorized the issuance of not exceeding Three Million Six Hundred Thousand Dollars (\$3,600,000) Limited Tax Bonds, in one or more series (the "Bonds"), for the purposes of (i) refunding all or a portion of its \$3,970,000 Limited Tax Revenue and Refunding Bonds, Series 2017, of which approximately \$3,355,000 is currently outstanding (the "Refunded Bonds"); (ii) funding a debt service reserve fund or paying the costs of a debt service reserve policy, if necessary; and (iii) paying the costs of issuing the Bonds, including the costs of bond insurance, if necessary (collectively, the "Refunding"); and WHEREAS, it is now the desire of the Parish Council of the Parish of Tangipahoa, State of Louisiana (the "Parish Council"), acting as the governing authority of the Parish of Tangipahoa, State of Louisiana (the "Parish"), to approve the issuance of the Bonds.

NOW, THEREFORE, BE IT RESOLVED by the Parish Council of the Parish, that:

**SECTION 1.** Parish Approval. In compliance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of the District, this Parish Council hereby approves the issuance of the Bonds, to be issued by the District, under its authority and for the purposes of the Refunding. The Bonds shall bear interest at a rate or rates not to exceed five percent (5%) per annum and shall mature no later than April 1, 2046.

**SECTION 2.** No Parish Liability. Neither the Parish nor this Parish Council shall be liable in any manner for the payment of the Bonds which shall be limited in nature. The Bonds and the Bond documents shall clearly state that neither the Parish nor the Parish Council shall have any responsibility for, or liability pursuant to, the Bonds.

On motion by Mr. Joseph and seconded by Mr. Sinagra, the foregoing Resolution was hereby declared adopted on this the 10<sup>th</sup> day of June, 2024 by the following roll-call vote: YEAS: Sinagra, Ingraffia, Joseph, Havis, Ridgel, Mayeaux, Wells, Vial, Hyde, Cieutat

ADOPTION of T.P. Resolution No. R24-19 - A Resolution authorizing Tangipahoa Water District, 6. Tangipahoa Parish, Louisiana to proceed with the issuance, sale and delivery of its not to exceed \$25,370,000 Water Revenue and Refunding Bonds, in one or more series - Jim Ryan notified the council of the 2020 bond refund that estimates about a half million savings and the new money is for the rehabilitation of the Eastern Heights Water System. The combining of bonds saves in fees. WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, as amended, and La. R.S. 33:1415, it is now the desire of the Parish Council, as the governing authority of the Parish of Tangipahoa, State of Louisiana (the "Parish Council") to approve the issuance and delivery of not to exceed \$25,370,000 Water Revenue and Refunding Bonds, in one or more series (the "Bonds"), by Tangipahoa Water District, Tangipahoa Parish, Louisiana (the "District"), the proceeds of which will be used by the District to (i) finance the cost of construction and installation of improvements, extensions and replacements to the System, including but not limited to, improvements to the newly acquired Eastern Heights water system; (ii) refunding all or a portion of the Series 2020 Bonds either by tender or conventional refunding; (iii) funding a Reserve Fund or purchasing a reserve fund surety, if necessary; and (iv) paying costs of issuance of the Bonds, including the cost of a municipal bond insurance policy, if required.

NOW THEREFORE, BE IT RESOLVED by the Parish Council, as the governing authority of the Parish:

SECTION 1. That, in compliance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, as amended, and La. R.S. 33:1415, and in accordance with the request of the Board of Waterworks Commissioners of the District, the Parish Council approves the issuance and delivery of not to exceed \$25,370,000 Water Revenue and Refunding Bonds of Tangipahoa Water District, Tangipahoa Parish, Louisiana, in one or more series. The Bonds shall bear interest at a fixed rate or rates not exceeding six percent (6.00%) per annum, shall mature no later than December 1, 2044, and shall be issued under the authority of Chapters 14 and 14-A of Title 39 of the Louisiana Revised Statutes of 1950, as amended and other constitutional and statutory authority, or such other authority as may be determined by resolution of the District at the time of the issuance of the Bonds.

SECTION 2. The Parish President, the Council Chairman and the Council Clerk are hereby authorized and directed to do any and all things necessary and incidental to carry out the provisions of this Resolution and to assist the District in carrying out its functions in connection with the financing.
