PLEDGE OF ALLEGIANCE

Commissioner Pulcini opened the meeting at 6:30 PM and led the assembly in the Pledge of Allegiance

ROLL CALL

Present were Commissioners Shrouder, Pulcini and Meltzer. Mayor Ross appeared by telephone. Commissioner Green was absent.

CHANGES TO AGENDA/EMERGENCY MATTERS

City Manager Napoli moved Items 2 and 3 to the regular agenda. Item 11 was deferred.

PROCLAMATIONS/PRESENTATIONS

None.

PUBLIC SPEAKING

Open Public Meeting –

Executive Pastor Paul Volan from The Pentecostals of Cooper City spoke on restoring the nonprofit fire assessment exemption.

Commissioner Shrouder spoke on having a process in order.

Commissioner Meltzer advised the Commission to set a rate to move forward in the process and encouraged residents to attend the attend budget meetings.

David Nall, spoke on the nonprofit exemption.

Bob Sands spoke on the nonprofit exemptions and moving toward accessing properties during the pandemic.

Fernando Nunez, spoke on upcoming sporting events in Orlando.

Agenda Concerns –

BOARD/ADMINISTRATIVE REPORTS

CONSENT AGENDA

Minutes

Regular commission meeting minutes of July 13, 2021

MOTION: Commissioner Shrouder moved to approve the minutes of the consent agenda. Commissioner Meltzer seconded the motion which prevailed by a unanimous roll call vote (3-0). The Mayor could not be heard.

Motion to Approve**Motion to approve additional FDEM Grant dollars and approve time extension for wind impact resistant replacement windows and front doors at Fire Station #28 – Public Works**

Commissioner Meltzer spoke on the original budgeted costs and the increasing prices.

Public Works Director Ken Griffin spoke on the additional grant dollars and completing the doors.

Commissioner Pulcini asked about the delay in bringing the grant item to the Commission.

Commissioner Shrouder asked if we bid out the first numbers.

Tim Fleming, Operations Supervisor advised we obtained the windows from Home Depot.

Commissioner Meltzer advised the City did not budget enough.

Commissioner Pulcini asked if this item could be brought back with more information.

Director Griffin advised there is a time limit for the application.

Discussion ensued on discrepancies in the numbers provided.

City Manager Napoli advised the total cost in 2019 was \$44,925. The estimated cost now is \$57,521 with a total of \$102,516.

Commissioner Meltzer advised the totals do not add up.

Commissioner Shrouder would like to approve the extension only and lock in the pricing for the remaining work.

City Manager Napoli will bring the item back with a contract and price guarantee at the next meeting.

Commissioner Meltzer amended his motion to approve the time extension only.

Mayor Ross would like to include a completion date before the grant ending date.

Commissioner Meltzer amended his motion to approve the time extension through April 2022.

MOTION: Commissioner Meltzer moved to approve the time extension and to adhere to the April 2022 deadline. Commissioner Shrouder seconded the motion which prevailed by a unanimous roll call vote (4-0).

Motion to approve Broward County Water Conservation Program Interlocal Agreement - Utilities

Director Mike Bailey advised that when the administered the program in-house it was more costly.

MOTION: Mayor Ross moved to approve the Broward County Water Conservation Program Interlocal Agreement. Commissioner Shrouder seconded the motion which prevailed by a unanimous roll call vote (4-0).

REGULAR AGENDA**Motion to approve water treatment plant roof replacement – Utilities**

Commissioner Meltzer asked if the roof could be inspected prior to completion. Utilities Director Mike Bailey advised the roof is concrete and adding contingency helps when finding issues as change orders can take a long time.

Commissioner Meltzer does not prefer change orders. Commissioner Meltzer also advised the project should be listed as a capital improvement.

Commissioner Shrouder stated that the Cooper City agreement references the piggyback and vendor submittal but he does not see where the prices are locked in. Attorney Goren advised the agreement states Exhibit "A" as the services to be provided.

Director Bailey advised the pricing sheet is Exhibit "A".

Commissioner Shrouder wants Exhibit "A" labeled.

Director Bailey asked if approval could be contingent upon the appropriate items listed as Exhibit "A".

MOTION: Mayor Ross moved to approve the water treatment plant roof replacement, subject to the pricing sheet and exhibits are labeled as Exhibit "A", priced at \$136,525.63, with a 10% contingency. Commissioner Shrouder seconded the motion which prevailed by a unanimous roll call vote (4-0).

Motion to approve purchase of trailer-mounted generator – Utilities

Commissioner Meltzer advised the current generator is out of service.

Director Bailey spoke on an error on the agenda report; the generator is reflected at a price of \$53,027 when it is actually \$53,036

Commissioner Shrouder would like a wheel lock for the generator.

Commissioner Pulcini advised that Director Bailey might want to budget for transformers in the future.

MOTION: Commissioner Meltzer moved to approve the purchase of trailer-mounted generator. Mayor Ross seconded the motion which prevailed by a unanimous roll call vote (4-0).

Motion to approve amended agreement with Kemp Group International Corporation for the continuation of crossing guard services – Recreation

MOTION: Commissioner Shrouder moved to approve amended agreement with Kemp Group International Corporation for the continuation of crossing guard services. Mayor Ross seconded the motion which prevailed by a unanimous roll call vote (4-0).

Discussion on Section 25-102, Driveways and Sidewalks, Repair and Maintenance required – Mayor Ross

Mayor Ross wanted to clarify the responsibilities of sidewalks. The beautification process includes residents keeping the sidewalks clean.

Commissioner Shrouder spoke on the code section on sidewalks and the responsibilities. He would like to return sidewalk maintenance to the abutting landowner unless money is available to fix the damage by the City.

Discussion ensued on the history of the item and the code change.

Commissioner Shrouder spoke on his concerns with the city's responsibilities for the sidewalks in the apron. The process is long and time consuming.

Commissioner Meltzer would like to look at the issue again with everyone present.

Discussion and possible action on sufficient backup for agenda items –Commissioner Pulcini

Commissioner Pulcini advised there is a staff report in the backup that he would like staff to use for Commission agenda items to provide sufficient backup for the residents.

MOTION: Commissioner Pulcini moved to approve clear and sufficient backup for agenda items. Mayor Ross seconded the motion which prevailed by a unanimous roll call vote (4-0).

ORDINANCE NO. 21-21 (Commissioner Shrouder)

Attorney Goren read “AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING THE CITY’S CODE OF ORDINANCES BY AMENDING CHAPTER 10, RENAMING CHAPTER 10 “NOISE AND VIBRATIONS;” AMENDING SECTION 10-2, ENTITLED “DEFINITIONS;” AMENDING SECTION 10-3, ENTITLED “EXCESSIVE NOISE PROHIBITED;” AMENDING SECTION 10-4, ENTITLED “MAXIMUM PERMISSIBLE SOUND LEVELS;” PROVIDING FOR ASSESSMENT OF SOUND LEVELS WITHOUT A SOUND LEVEL METER; AMENDING SECTION 10-9 ENTITLED “ENFORCEMENT RESPONSIBILITY;” PROVIDING FOR PROCEDURE OF ENFORCEMENT; DELETING SECTION 10-11 ENTITLED “PENALTY FOR VIOLATIONS;” PROVIDING FOR CODIFICATION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE” by title.

MOTION: Mayor Ross moved to approve Ordinance 21-21. Commissioner Meltzer seconded the motion which prevailed by a unanimous roll call vote (4-0).

CITY MANAGER REPORT

Budget Transfer Notifications

City Manager Napoli spoke on the budget transfers. He spoke on tropical storm Fred and advised the City will stay diligent. The announcement is out for the public safety adviser. He also asked for consensus to move the budget discussion to the August 24, 2021 meeting to allow for more time on the discussion.

Consensus was reached to allow discussion on the budget at the August 24, 2021 meeting.

Commissioner Shrouder advised we are transferring money away from a utility vehicle earlier approved for the budget transfer. He advised we should delay buying the vehicle and reminded everyone that some items can wait.

CITY ATTORNEY REPORT

None.

POLICE CHIEF’S REPORT

Captain Di Giovanni spoke on safety tips for the school traffic, which returns on August 18, 2021. The Captain asked all to please stay mindful of school zones and times. He also reminded parents to arrive on time and to take alternative routes to help with traffic congestion. A traffic operational plan will be in place. The Code Enforcement commercial initiative is ongoing with six plazas in violation at the last

Special Magistrate hearing, which gives the centers 60-90 days for compliance. Currently, 48 out of 66 plazas are in compliance and code is working diligently with the remaining 18.

The Code Enforcement City Wide Sweep has been very successful with over 40 citations. The goal is compliance and it is being reached.

The Captain also spoke on a residential burglary involving a child and wanted to reassure residents that District 16 worked diligently, brought in over 60 field personnel and obtained the subject in less than 24 hours.

In addition, there was a burglary at the Public Storage on Sheridan Street and in partnership with the South Broward Investigation Team they apprehend the burglar safely.

He thanked Potential Church for Heroes Day. Lastly, the Captain advised there are two vacancies: the community involvement position and one CSA.

Commissioner Meltzer requested a detailed list of updates on the commercial plaza initiative. He also asked about the traffic plan for Renaissance Charter.

Captain De Giovanni advised he and City Manager Napoli met with Renaissance and Franklin Charter School and they presented a traffic plan that they believe will be very successful.

Commissioner Meltzer requested a copy of the plan.

City Manager Napoli advised they will have three separate pickups.

Commissioner Shrouder asked if the traffic plan entails a police car blocking Sheridan Street.

Captain De Giovanni advised the traffic deputy does put marked unit in turning lane, which is necessary to send away parents that arrive early.

Commissioner Shrouder advised the school cannot shut down a main road.

Captain De Giovanni can speak to the traffic deputy.

Commissioner Shrouder advised they should not block the road. He does not want a traffic issue. The school needs to adhere to their conditional use.

Commissioner Pulcini advised they need another feasible plan.

Captain De Giovanni advised the school looked at various plans and recommendations.

Commissioner Pulcini asked what the schools original plan was when approved.

Captain De Giovanni explained that predates his time but from discussion there were to be no traffic issues due to capping enrollment and staggered pick up.

Commissioner Shrouder advised the schools need to make a plan that does not shutdown main roads.

Commissioner Meltzer advised the schools need to adhere to the plans.

Captain De Giovanni advised his team will work to put safety first.

FIRE CHIEF'S REPORT

Chief Bishop advised District 28 gave mutual aid to the Town of Davie five times, this month we have received mutual aid from them twice. There are currently delays at the hospitals due to under staffing. The call volume up 34% this month due to COVID-19.

Chief Bishop advised he received two letters thanking his team for transporting.

There will be a Bike Rodeo on September 4, 2021 and on September 12, 2021 there will an autism event.

They are also moving to a new reporting system for fire calls a record management system.

Chief also advised the engine and platform are in service.

Commissioner Shrouder asked if BSO Fire has come down in price in the budget.

Mayor Ross advised the Sheriff refuses to meet with him in person and the Fire Chief will not meet with him until he meets with the Sheriff.

Commissioner Shrouder requested to meet with the Sheriff's office and has not heard back. Commissioner Shrouder advised both union presidents met with them but the sheriff's office will not meet.

COMMISSIONERS' CONCERNS/REPORTS/ITEMS TO BE PLACED ON NEXT AGENDA

Commissioner Shrouder spoke on the procurement process in regards to the point system, which was not clear. He would like to update the process and have penalties for non-performance.

He would like to have the fire vehicles in the budget and see a capital replacement plan.

He would like to reorganize the Public Works and City Clerks Department. He wants to speak on efficiencies in the budget process. He would also like to budget positions by numbers at the budget overview meeting. Discussion ensued.

City Manager Napoli will provide a list of positions that make up department salary. Commissioner Shrouder wants to budget by position.

Mayor Ross advised his concern was not being able to meet with the Sheriff.

Commissioner Pulcini advised the Commission should be meeting with the auditors as soon as possible.

Commissioner Shrouder advised that more than \$200,000 should be put aside for a police department. He wants to see efficiency's in departments.

Commissioner Pulcini thanked Attorney Goren and Mayor Ross.

ADDITIONAL PUBLIC COMMENTS (2 MINUTES)

David Nall, spoke on BSO issues and the tax-exempt issue.



Bob Sands, asked if the City Manager and Commissioner Shrouder speak in private.


ADJOURNMENT
