## Reports from Staff

City Administrator David Cameron welcomed Council Member Grooms. Mr. Cameron reported Mr. Grooms' first meeting with us is the largest we have had since Mr. Cameron started here. Mr. Cameron shared he appreciated Mr. Grooms' work and willingness to serve. Mr. Cameron welcomed the re-elected Council and Mayor. Mr. Cameron clarified the Mayor's term is for 3 years to fulfill the term of the previous Mayor. It will be 3 years until our next Municipal Election. Mr. Cameron reported we have a lot of work to do.

City Administrator David Cameron told Council Member Franklin how much it means to staff when he referenced the Mission, Vision, and Values and spoke about how he looks at it in his office. Our Mission,

Vision, and Values mean a lot to us and it is what governs and guides us. Mr. Cameron shared it is reassuring to know he has that document crinkled up because it guides what we do every day. It means a lot that it goes with him because it comes with what we do and say.

City Administrator David Cameron shared we take what is going on in our community very seriously as a staff. This is not just growth and development, but we do our fundamentals correctly and protect the interests of the community we serve. We work hard for our programming for events such as Have-A-Blast, the gotMud? run, and our 150 year celebration. We work hard to make sure those things are protected and not just growing for the sake of growing. There is a lot of work that goes into these agendas and we got through those items in about an hour and ten minutes. Mr. Cameron shared that doesn't just get pulled off, there are a lot of documents drafted by the attorney's office, the clerk's office, and staff that meet with these developers and prepare these items including Karen, Chris, and Andrew. Mr. Cameron shared he asked them to get through the items quickly, but it took days, weeks, and months of work and collaborating to get to here. Mr. Cameron emphasized that one PDD is \$70 million invested in our community in one development.

City Administrator David Cameron thanked all the developers in our community, including Blake Cantrell who was present for the meeting. They all represent money invested into our local economy and work for local subcontractors and suppliers as well. Mr. Cameron shared they are only building more momentum for our community. Mr. Cameron reminded everyone this all started with our Mission, Vision, and Values and will end with the Mission, Vision, and Values. We can't lose our identity in this and Mr. Cameron reminded Council we worked hard on that instrument and to stay true to what that is, but that is what is delivered. Mr. Cameron stated "the best is yet to come". Mr. Cameron thanked staff for their work and thanked Scott, who had a lot of work to do to pull this together in addition to other development agreements. Mr. Cameron shared his appreciation for all the work. Mr. Cameron shared we make it look too easy sometimes.

City Administrator David Cameron announced the 150 year celebration is coming up. Jared and his staff are rolling it out. Mr. Cameron thanked Jared for that work. Mr. Cameron shared we are moving Pumpkin Daze to J.R. Martin Park. Mr. Cameron also spoke about the Parks Department implementing the Trust Edge and how they took the pillar of connection to a whole new level. Parks is connecting with Pumpkin Daze, which we have always stayed out of, but are now partnering to create more opportunity. Mr. Cameron reminded everyone that connection and relationship building is important.

City Administrator David Cameron spoke about the new Chamber Director, Macy Mitchell. Mr. Cameron shared if you get a chance to go to the Chamber Luncheons on the 1st Tuesday of the month, there was no room left at the last meeting. Mr. Cameron reported we are working with Macy to find a venue and creating sponsorships to get that done. Mr. Cameron shared the Chamber is giving a place for businesses to have a voice for when they come in here on how to get business done. They work with us on the needs of businesses and bridge the gap between the businesses and government. Mr. Cameron shared we have a healthy city, chamber, and school district and will continue to grow those relationships. Mr. Cameron commended Macy for the fantastic job.

City Administrator David Cameron emphasized he loves this community and the passion behind it. Mr. Cameron shared that is why he referenced the Mission, Vision, and Values. If you really want to know what is driving what we are, just look at our Mission, Vision, and Values. Mr. Cameron spoke of how quickly you can lose trust, so it is important that we are responsible and handle the City's finances well. Mr. Cameron thanked everyone for the opportunity to serve, for all our staff, and for the community that came out and our developers and investors into our community. Mr. Cameron shared he appreciates feedback, even when commenting on too much growth.

Council Member Pool announced the Farmer's Market starts May 6th at the Senior Center parking lot. Orscheln decided not to have them back so they are going back to the Senior Center. Mrs. Pool shared

her appreciation for Jared and his staff for allowing them and the vendors. Mrs. Pool reported they had 15 vendors last year, and 27 was the most they had when at Orscheln. Mrs. Pool reported it is every Thursday from 4-7. Mrs. Pool shared she is thankful for the work our people do, our attorney, city clerk, and David. Mrs. Pool shared she doesn't see how David keeps it straight. Mrs. Pool shared her appreciation for Mayor Russell.

Council Member Franklin shared this was the biggest agenda he has seen. Mr. Franklin shared it was a huge job and great job getting done so efficiently. Mr. Franklin congratulated those who were elected. Mr. Franklin thanked Mr. Haun and Mr. Gerlek and shared it is encouraging to see citizens stepping up. Mr. Franklin shared that last week a citizen contacted him about a street issue, and it was fixed before he could blink an eye. Mr. Franklin thanked staff. Mr. Franklin shared a lot of great stuff is coming to Republic and he is excited and grateful to be here.

Mayor Russell shared he gets to having fun with friends and apologized for making this a little less formal. Mayor Russell emphasized he wants everyone to know it is important. Mayor Russell shared he didn't put anything about the election on Facebook when won until asked. Mayor Russell shared he believes he is a very small cog in a very large machine, a well tuned and fast moving machine. Mayor Russell shared his style is to be friendly, in court and in here. Mayor Russell shared that as his friendliness comes across in this meeting, please know he is still taking it seriously and is proud to be here. Mayor Russell welcomed Council Member Grooms, sharing he appreciates his experience and looks forward to working with him in the future. Mayor Russell congratulated Council Member Deichman on being elected as Mayor Pro Tem. Mayor Russell thanked Council Member Franklin for serving as Mayor Pro Tem for the past year. Mayor Russell acknowledged being Mayor Pro Tem was important to Mr. Franklin and Mayor Russell shared he appreciated being able to count on Mr. Franklin and knew the City could count on him as well.
