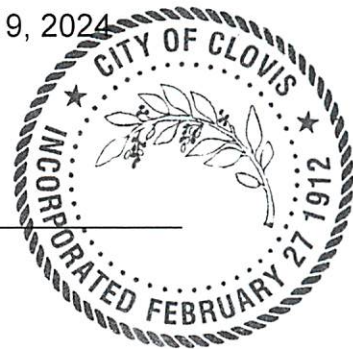

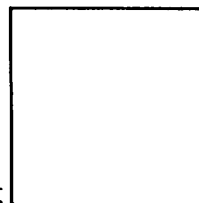

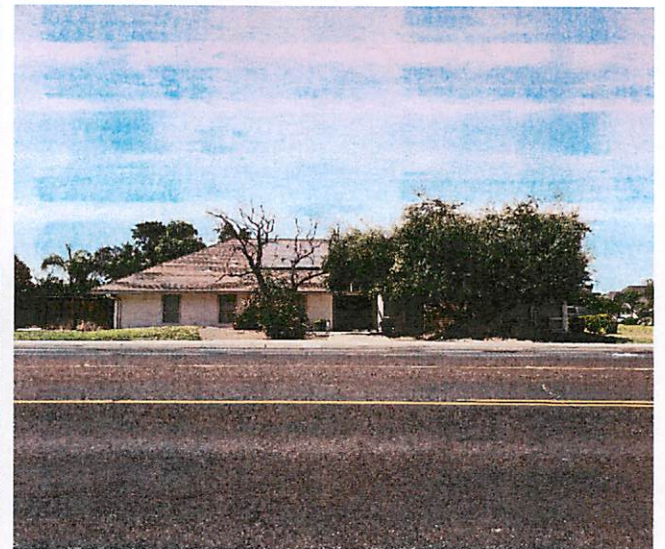

This letter is to provide updated background information as it relates to the Congregate Care Facilities within the City of Clovis and a new proposed location. There has been opposition by members of the community regarding this facility due to safety and calls for service at this location.

I was asked to provide background information on these facilities to include Calls for Service from the Clovis Fire Department. As originally provided in Exhibit 36 of the staff report, the associated calls for service were lower due to a reporting anomaly within the Fire Department records management system (RMS). Using more detailed query parameters, improved analysis demonstrates a slight increase in calls for service when compared to the previous report as provided below.

- 1817 N. Locan Ave: 1 Calls for service in 2023.
- 3019 Powers Ave: 0 Calls for service in 2023.
- 250 Villa Ave: 19 calls for service in 2023. Most calls are for medical aid/assistance.
- 648 W. Sierra Ave: 13 calls in 2023. Most calls are for medical aid/assistance.

Based on the project proposal, the Clovis Fire Department does not have any opposition to this project. Conditions as required by the California Fire Code with local amendments have been provided as a part of the Conditional Use Permit to ensure safety for residents and staff.

Thank you again for allowing me to address concerns regarding the projected Congregate Health Care Facility proposed for our neighborhood. My name is Tom Judd and I live on Indianapolis Ave. near the proposed facility.

First, I would like to thank Mr. Ramirez and the builders for making a few changes to the proposed plan after listening to citizens' concerns. As stated before, I know that congregate health facilities can be built in neighborhood areas, and I also believe there is a need for these care services for our community.

However, there are still a few concerns I'd like to address. After reviewing other health care facilities in the city of Clovis, I still feel that the proposed 18-bed facility is much larger than any other health care facility on just .55 acres of land. The report to the Clovis City Council inaccurately states that the property of the proposed health care facility is over twice as large as other lots in the neighborhood. Most single-family home properties in the neighborhood are on at least 1/3 of an acre (.33), while some lots are larger, and a few are smaller. .55 of an acres is not over twice as large .33 acres. If that fact were accurate, the property would be around at least .67 to .70 acres, and it is not. Why does this health care facility have to be more than two times larger than most homes in the neighborhood. This project is projected at such a large size that it appears the income garnered financially appears to be the priority not its services to Clovis or the elderly. Just because you can "squeeze" the large facility into a lot doesn't make it right. The City of Clovis has always been about doing what's in the best interest of all stakeholders and reaching decisions that have positive outcomes for all. You have always held yourselves to high standards, and I would expect that this would ring true regarding this project.

Look at this PowerPoint presentation including the chart showing some of the other Congregate health facilities located in the City of Clovis. The chart shows.....

The Armstrong project is the largest health care facility on one of the smallest pieces of land. Why can't it be a 10 or 12 bed facility instead of 18? This proposed facility will not blend into the neighborhood as promised. It will stand out with its size on a smaller parcel of land. It should be what is good for the neighborhood and for the city. It should not be about how much money can be made by a company that is not even located in Clovis and has no vested interest except building health facilities with the most profit.

Additionally, in relationship to the houses on the north side of this property, the health care facility is proposed to be anywhere from 5'-8' from the property line with an additional 4' from two different

pool areas. This makes the congregate health facility building approximately 12' from the living area of the houses to the north. If the health care facility were to be transposed to the other side of the parcel, the distance would be 5'-8' from the property lines on south side, but the house is another 38' from the property line. This would give the neighbors to the north a much larger set back from the building and center it better between living areas of both north and south side living spaces. It just make more sense.

Also, from observation, other health care facilities located in the City of Clovis have a 7' to 8' brick wall between the facility and current houses in the neighborhood. The proposed brick wall is only scheduled to be a 6' brick wall. The houses on the north side of the facility are on higher ground (approx. 2-3') than the health care facility, so a larger wall should be built between properties to enable privacy for the neighbors to the north and the patients from the health care facility. The residential property to the south does not stand any higher than the proposed health care facility. While there are no windows facing the north properties, there is a garden area proposed in the back of the facility where people can sit and relax with patients. There needs to be at least a 7' wall built to keep privacy from both parties due to the lower elevation of the property of the health care facility unless the property is elevated from quite a bit additional top soil being added for the construction of the facility.

The final concern that I have may be the most important point of all. I am adamantly opposed to there being a possibility of a change in residence at this facility in the future. Do we have assurance that this residence does not change to a mental health, drug rehabilitation or teenage group home facility in the future? The close proximity to Gettysburg Elementary School would make this designation completely inappropriate and significantly affect the safety of children in our neighborhood and at the school. Is there a way to have a protocol in place in the unlikely event that there would be a request for change of residence?

I am not asking the Clovis City Council to completely stop the construction of this health care facility. Facilities like this are needed. But the plans need to be drawn up again to include:

- 1) A **smaller health care facility** that would better blend into the neighborhood and not stand-out amongst the smaller homes.
- 2) **Transposing the facility to the other side of the property** to better center the building on the property and allow more distance from the living areas of the health care facility and the neighbors' houses on both sides.
- 3) At least a **7' brick wall** built to allow privacy for all residents, especially since the property on the north side is elevated a foot or two higher than the proposed health care property.
- 4) **Guarantees made that this health care facility does not turn into a drug rehabilitation facility or a mental health institution** ensuring the safety of elementary school children.

I hope these requests will be thoughtfully considered and that the City Council continues to place a hold on the construction of this facility until new plans are drawn up to reflect these changes. I am not asking for any more than what has already been done at most of the other health facilities built in the City of Clovis.

Again, I want to thank the Clovis City Council for your time and for myself and others to be able to speak tonight.
