Reports from Staff

City Administrator David Cameron commend everyone for the meeting. Mr. Cameron noted in 2018-2019, Andrew brought a vision on a napkin with a drawing of the new MM alignment with a school, library, and City Hall in that area and negotiated that street dedication to benefit that school by allowing 60 Highway access. Mr. Cameron commended him for the leadership, noting it saved the school district \$1.5-3 Million in waterline improvements. Megan will draft the 60 Highway street access. Mr. Cameron noted everyone thought he was crazy, but commended everyone and Council for seeing that vision through. We do plan and lay these things out but it takes investors to complete the vision and the work of the crews making this happen.

City Administrator David Cameron thanked everyone for the spirited discussion tonight, adding he loved seeing business owners show up.

City Administrator David Cameron noted Andrew's presentation on the combo truck, thanking everyone on the team and noting it should have been purchase 10 years ago per our compliance order. Mr. Cameron spoke to the BUILDS crew present, noting the amount invested in their equipment, reminding them that money follows trust. Mr. Cameron added we will bring another vehicle in the future, but first this one has to be running consistently to demonstrate the value. Mr. Cameron added he doesn't think it will last 10 years due to the need for running it, but Andrew and Council demonstrated a willingness to provide those resources. Mr. Cameron also noted the tenure of their crews with Eric Brown at 30 years, Brad Besett at 32 years, and an average tenure of 18 years in BUILDS Department.

City Administrator David Cameron noted that Senate Bill 979 has been filed and would allow Springfield to annex up to 6 miles without being compact and contiguous. Mr. Cameron noted he looks forward to finding out the legalities of this bill and speaking with representatives on it.

City Administrator David Cameron congratulated and welcomed Mr. Campbell to Council.

City Administrator David Cameron noted this is the last meeting of the year and we saved the longest for last. Mr. Cameron shared it is a blessing to lead this community; reminding everyone not to forget the reason for the season. Mr. Cameron shared his appreciation for the staff and Council, along with those who have signed up to serve. Mr. Cameron added we will continue to advance for the good and bad in 2024. Mr. Cameron wished everyone a Merry Christmas and Happy New Year.

Council Member Neal noted the paving map and asked if it is something we could do for sidewalks as well to plan for improvements to sidewalks. Mr. Cameron noted there is no master sidewalk plan as there was no funding for streets, adding the more we have those conversations and people identify special need areas, we could get one in short order.

Council Member Wilson noted there are streetlights out all over town, particularly at Elm and 60 there are 4-5 out. Mr. Wilson asked if at night we could have law enforcement note those when not on calls. Andrew Nelson noted one sergeant gave him that list, who is now the chief. Mr. Nelson noted he is signing off on outages reported to us and it takes a little time to complete. Mr. Cameron noted it is something that could be noted on social media as well.

Council Member Franklin thanked Megan McCullough and Judge McBride for allowing him to observe court. Mr. Franklin noted there were lots of things going on and he was impressed by the process. Mr. Franklin also thanked the Fire Department, as he got to go spend an afternoon with the crew cutting a car



in half. Mr. Franklin noted it was impressive to see and they even let him wear the uniform. Mr. Franklin thanked Laura and Megan for the preparation of the large agenda. Mr. Franklin also thanked Laura for the candidacy filing, noting it was a smooth process. Mr. Franklin noted the End of Year meeting last Friday and thanked Mr. Cameron and Mayor Russell for speaking; adding his congratulations to those who received awards. Mr. Franklin wished everyone a great holiday.

Council Member Updike shared that with the Republic Tigers championship game in Columbia, there were at least 2,000 people at the game, which was a great turnout. Mr. Updike gave a shout out to the coach.

Mayor Russell echoed Council Member Updike, noting it was a great thing being invited to speak at the school as he was honored to present the Republic High School with a proclamation. Mayor Russell noted it was neat to be in the auditorium full of kids excited about going to state, adding he remembers that feeling as a student and what a memory that created. Mayor Russell noted this is an indication of our community with positive momentum and thanked everyone for the hard work for our community that is being seen at our school and other communities.
