Dear Ms. Salazar and City Council Members,

As a homeowner in Old Town Clovis (OTC), I would like to offer my written comments as requested regarding above named proposed project, proposed amendment, and proposed rezoning. I live on Baron Ave in a home that is over a 100-year-old, and I specifically sought out a small historic home in OTC. Nowhere else in Clovis can you find old historic homes/buildings.

Old Town Clovis is uniquely situated at the base of the Serra Nevada's and Old Town is at the heart of Clovis with a hub of events, neighborhoods and businesses. It is our responsibility to preserve and guard the heart of Clovis... Old Town. As you think about Old Town as the heart of Clovis and preservation, I ask the Council to pause and consider conditionally approving this general plan amendment/rezone contingent on this project. In requesting to conditionally approve the general plan amendment and rezone for this multi-family senior housing development project with this specific project/developer we guard Old Town. My fear is this, the property gets rezoned, and this project falls thru. Then we have a property that has been rezoned and I end up with an 8-story high-rise building in my backyard. Please tie the rezoning directly to this project.

A blanket change to the general plan and rezone as before you would not preserve the authenticity of Old Town and our neighborhood as not all projects are the right fit for each area. As the prior project/developer was not the right fit. I believe the current project presented by from Clovis 135 Osmun, LP, to develop a multi-family senior housing development is a fit for the area and serves a great need in our community. Although I do wish it was single story and smaller, the project is needed in our community. This project and developer seem to be a better fit and not necessarily any other project. By approving the general plan amendment/rezone as presented then if the multi-family senior housing development did not come to fruition as planned then any other project can come in, as the general plan/rezone would have been potentially approved.

I respectfully ask you to be open to change and to consider conditional approval of the general plan amendment/rezone contingent on the multi-family senior housing development as presented by Clovis 135 Osmun, LP.



#### Gordon.

The minimum for residential services (base rate for water, sewer, refuse, recycling, greenwaste, and street sweeping) with zero consumption is roughly \$150. So the customers saying that their previous bills were lower than that would only happen for a couple of reasons:

1. They had paid extra in a previous period and thus had a credit that applied to their current bill

2. They had their deposit applied on the previous bill, which caused it to be lower. We did apply a lot of deposits in May as part of the cleanup process for the transition, so those bills likely were lower for many customers.

Unfortunately, without knowing the specific customer's situation, We can't say definitively why the balances were different. But the rates for service are the same for residential customers.

Thank you for your request. This is primarily an enforcement issue that should be coordinated with the Police Department. Per California Vehicle Code 22352(b)(1), the prima facie speed limit for a residence district is 25 miles per hour. With prima facie speeds, we typically do not post speed limit signs. There are situations in residence districts where speed limit signs have been posted. The Engineering Division will investigate your concern further to see if enforcement alone is inadequate. We will do so by putting up speed detectors and monitor

Bloom Avenue and North Preuss Avenue for a period of time (typically a week). The detectors are currently being used, so it may take a few weeks to put up them up.

Note that we typically do not install and maintain Radar Speed Signs, so we may not be able to install them in your neighborhood. I will speak with City staff to verify.
