Roll Call and Excused Absences.

All Councilmembers were present.

Wharton Moment.

Mayor Tim Barker stated Mr. Doc Blakley and his wife were moving to the hill country to be closer to their son, and a drive thru party would be held February 23, 2021 at the Methodist Church in Wharton. Mayor Barker said the Blakley's would be missed and that Doc was a "Cornerstone to the Community." Mayor Barker thanked the City of Wharton employees for their work during the February 13-17, 2021 North American winter storm, also referred to as Winter Storm Uri. Mayor Barker thanked Utility Clerk Lynette Masek for her hard work, stating a citizen commented to him how helpful she was to him.

Councilmember Russell Machann thanked the Public Works Department for their hard work during the storm, keeping utility services going for the entire City.

City Manager Andres Garza, Jr. thanked Interim Public Works Director Amy Horelica and Utility Director Harold Matula for their leadership during the storm and for all city employees and department heads hard work during the storm.

Public Comments.

Mayor Tim Barker called for Public Comments. No comments were made.

Review and Consider:

The first item on the agenda was to review and consider the City of Wharton Financial Report for January 2021. Mrs. Andel stated that the TexPool balance for January was \$201,988.15 with an average monthly yield of .08%. She said the Prosperity Bank balance for January 2021 was \$9,049,225.48 with an average monthly yield of .50%. After some discussion, Councilmember Russell Machann moved to approve the City of Wharton Financial Report for the month of January 2021. Councilmember Don Mueller seconded the motion. All voted in favor.

The second item on the agenda was to review and consider a request by the Wharton County Recovery Team for a temporary variance of Chapter 38-Manufactured Housing, Mobile Homes and Travel Trailers; Article II-Requirements Concerning Mobile Homes, Manufactured Housing and Trayel Trailers; Division 3-Recreational Vehicles, allowing the placement of a Travel Trailer at 517 Black Street as temporary housing for a client until other housing arrangements can be made. City Manager Andres Garza, Jr. presented a copy of the request by the Wharton County Recovery Team for a temporary variance of Chapter 38-Manufactured Housing, Mobile Homes and Travel Trailers; Article II-Requirements Concerning Mobile Homes, Manufactured Housing and Travel Trailers; Division 3-Recreational Vehicles, allowing the placement of a Travel Trailer at 517 Black Street as temporary housing for a client until other housing arrangements could be made. After some discussion, Councilmember Clifford Jackson moved to approve the the request by the Wharton County Recovery Team for a temporary variance of Chapter 38-Manufactured Housing, Mobile Homes and Travel Trailers; Article II-Requirements Concerning Mobile Homes, Manufactured Housing and Travel Trailers; Division 3-Recreational Vehicles, allowing the placement of a Travel Trailer at 517 Black Street as temporary housing for a client until other housing arrangements could be made. The third item on the agenda was a review and consider a request from Ms. Sheila Hoffman, owner of Wikki Wikki Hawaii Shave Ice to address the Council regarding her food truck trailer. City Manager Andres Garza, Jr. presented a copy of a letter from Ms. Sheila Hoffman, owner of Wikki Wikki Hawaii Shave Ice to address the Council regarding her food truck trailer. Ms. Hoffman stated that her request was for an approval to use the food truck trailer as a drive-thru temporarily for the duration of the crawfish season. After some discussion, Councilmember Russell Machann moved to approve the temporary use of a food truck trailer as a drive-thru for the duration of the 2021 crawfish season at Wikki Wikki Hawaii Shave Ice. Councilmember Clifford Jackson seconded the motion. All voted in favor.

The fourth item on the agenda was to review and consider a resolution of the Wharton City Council approving a VOCA Grant-Victim's Assistance Officer for the Wharton Police Department-80/20 match for two (2) years and authorizing the Mayor of the City of Wharton to execute all documents related to said grant. City Manager Andres Garza, Jr. presented copy of a memorandum from Chief Terry Lynch to him regarding the VOCA Grant Victim's Assistance Officer for the Wharton Police Department. City Manager Garza stated that the City had applied for the Victim's Assistance Officer position through the H-GAC Governor's VA Grant Program. Chief Lynch stated the City was approved in the previous year for the position and it was currently operational, having appointed Officer Melissa Huggins in that position but the grant term was for one year. After some discussion, Councilmember Terry Freese moved to approve City of Wharton Resolution No. 2021-21, which read as follows:

Councilmember Alice Heard-Roberts seconded the motion. All voted in favor.

The fifth item on the agenda was to review and consider a resolution of the Wharton City Council approving the revision to the Wharton Police Department Use of Force Policy and authorizing the Mayor of the City of Wharton to execute all documents relating to said policy. City Manager Andres Garza, Jr. presented a copy of a memorandum to him from Chief of Police Terry Lynch regarding the Executive Order 13929 Compliance with Use of Force Policy revision. City Manager Garza stated Chief Lynch had revised the policy to meet Texas Best Practices and ban choke holds as defined in the order, Chief Lynch stated that this Executive Order required that the Texas Police Chiefs Association Foundation certify law enforcement agencies and under the revised policy, Wharton Police Department met the requirements and had therefore been certified by TPCA. After some discussion, Councilmember Russell Machann moved to approve City of Wharton Resolution No. 2021-22, which read as follows:

The Wharton Police Department Use of Force policy has been revised to comply with Executive Order 13929 (Executive Order on Safe Policing). The revision streamlined the policy to meet Texas Best Practices and ban choke holds as defined in the order; and,

WHEREAS, Under this revised policy, the Wharton Police Department meets these

requirements and has therefore been certified by TPCA; and,

WHEREAS, Failure to comply with Executive Order 13929 will prohibit our agency

from receiving any future federal funding.

Section I. The City of Wharton has complied with the requirements of Section 2 of

The sixth item on the agenda was to review and consider a resolution of the Wharton City Council amending the agreement with IDC Inc. for engineering services for the FM 102 Relocation or FM 1301 to Hwy. 59 Expansion and Overpass Project and authorizing the Mayor of the City of Wharton to execute the agreement. City Manager Andres Garza, Jr. stated that on April 25, 2011, the City of Wharton entered into an agreement with IDC Inc. for engineering services for the FM 102 Relocation or FM 1301 to Hwy. 59 Expansion and Overpass Project. City Manager Garza said the City Staff had been working with Texas Department of Transportation (TxDOT), SMC Consulting, Inc. and IDCUS on moving forward with the project. Community Development Director Gwyn Teves stated the current modification was for the revision of the roadway alignment and update of the PS&E Plans from SH 60 to Railroad Overpass to avoid/minimize Right-of-Way (ROW) taking at the Magnolia Mobile Home Park. City Manager Garza presented a copy of the amendment and additional cost information to continue with the services and contract for the

Councilmember Alice Heard-Roberts seconded the motion. All voted in favor.

The seventh item on the agenda was to review and consider a resolution of the Wharton City Council approving an extension of the Declaration of Disaster signed on February 15, 2021 in accordance with Texas Government Code §418.108(a). City Manager Andres Garza, Jr. stated that on February 15, 2021 Mayor Tim Barker signed an Emergency Declaration in response to the severe winter weather. City Manager Garza said that this allowed the Mayor to perform extraordinary actions, if necessary, to protect the public. Emergency Management Coordinator Steve Johnson stated that pursuant to Texas Government Code 418.108 (b) the declaration would need to be continued or renewed by City Council within 7 days of issuance. After some discussion, Councilmember Terry Freese moved to approve City of Wharton Resolution No. 2021-24, which read as follows:

- **Section V.** That this resolution shall become effective immediately upon its passage.

The tenth item on the agenda was to review and consider a resolution of the Wharton City Council approving Halff and Associates to proceed with the recommended contractor for the Wharton Water Well & Water Plant Project even if the contractor intends to subcontract above 50% of the construction. City Manager Andres Garza, Jr. stated that on January 26, 2021, bids were received for the Wharton Well and Water Treatment Plant Construction and Drilling. City Manager Garza said that there were two (2) bids submitted for the Construction and four (4) bids submitted for the water well drilling and upon review of the bids for construction by Mr. Mike Kochanek with Halff and Associates, who was the contracted engineer service for the City, it became apparent that E-Contractors, who was currently the lowest bidder would be subcontracting \$1.66M of the work or 72% of the contract. Community Development Director Gwyn Teves stated that per the contract language "the Contractor shall not award subcontract work valued at more than fifty percent of the Contract Price to Subcontractor(s), without prior written approval of the Owner" and the City must authorize the contractor to sub out this amount of work. After some discussion, Councilmember Terry Freese moved to approve City of Wharton Resolution No. 2021-27, which read as follows:

City Manager Andres Garza, Jr. presented a copy of a memorandum from Community Development Director, Gwyn Teves, providing an update on the City of Wharton Grant Programs. After some discussion, no action was taken.

The twelfth item on the agenda was to review and consider the update of City of Wharton on-going Projects. City Manager Andres Garza, Jr. presented a copy of his memorandum dated February 17, 2021 to the City Council providing an update on the City of Wharton current projects as of January 31, 2021, which read as follows:

FLOOD REDUCTION (LEVEE) PROJECT

The U.S. Army Corp of Engineers (USACE) Lower Colorado River Phase I Report - City of Wharton Flood Prevention Project and Recommended report is located at the Wharton County Library and the office of the City of Wharton City Secretary for viewing or the report may be viewed on line at http://www.cityofwharton.com/information-a-notices/lcrb-feasibility-study. The Project Participation Agreement (PPA) has been executed. The City has begun the process to acquire the property necessary to construct the project. The City has hired HDR for Right-of-Way Acquisition and Jones & Carter for City and private company utility relocations. The City through HDR has begun the process of making offers to property owners.

DRAINAGE:

1. Stavena Addition Drainage Project.

The design and construction plans are complete. The challenge on this project is to find locations to place approximately 35,000 cubic yards of soil. The ideal disposal site should be close to the project site to reduce the cost of construction. The project is listed as one to be funded with the Texas Water Development Board (TWDB) Program for partial assistance.

2. Ahldag Ditch Improvement.

The project was approved by the City Council. Public Works Director is currently working out the details. The ditch improvements were proposed under the Texas General Land Office (GLO) Infrastructure Grant Program. The City is awaiting the approval of the grant request.

3. On-going Drainage and Maintenance Program.

The Public Works Department has continued working on cleaning residential draining ditches that have experienced poor drainage.

4. Pecan Acres (Mahann, Kinkaid, Delmas) Drainage Project.

Installation of the drainage pipes was completed. The City Public Works Department will be regrading ditches to improve the drainage in the area.

WATER/SEWER IMPROVEMENTS:

1. On-going Water and Sewer Maintenance Program.

Water leaks and sewer failures are still being seen in the month of January.

2. Water Well and Water Plant Project - CR 222 (Halford).

Halff and Associates the City's engineering firm on the project are completing the plan and specifications for the project. The plans and specifications have been submitted to the USDA for review and approval. The City Staff anticipate the project to be out for bid by the first quarter of 2021 once USDA approves the plans and specifications.

STREET IMPROVEMENTS

1. FM 1301 Extension and Overpass Project Progress Report.

IDC Inc. has submitted to TxDOT Yoakum District Office all required plans for the project. The City Staff continues to coordinate with TxDOT to ensure the project continues to move forward. The City Staff is working on funding for the project under the State Infrastructure Bank (SIB) Program.

2. I-69 Project.

The City submitted the comments as approved by the City Council to TxDOT. TxDOT has informed the City that an engineering firm has been selected to design the project from Highway 60 to FM 961.

3. NanYa Exit Ramp Project.

TxDOT has been coordinating with NanYa and JM Eagle on the exit design.

4. 2020 City Street Improvement Project.

The City has begun the 2020 Street Improvement Project. The City of Wharton Public Works Department has prepared approximately 75% of the streets for the Street Program. The seal coating is expected to be completed by May 2021.

After some discussion, no action was taken.
