### Year in Review: Central Tybee Island Residential National Historic District



- National Districts do not impose requirements on property owners but can help them access federal and state incentives for historic preservation
- General boundaries are 6<sup>th</sup> Street to 12<sup>th</sup> Street and Jones Avenue to the Beach/Atlantic Ocean
- 79% of structures are historically contributing to the district
- Includes the Fresh Air Home, one of the last examples in the nation of "fresh air homes" that were common in coastal towns during the late 19<sup>th</sup>/early 20<sup>th</sup> century for disadvantaged children of the city

### Year in Review: Central Tybee Island Residential National Historic District



- Largest concentration of remaining Raised Tybee Cottages (architectural style unique to Tybee; on GTHP "Places in Peril" List)
- 5 surviving Tybee Beach Company cottages built as demonstration beach cottages in support of the c1922 land subdivision prior to completion of the Tybee Road
- The District's association with the American Coastal Resort Movement revolves around these cottages (along with the Raised Tybee Cottages) as they were directly built by the development company
- Tybee Island is only example in Georgia of the American Coastal Resort Movement





#### HPC Annual Planning Meeting, February 3, 2024

#### **ADMINISTATIVE PLANNING - DECISIONS MADE**

#### **HPC 2024 MEETINGS:**

- HPC meetings are the second Monday of each month.
- HPC will move its February and March meetings to February 26 and March 25 to accommodate Planning Commission.
- Cassidi Kendrick will change the HPC meeting dates on the city calendar.
- Until the city has the capability to record two meetings simultaneously, HPC will continue to have to move its January, February, and March meeting dates to accommodate Planning Commission.

#### **LIAISON POSITIONS:**

- Marna Lewin will serve as the HPC Liaison to the Lazaretto Creek Coalition.
- Mike Goldberg will serve as the back-up HPC Liaison to the Lazaretto Creek Coalition.
- NOTE: Pat Leiby will continue to serve as a Liaison between Tybee/MLK and HPC.
- NOTE: Sarah Jones will continue to serve as HPC Advisor and as Liaison to the Tybee Island Historical Society members.

#### **HPC PROCEDURES:**

- The HPC Chair advised the members that the HPC Procedures do not address the election of HPC Chair or a position of Vice-Chair.
  - Members agreed that such provisions be added to the HPC Procedures.
- The HPC Chair proposed an addition to HPC Procedures that would allow HPC to schedule and hold workshops for the purpose of working on its projects and initiatives outside of HPC monthly meetings.
  - Members agreed to the addition to the HPC Procedures.
- The HPC Chair and HPC Staff Liaison determined these minor changes to the HPC Procedures do not warrant legal review by the City Attorney at this time. The changes will be held from legal review until the volume of modifications needed justify legal review time and costs.

#### **HPC POSITIONS:**

- The HPC Chair and HPC Staff Liaison requested that HPC add the position of Vice-Chair.
  - HPC members agreed in principle but there were no volunteers or nominations at this time.
- Cara Cole made a motion to nominate Holly Grell-Lawe as HPC Chair. Seconded by Mike Goldberg. Passed unanimously.

#### MONITORING CITY COUNCIL & PLANNING COMMISSION

- To proactively identify local topics that do or can impact historic preservation, the HPC Chair proposed that formal monitoring of topics on the meeting agendas of the Planning Commission and City Council be initiated.
  - Members agreed. Responsibility will rotate quarterly.
  - The HPC Chair will monitor through March 2024.

#### **PROJECT WORK:**

- Cassidi Kendrick will send draft City Council resolution for CLG grant to legal and get it on the City Council agenda for 2/22/2024.
- Participants at the HPC Annual Planning Meeting voted (10-2) to develop and conduct a
  Tour of Homes as the primary HPC fund-raising event for Historic Preservation Month
  (May 2024). 10 votes were for a Tour of Homes and 2 votes were for the traditional
  Trolley Tour.
- Cassidi Kendrick will order the across-the-road banner for historic preservation month (May 2024).
- Cara Cole will draft an information/fact sheet on the proposed Central Island National Historic District for the March HPC meeting.
- After completion of the replacement historical signage, HPC members agreed to prioritize the batteries for installation of new signage (where TIHS has homeowner permission).
- Follow-up is need to ensure that the architect's documentation (plans, blueprints, change orders, bills of materials, etc.) associated with the renovation of City Hall is provided to Sarah Jones at the Tybee Island Historical Society for permanent retention in their archives. Cassidi Kendrick will follow-up with the City Engineer.
