#### 2. QUARTERLY FINANCIAL UPDATE

The prior quarterly and year to date revenues and expenditures is provided for informational purposes. All financial records of the SBF are maintained by the Finance Department of the City of Oroville, SBF Fund Administrator.

After discussion and clarification of the following two items a motion was made by Committee Member, Riggs and seconded by Committee Member Johnstone, to approve the Consent Calendar. The motion passed.

- 1. <u>Selection of a Parks & Trails ad hoc Committee</u>: Committee Member Brandt expressed concern about meetings of the ad hoc Committee and that all of the agencies in the Oroville area should be included in the meetings. He provided a copy of a Memorandum of Understanding (unsigned) dated October 1996 between the various agencies and municipalities in the Oroville area. A copy will be provided to all committee members and Chairperson Pittman requested that discussion as to how to proceed will be placed on the next SBF Committee Meeting Agenda.
- Draft letters sent from the SBF Committee: Committee member DeLong requested that
  future correspondence should be the consensus of the SBF Voting Committee not any
  single committee member. Mr. Marciniak will prepare an addendum to the SBF Committee's
  rules and include it in the next SBF Committee Meeting Agenda.

- 3. Andrew Bambauer, DWR Alternate Advisor, presented information regarding potential adjustments to SBF funds as detailed in Appendix B, Exhibit A, (6.0) which allows for a decrease in funding related to water flow and (8.0) which allows for a decrease in funding related to forced physical outages.
