Failure to pay for the removal of above material within 15 days of notification shall constitute a lien against the property for the amount so billed.

Town Manager Forbes thanked everyone for coming and said he was happy to see things getting back to normal.

Blighted Properties - 125 W. Fifth St demolition complete.

<u>Contacts/ Meetings - IDA</u> with guest speaker Sharon Carney Hurt and Profitt Engineers on prospects for main street improvements

Airport - New Fence completed. Roof painted and working on sides.

<u>Streets - Spring Clean 26-30 April, Sidewalks to be power washed this month. VDOT has</u> street sweeping scheduled for late April. Storm damage cleanup completed. Requested FEMA funds to cover cleanup up and storm damage cost.

<u>Water/Sewer</u>-Repairs made at Green Acres trailer park for storm water I and I. Jamie Smiley and town crew to complete camera work to determine cause of continuous flow.

Digital Water meters with complete wireless setup for entire town approximately \$300,000 with stimulus funds with council approval.

<u>WWTP - SCADA</u> system completion to include all pump stations approximately \$90,000. Stimulus finds to be used with approval from council. Also new portable pump for plant and emergencies approximately \$45,000 with stimulus funds

<u>Endly Street Project - Basketball retaining wall near completion. Sidewalk on eastside near Sundaes near completion.</u>
