## **Reports of and Communications from Township Officials**

## A. Supervisor/Treasurer

**Supervisor Schumann** reported that she met with the Supervisor's Division recently and she acquired many ideas concerning the Decennial Committee.

Many townships are already prepared to submit their Decennial Committee reports. Palos Township and the Palos Township Highway Department still need to get the Decennial Committees underway. She was able to see the many outstanding things that Leyden Township is involved with and partnerships they are working with. She was able to see a completed Decennial Report which will be a help to us. We will have some meeting dates concerning the Decennial Committees soon. Our committees are appointed and there is no penalty if we do not have a meeting by June. She learned many new things at this meeting.

### **Trustee Woods**

The 2024-25 budget will be ready for posting either Monday, April 29 or May 6, 2024, and will be posted for at least 30 days before the meeting to approve it. **Trustee Woods** stated that the Township is in very good financial shape, even with the \$100,000 capital improvement expense. The budget is way over expected revenues. He will do a brief presentation of the budget before the passage.

The township will have a very good surplus. **Trustee Woods** is trying to build up the "rainy day" fund. He is working to get grant money to possibly discuss the idea of a new facility for the township.

#### **Trustee Jeanes**

**Trustee Jeanes** was absent so there was no report for the Board.

### C. Highway Commissioner

Highway Commissioner Adams reported that the month of March was extremely busy putting all the signs out and back in order after the winter. The Road District has many signs to put up every spring. There were also annual asphalt cracks and other asphalt repairs to perform. There was a great deal of garbage including vacuum cleaners, washing machines, etc., that was found during the cleanup. There are "no dumping" signs posted, but the residents pay no attention.

4. Annual Palos-Hickory Police Report

**Clerk Nolan** and her husband attended the yearly Palos/Hickory Police update in March.

Some of the key things brought forth by Police Chief Cucio, Palos Hills and Police Chief Joseph Boyle, Hickory Hill were:

- a. Pre-trial works better than they thought it would.
- b. Many violators stopped are let go unless they are considered a danger to society.
- c. Violators can be released right on the street.
- d. Red light cameras were discussed and they are good in their opinion. They now use Flock cameras which produce better quality pictures.
- e. There is a partnership between Hickory Hills and the Palos Hills Police Departments that allows more criminals to be caught.
- f. They discussed the recent Chase Bank break in. The perpetrators were roommates in prison!
- g. They pointed out that both municipalities should invest in infrastructure.
- h. Palos Hills police officers have new cars that contain cameras and new vests that have video cameras on them.

- i. Most of the hard work is now done by cameras. The police work together using these cameras.
- j. They asked to please watch the legislation from Springfield closely as the continuing changes often affect community Police Departments.

### E. Attorney

**Attorney Peck** discussed the scrivener errors in the levy draft ordinances on tonight's agenda. The Road and Bridge numbers did not match on one of the pages. These ordinances are just correcting those errors. It does not change the totals of the levies.
