Call to Order

The General Meeting of the Palos Township Board was called to order by Supervisor Schumann in the Township Hall, 10802 S. Roberts Road, Palos Hills, at 7:00 P.M.

Roll Call

a. Approval of Minutes – General Meeting November 13, 2017

1. Consideration of Ordinance 2017-0-03 Township and GA Levy

2. Consideration of Road District Ordinance 2017-0-02 Annual Tax Levy Ordinance

c. Technology, Automation and Information – Trustee Riley

d. Buildings and Grounds – Trustee Jeanes
