**Citizens Wishing to Address the Board**

He wanted to read a support statement for Trustee Brannigan. Trustee Brannigan did not concur with his statement, and she had not asked him to attend. He did enter the Town Hall but left before the meeting began as he was taunted and screamed at by the protestors with shouts of “Nazi scum get out of the room!”, and “racist go home!” He left and moved across the street where he and some of his followers held up signs and shouted at the protestors.

The Board entered the room at 7:00 P.M. The taunts and yelling began right away. The protestors even screamed through the Pledge of Allegiance. The Board continued their meeting using the microphones. Some of the things yelled throughout the entire time the Board was conducting the meeting were “Shame on you for protecting Arthur Jones and Nazi’s.” “Nazi scum get out of the room!” “Hey, no racist USA, No Sharon, No KKK, No Racist USA!” When the Supervisor told them, the meeting would be shut down they replied with “Brannigan resign, “and “We don’t care --- shut it down!”

## **Executive Session**

No motion was made to enter Executive Session.

## **Adjournment**

**Trustee Woods** moved to adjourn the meeting at 7:08 P.M. **Trustee Riley** seconded the motion. The motion was carried unanimously. Meeting adjourned.
