AS A RESULT OF HURRICANE IDA***

BE IT KNOWN AND REMEMBERED, that a specially scheduled emergency meeting of the City Council of the City of Abbeville was held on the 27th day of August 2021, commencing at 4:30 o'clock p.m. at City Hall, Abbeville, Louisiana, where the following resolution was moved, duly seconded, passed and adopted, to-wit:

WHEREAS, the Council of the City of Abbeville does hereby recognize that Hurricane Ida is currently located in, or may soon be located in, the Gulf of Mexico with projected landfall along the coastline of south Louisiana and thus presents dangers to the citizens of Abbeville for both to their personal safety and property;

WHEREAS, as a result thereof, a state of emergency exists;

BE IT RESOLVED that it is hereby declared that a state of emergency exists for the City of Abbeville pursuant to all applicable state and federal laws and regulations which may govern same, and further suspending compliance with the public bid law (LSA-R.S. 38:2184, et sequa).

***A RESOLUTION AUTHORIZING THE EXECUTION OF
EMERGENCY DEBRIS REMOVAL CONTRACTS
AND A PROFESSIONAL SERVICES CONTRACT
IN CONNECTION WITH SAME***

BE IT KNOWN AND REMEMBERED, that a specially scheduled emergency meeting of the City Council of the City of Abbeville was held on the 27th day of August 2021, commencing at 4:30 o'clock p.m. at City Hall, Abbeville, Louisiana, where the following resolution was moved, duly seconded, passed and adopted, to-wit:

WHEREAS, FEMA regulations dictate that a governmental entity seeking reimbursement for emergency debris removal created by a natural disaster must have in place prior to the event one or more contracts which govern the removal of said debris, and

WHEREAS, the City Council does hereby determine that it is in the best interest of the City of Abbeville, its residents, and businesses to enter into contracts with Vermilion Shell & Limestone Co., Inc. and Acadiana Shell & Limestone, Inc. to provide emergency debris removal services for a term ending May 31, 2021; and a separate contract with Primeaux, Touchet & Associates, LLC for professional Engineering Services in connection with extraordinary emergency recovery events; and

BE IT RESOLVED that Mark F. Piazza, Mayor of the City of Abbeville be, and the same is hereby, authorized to execute said contracts on behalf of the City, and to do and perform all acts necessary in the premises.
