Scope of Work #3 – Fence Repairs at Parker, Shelby, Voorhoff, Luquette, and Delcambre:
At all fields we will replace rusted wire, top rail, etc. to get fences looking new. In between
Delcambre and Luquette fields we will furnish and install with new 300 ft. of 6 ft. high chain
link fencing with 1- 20 ft. roll gate.

~Proposal~ Baseball Park Upgrades

To: City of Abbeville
 AA Comeaux Parks & Recreation
 Abbeville, LA

For this project, we hereby propose to provide *all material, labor, and equipment* for the following scopes of work:

- approx. 11,000sqft new concrete, 2600sqft demo, 9 component canopies
- all spoil stays onsite
- all demo'd concrete to be loaded and hauled off by others
- all new slabs shall be 3000psi straight mix, 4" thickness minimum
- all posts 4x4 galv, all structural components galv
- Roof panels and trim fern green

Delcambre Field:

- Add 20x30 canopy. Tie into existing canopy with approx. 200sqft of cover
- Demo handicap rap @ west side of existing slab
- Add 20x30 concrete. Extend new concrete to meet existing slab

Luquette Field:

- Demo existing concrete under old large bleachers (bleachers and cover to be removed by city)
- Add 23x47 canopy, starting in same location with respect to concession, and run 47' to fence at road. Tie new canopy into existing remaining canopy with apron wall.
- Add 3' apron wall to east side of existing remaining canopy
- Add new concrete under remaining canopy
- Demo and repour side walk from existing remaining canopy to north end of dugout
- Run 6" curb along east side of new sidewalk to divert water from road, going north

Shelby & Vorhoff Fields:

- Overlay concrete between dugouts of Shelby and Vorhoff. Start new concrete at west side of field access gates on west side of dugouts
- Demo all concrete from east side of dugouts, continuing east around concession
- Create positive drainage west to east, around concession to existing catch basins on east side of concession
- Add (2) 14'6x30 canopies in main area (leave space between tops for new light pole)
- Slope both tops to center
- Add gutters and downspouts on low side
- Collect guttered water with subsurface drainage to existing catch basin
- Add 20x30 canopy and concrete to east sides of both Shelby and Vorhoff

Parker Field:

- Add (2) 20x30 canopies, 1 left and 1 right of back-stop
- Connect both canopies behind home plate (3 canopies creating essentially 1 large canopy)
- Add new concrete under all covered areas, tying into existing concrete area
