The Mayor and Council of the City of Abbeville met in regular session on December 1, 2020 at 5:30 P.M., at the A. A. Comeaux Recreation Center located at 300 A. A. Comeaux Drive, Suite 200, Abbeville, Louisiana with the Honorable Mark Piazza, Mayor, presiding.

Mayor Piazza asked Mr. Ike Funderburk to lead those assembled in prayer. Mayor Piazza asked Mr. Gene Sellers to lead the assembly in the Pledge of Allegiance.

Councilwoman White discussed the proposed revision of the job description for the open unclassified position. She had spoke with the Mayor about the vacant position we have and that we should think about adjusting it to include someone who could help with digital media and website maintenance. She also spoke with Kathy Faulk, Charlene Beckett and with Alli Miller to ask them what areas they need the most help with. Most of them needed assistance on the digital side. She is proposing that we look for a digital media assistant that will work at City Hall and the Alliance Center to help with those items. We will also incorporate some of the items that were already part of the other job description. The necessary skill sets required are also listed on the job description. We could go to UL to see if they have a student that is just coming out of media classes that would need placement. We may also have someone in the community that has these skill sets. Councilman Broussard stated that he likes the job description and that it goes to where society is going. That is the future and we are already in the infancy of it. He endorses the changes. That will provide a more qualified person in City Hall. Councilman Plaisance stated he reviewed the job description very carefully and he likes the way it explains things. He hasn't seen anything on there that should be different. He appreciates the work Councilwoman White has done on this and it explains very well where we are going in the future. We will need a person like this. It is an essential position. Councilman Touchet asked to add knowledge of Zoom, Google meet and things like that for the future. Ike suggested that instead of going with a brand name we go with something generic, like virtual meetings, so that we won't have to change it in the future. Mayor Piazza stated in the absence of the Secretary-Treasurer and the Director of the Cultural Center, that individual should report to the Mayor's office or the representative of the Mayor's office. Councilwoman White stated the seven days notification to request leave came from Alli so she can plan better. That is a change we clarified.

-01 introduced by Ms. Roslyn White and seconded by Mr. Francis Plaisance to approve the job description, with the revisions discussed tonight, for the open unclassified position. The motion carried unanimously.

Mayor Piazza stated we have a guest, Mr. Ted Johnson, who is the government relations executive for Entergy in Acadiana. He and Ted have had many conversations throughout the summer with the numerous tropical storms and hurricanes. We appreciate him taking his time to be here tonight. When he called Ted a couple of weeks ago, they had a lengthy discussion about the process that Entergy goes through in the event of a hurricane. We had several issues. The City of Abbeville does not generate its own power. We cannot produce our own electricity here like some cities do. We have to purchase power elsewhere and transport it over Entergy's lines to the City of Abbeville for us to resell that electricity. You could have a tornado somewhere or a hurricane in other parts of Acadiana where our lines may not be as damaged as Lafayette or Crowley, where Entergy transmission lines may suffer severe damage. That affects us here. We may have our own system up and running and not have power that can get to Abbeville or we may have power to our substations but Entergy's customers south of Abbeville may not have electricity because of some transmission lines that are down in Entergy's side of the transmission grid. We, as elected officials, get all the phone calls about when the power will be restored and we need to answer those questions. He asked Ted to be here tonight just to answer some questions and to give us a brief explanation of Entergy's policies and procedures of how they get their system back up and running, how they assess their damage, how they inform municipalities and parish governments regarding how long it will take to restore the power and how do we get a line of communication with Entergy and who should we be talking to when those situations arise. He turned the floor over to Ted. Mr. Johnson stated if you start at a generation station somewhere in Texas, they make the power there and they transport it over transmission lines. Those transmission lines will be on the low end at 69,000 volts and on the high end, 500,000 volts. They do have some transmission structures that go up to 1,000,000 volts. All the transmission lines go to substations. Substations step down the voltage from a transmission voltage to a distribution voltage. Distribution voltages will run from 7,000 volts and 34,000 volts. All the transmission feeds are loop fed. You will have generation station, transmission substation, substation, substation and back to the transmission. So, if you have a fault between two substations, you can isolate that fault and feed it from the other direction and those substations stay hot. All customers on the distribution behind the substation remain with power. You will have a brief interruption. Such is the case with the City of Abbeville. Imagine Abbeville in the center, two transmission feeds coming into the City. If we have damage on one of these facilities, it is no problem. All we do is open a switch, close a switch then feed the substation that feeds the City of Abbeville. The residents may see a short outage. In the case of the storm, we had multiple damage to both sides of the transmission feed. It was unprecedented in our area the amount of transmission damage that occurred. It was way outside of Abbeville and that is what caused the extensive outage. Most of our distribution feeds are loop fed but not all like our transmission feeds. Some of your distribution feeds in the City are loop fed and some are not. You will have distribution feeder and you will see the transformer on it and that goes to secondary. It steps it down from 7,000 volts to 120 volts to the meter on your house. That is a big picture. We have distribution customers south of the City that we feed with an Entergy meter. The City takes care of the distribution for their customers and we take care of the City on a transmission level. The easiest way to see where the outages are is to go to the Entergy app. The green lines on the map are their customers. This is real time data. You can look down to your address if there is an outage. It will tell you what the projected restoration time is. The algorithms on the map depend on the customers who call in. We are installing smart meters now so the meter will report when there is an outage. This will be fully implemented within 6 months. All areas of the electrical grid will be monitored real time including generation, transmission and distribution. After a storm, we go out and check the transmission lines for their area that is predetermined prior to the storm. We can predict by those assessments how many customers we will have out. Customers at the end of the distribution lines that are not loop fed are the last to come back on. We try to pick up the feeder that will bring on as many customers at one time. Councilman Broussard stated our customers depend on the Council to find out what is happening. Not everybody has the internet or a smart phone. If the City can't reach you then we can't tell them what we don't know. We have some of your customers south of Abbeville and if we can't get the information from the Mayor then we cannot reply to our constituents. Some of your customers in the City of Abbeville do not understand that we do not supply their electricity. Please keep the good relationship that you have with our Mayor and keep the line of communication open and answer the Mayor's calls because we can't take care of Entergy customers' in the City if we don't know what is going on. We can spread your good news if we know it. If we don't know it citizens may expect the worst and not the best. Please take the Mayor's calls and the Mayor will certainly take your calls. It is good communications and that is a good business practice. This year was not normal. You are not the only provider of electricity we also have SLEMCO. Councilman Touchet stated that for Hurricane Laura our Mayor and supervisors could not get in touch with you. This caused us a two-day delay in power restoration. We got a lot of heat for that. Nobody answered our calls. Can you give us a name and number that somebody will answer our call so we can spread the word out? He was telling citizens that it was Entergy's fault. Mr. Johnson stated that is a fair question. He handles a large portion of the state and he will average about 6 missed calls when he is speaking with someone. He was working 16 hours per day seven days a week straight. After that storm, Laura, he asked for somebody in Lafayette with the computer that knows how to work it. He got a team of professionals that came to help him. That will happen again for the next storms. That will give him the relief he needs to get the information to you. Mayor Piazza stated he is very impressed with the app. The question we get asked is how long. That is all they want to know because they have food sitting in their refrigerator and they are running out of ice. We need to figure out a way to get to a warm body that will give us a little heads up to be able to say how long it will be. This way we will know what to tell them. You can't answer 1,800 calls a day personally. Entergy knows what our concerns are and you are making a lot of headway with this technology and that will help tremendously. When we go out a do an assessment, we will go to areas that are the least damaged and get the greatest number of people on that we can. The ones that have the most severe damage in their neighborhoods will be last. That is the way Entergy operates too. Mr. Johnson wanted to compliment the Mayor. It was late in the evening and they weren't projected to get power until the next day. He called him at 10 PM to say that they could heat it up and if the Mayor could get somebody to the substation. He made it happen by 11 PM that night. The electrical crew had gone home already but got back in their trucks and went back to the substations. Kudos to those guys. Mayor Piazza stated that the City has some excellent workers and linemen here. We do not have the substation expertise in-house. We rely on Harvey DuBois for this. We had to get him here too that night to make this happen. All those things have to fit and there are not a lot of people who are aren't privileged to how our electrical system and distribution system works. That is why we asked Ted to be here tonight to get that information to the public. These things take time and we are communicating and making these things happen as quickly as possible. There are a lot of moving parts out there and a lot of people out there that are working tireless hours to get the light back on. We are trying to communicate, as best we can, with our citizens. Mr. Johnson stated we will be sending a GCR report that will be broken down by parish. It will be emailed twice a day. That will free up some time because he won't have to make a phone call to give this data. The management team will also help too. Those things will help with communication.

-02 introduced by Mr. Francis Plaisance and seconded by Ms. Roslyn White to approve the minutes from the regular City Council meetings held on October 20, 2020 and November 3, 2020 and the special City Council meetings held on November 3, 2020 and November 17, 2020. The motion carried unanimously.

Mayor Piazza asked if there were any comments from the public on any agenda item prior action. A gentleman in the audience asked how will it be determined where the cameras will be placed on utility poles around the City. Mayor Piazza stated that is a coordinated effort between the Chief of Police, the Sheriff, Lieutenant Jason Hebert and the narcotic task force representative, Mr. Drew David. It was those individuals that determined that.

-07 introduced by Mr. Francis Plaisance and seconded by Mr. Francis Touchet, Jr. to accept the quotation from Bayou Fencing and Supply for fence repairs for several parks. All fences were damaged as a result of Hurricane Delta. The motion carried unanimously.

Councilwoman Roslyn White presented the new website design. She stated this is the initial design. We took into account the audience as opposed to designing it according to departments. Not everyone is familiar with the departments of the City. We have three audiences. We have government, community and businesses. We will also have a search bar if they are not sure where they have to go, they can put in a question and it will navigate them to where they need to go. The current website design has a lot of information but it is not easy to navigate and it is not current. That is part of why we wanted to rewrite the job description of the person who will manage the website. There are buttons to make payments, permits and reporting an issue. We want the constituents to be able to report an issue and the email will go directly to that department. That will help with communication with the public. We will have a hero banner where we will feature photography and current events. We can change that out. We will have an event calendar with where to stay, where to eat and what to do. Photography will be updated

every month to go along with the activities that are going on at that time of year. The three squares will be our blog. You can click on that and get current information. This is a sneak peek of the design. The color scheme is taken from our logo. Mayor Piazza stated that this was a part of the budget for this year and we have allocated \$5,000 in 2021 to update the photography and video. Councilwoman White also presented the print ad that was discussed at the last meeting.

Chief Bill Spearman stated they found three units that were turned in by the New Iberia Police Department through Midsouth leasing. We bought a car a little over a year ago and it is still running and has not given us any problems. What is nice about these cars is that when you buy them for \$20,000, they have between 56,000 and 60,000 miles on them. They paint them white for us and it comes with lights, cages, the radio console, the push bumpers and everything that we would have to buy separately. All the units are 2017 models. We are getting a good deal on this. Two months ago, a car took out one of his units and it is out of commission. He is almost at full staff and when he gets at full staff, he won't have enough cars. We have a lot of old Crown Vics and they are costing a lot of money to maintain. Mayor Piazza would prefer if we would pay for the units outright instead of lease them. He would like to amend this year's budget so the Chief can order and purchase them now.

-08 introduced by Mr. Francis Touchet, Jr. and seconded by Mr. Francis Plaisance to amend the Police Department 2020 budget to add an additional \$40,000 to the Sales Tax budget to purchase used police units. The motion carried unanimously.

Councilman Francis Plaisance asked Chief Spearman to ask his officers to slow down especially on Charity Street. If a car pulls out, there will be some fatalities. Chief Spearman said he would.

Chief Spearman stated that for over a year they have been receiving cameras from Crime Fighters of Louisiana. They have been putting the cameras up and we have been supplying the poles, the electrical boxes and the sims card. Mr. Brooks has been doing this for agencies all over Acadiana and at this time they need more money for more equipment. We were presented with a contract from Mr. Brooks that would show us what he would provide for the City and he what he wants the City provide for him. There is an estimate on what it would cost for two different packages. Councilwoman White asked Chief Spearman if the price was an annual figure or for a three-year term. Chief Spearman stated that he thinks it is three years for both figures. The Mayor spoke to Mr. Brooks and he was having e-mail trouble so he didn't receive the quotes. Councilman White stated she would like that clarified in the contract since it does not specifically say that. Chief Spearman asked Ike to review the contract for us to get the specifics. Ike asked the Mayor and Council to consider to authorize him to do some research on other communities that have entered into an agreement with Mr. Brooks. He has already started that process. He would also like to negotiate with Crime Fighters of Louisiana, LLC because there are some things in the contract that need to be discussed. It is not a contract. It is a cooperative endeavor agreement. It is not a lease nor a purchase. He has some areas of concern with the agreement. Chief Spearman stated he would like to help Mr. Brooks because he has given us the cameras this year. Mayor Piazza stated he is not happy with allowing Ike to negotiate the contract because he has some concerns. That is not the same as actually pursuing and funding this amount of money if it meets the terms of the contract and Ike's satisfaction. Councilman Touchet stated he has not yet read the agreement and this is the first time he sees it. He would like Ike to bring this back and then we could take it up. Chief Spearman asked if he, the Mayor and Ike could meet in private to iron out those details so that there would not be much delay. Councilman Touchet stated he was not sure of the exact dollar amount requested. He would like Ike to get those specifics and then have Ike present it again with all those specifics. Chief Spearman stated there is a clause that will allow a cancellation period within 60 days. Mayor Piazza stated he is still uncomfortable with assigning

the City Attorney to negotiate a contract for the Police Department when this is a law enforcement issue and our law enforcement agency should be doing the negotiation. It should not be our City Attorney. Our City Attorney should review the contract after the negotiations are made and to review the contract to make sure it is acceptable to the City legally. The Chief really needs to be negotiating the terms of the contract and he should present that to the Council. Councilman Touchet stated he is not asking Ike to negotiate anything. He was trying to buy some time because Ike said there is some stuff that causes him concern. He doesn't even know what this will cost us and what are we tied to. Councilwoman White stated she thinks the cameras are invaluable. It is a resource that we need. Putting this agreement on our desk when we walk in here without an opportunity for us to review it and read it makes it difficult to agree to it. She needs more time to review it and needs more concrete details. She is onboard for this but she needs to make sure she knows what she is signing the City up for. That is how she feels. Mayor Piazza stated he agrees with Councilwoman White completely. Councilwoman White stated she needs to be clear what the terms of payment are and what our out-of-pocket costs will be. It is well worth whatever it is but she needs to know that. Mayor Piazza stated what we should have done is put this in committee first tonight and then adopt it at the next City Council meeting. The problem with that is that he has to tell our City Auditor tomorrow what to put in the budget. This item came up during the Thanksgiving holidays. If it doesn't get put in his budget then it can't happen. Councilwoman White asked what the dollar amount for the 2021 budget is. Mayor Piazza stated the Police Chief asked for the \$71,000 to be put in the 2020 budget and the \$35,000 in the 2021 budget. This is a cooperative endeavor agreement. It is not to purchase cameras. We are buying a security service that provides cameras and detailed information through their camera system in Abbeville, in Vermilion Parish and throughout Acadiana. We will have access to his entire network of cameras, city to city and parish to parish. We are part of a larger network of cameras that include the City of Abbeville and the Vermilion Parish Police Jury who are also in the process of acquiring this camera service in and around Abbeville and Vermilion Parish where the Sheriff wants these cameras to be. They are also networked in Lafayette Parish including Lafayette, Youngsville, Broussard, Maurice and Opelousas and several other places. If we have an incident here whereby some crime has taken place in a particular area and a camera picks up a red ford explorer, they can track the vehicle through the cameras and through the networks going through. Chief Spearman stated they have utilized these cameras in this fashion already. Mayor Piazza stated we have 9 of these locations already. They just put two more up recently. These cameras are very expensive and Mr. Brooks will not continue to put those up for free. The cameras work very well and we have made arrests based on the footage. Mr. Brooks knows that and that is why he has offered those in the past for free. He also knows these cities will want more and down the road it will be an expensive proposition. It is worthwhile. Lieutenant Jason Hebert stated the cameras have been very useful and have helped solve many crimes. Chief Spearman stated the cameras help solve the crime of the murder of the 16-year-old. Councilman Broussard stated everyone on this Council knows the extreme value of the cameras to the safety of the citizens of Abbeville. He has talked to the Mayor for years to try to get that in place. He is glad the Chief is implementing this now. The camera never goes on vacation, it never catches COVID, it doesn't go on maternity leave and these cameras are the best investment we can make in fighting crime. Councilwoman White stated she agrees but she needs to know if something happens to the cameras, then are we responsible or will he fix those. She needs to know those details and is 100% onboard for us budgeting the money. It is necessary for fighting crime in Abbeville. She cannot approve this contract tonight without reviewing it. Mayor Piazza stated there is another issue with the budget too because it is a cooperative endeavor and not a purchase of cameras, which we don't want to do because there are other issues involved if we own them. It is not a sales tax item. We have to find this amount of money in the General Fund and that will not be easy. He knows the Council is uncomfortable voting on this tonight since they have not yet been able to review the agreement. He is not positive that he can work this into the General Fund

but he will work hard to get it in there with the auditor. He recommends that the Council grant him the authority to meet with the auditor to see if this can be worked into our current and future budget and to authorize him, Chief Spearman and Ike to negotiate the terms of the contract and get back with the Council. Councilwoman Broussard stated she would agree to that because we need to keep our citizens safe. Councilman Plaisance agreed this is a critical need.

-09 introduced by Mr. Francis Plaisance and seconded by Ms. Terry Broussard to authorize the Mayor to meet with the auditor to see if the cooperative endeavor agreement for the camera service can be worked into our current and future budget and to also authorize him, Chief Spearman and Ike to negotiate the terms of the agreement and to present the final agreement to the Council for approval. The motion carried unanimously.

Richard Primeaux, Engineer

- We will open bids for the Flood damage reduction project on 1/14/2021 and will present those at the 1/19/2021 meeting.

Ike Funderburk, City Attorney

- The Governor has put us back into a modified Phase 2 with COVID. He has a copy of the proclamation and can email it to the Council if they want it.

Mayor Mark Piazza

- Before coming to the meeting, he watched Dr. Henry Kaufman, Jr. on the television. He was pleading with the public. He is the Chief surgeon at Lourdes. Many of our hospitals are at capacity and they are talking about shutting down unnecessary surgical procedures and only hospitalizing people in critical condition. We need to do what we are supposed to be doing and take COVID seriously. It is far from over.
- Under the advice of Councilwoman Terry Broussard, he gave Pastor Walter August a telephone call this afternoon. They had a long discussion about several issues in Abbeville. He is a minister to several of our youth in Abbeville that have been to his church in Houston during summer camp. Pastor August is a product of Abbeville High School and he was born and raised in Abbeville. He has a lot of concern and care for Abbeville especially regarding the crime we have suffered through this year. Pastor August stated that law enforcement is very reactive to the crimes that happen and we have to get to our community before some of these crimes happen. The way to do that is through parents. Parents have to take responsibility. That is what he and the Mayor spoke about in detail. Pastor August's suggestion is that we have a committee formed with some of the religious leaders in our community that may want to undertake this and reach out to some of the families of some of the high crime areas and some of those who have suffered through crimes. We are dealing with a lot of juveniles. Somebody needs to reach out to the parents and grandparents of these juveniles to see if we can do something to help with their family situation. That is something he will work on with the help of Councilwoman Broussard and Councilman Francis Plaisance. Councilman Plaisance worked a lot with children with his previous job dealing with child protection. This would really help our police department out. We need to get into some of these homes before the crime happens. Mr. Norman Levine stated that his child knows that if he hits him then he (Norman) can be arrested. That is a problem. Councilwoman Broussard agreed and stated the kids know they can call 911 or tell their teacher then the parents will get in trouble. That is State law. Councilman Touchet stated he has four boys. It is what you do, as a parent, in their formative years that counts. You have to stay on that and if you have to discipline them then you do. You shouldn't beat them but they can be spanked so that they understand right from wrong. The government is not telling you that you can't raise your kids. You

can raise them. When you have boys, they will want to test you but you have to start early. We have to make sure that parents are educated. Our young people need to understand that when they have babies, you can't pass them off on grandparents or someone who is not totally responsible. We have to make sure our parents are parenting as soon as they come out of the womb. He has worked in the educational field for 30 years. He sees it. He has worked in Abbeville and has had to discipline kids at Abbeville High School. It goes back to having parents that will do what they have to do in those formative years and continue with that, consistently, until they become teenagers. That is what society is missing. Yes, you can spank your children and you can discipline them. Chief Spearman added that according the State law, parents have the right to discipline their children. They cannot beat them and leave marks all over but they can discipline them. They can spank their children. Councilman Plaisance added that there is a big misunderstanding out there. There is a difference between discipline and abuse. People have misunderstood that. He has taken photographs of an autopsy of kids that were beaten to death in this parish. We need to try and get a parent group together and talk to them about parenting and how to parent the children. Parents need to be responsible for the actions of their children. We need to teach them the difference between discipline and abuse. You can spank your child. We have to start somewhere because it starts in the home. We can't correct any of these problems unless we go to the parents and start right there. We tried it in the churches but you are preaching to the choir. Those people are not the people we have to be concerned about. We have to be able to reach out and get the parents involved with their children. Chief Spearman stated if we start this then it needs to be consistent. We can't start a program with 50 people then it gets weened down to only 2 or 3 showing up. It can't be that. We need to also bring people in with educational backgrounds too.

Councilwoman Roslyn White

- When we had the Peace March a lot of church leaders were there and there was conversation then that this would continue. The Christian Service Center and St. Mary Magdalen put it on but it had a bunch of other religious leaders so maybe we could reach out to them. No other meetings happened probably because of COVID but they had people who were engaged into a start of that conversation and working on that. She has the contact information for that.
- Drive through COVID testing site this Friday at the Vermilion Parish Health Unit on Charity Street. It is free testing. The Vermilion Parish Office of Homeland Security has more information if you need that. It is also on the City's Facebook page. It is from 8:00 AM to 3:00 PM.

Councilman Francis Touchet, Jr.

- Told Clay that the focus on the grass cutting crews should be on picking up litter right now since the grass is not growing.

Councilman Brady Broussard, Jr.

- We have hundreds of street lights out in the City of Abbeville. Being hit by Hurricanes Laura and Delta have caused a lot of damage to those. We have a dire shortage of personnel in our electrical department. They are doing Christmas decorations now. He would like to see if we could get FEMA reimbursement for the street light damages. Maybe we could bring contractors in to repair those. Mayor Piazza stated the FEMA representative will be here Thursday and he would ask him about that. Charlene had asked Stewart to try and do the Christmas lights because of the Christmas Stroll. The Stroll has been cancelled. The Christmas lights are not as critical as they were. We can ask Stewart to concentrate on street lights instead. The Council agreed this would be a good thing for Stewart to work on the street lights since the Christmas lights are not as critical. There is a Farmers Market Saturday in Magdalen Square.

-01 introduced by Mr. Brady Broussard, Jr. and seconded by Mr. Francis Plaisance to accept the resignation from Elliott LeLeux from the Abbeville Police Department effective December 11, 2020. The motion carried unanimously.

Mr. Gerald Gaspard stated the American Legion has been doing a food drive that is dedicated to needy veterans. We are in the process of looking for more veterans since about 22 have passed away. We are partnering with Super One Food. They have helped us tremendously. Right now, we have between 8,000 to 9,000 pounds of food that we will distribute. Anybody that knows any veterans' families or any civilian families that are in very dire need let us know. We take care of the veterans very good. The food will take care of them for over a week. We have also been able to give them a \$20 to \$30 gift card for other assistance. Our monetary donations have been very slim this year. Friday we will have a food drive at Super One. We hope to get groceries and monetary donations. We will vet those on the list. We will distribute the food Tuesday of next week. It all goes to a very good cause.

-02 introduced by Mr. Francis Plaisance and seconded by Ms. Terry Broussard to ratify bills paid in the month of November 2020. The motion carried unanimously.

Mayor Piazza asked if there were any comments from the public on any agenda item prior to action. There were none.

Touchet/Plaisance Resolution R20-24 A resolution granting the authority to the Mayor to negotiate and execute a contract with Terracon Consultant, Inc. to provide an accredited asbestos inspector for the City's FY 2019 LCDBG Clearance Program.

The motion carried unanimously.

-03 introduced by Mr. Francis Plaisance and seconded by Ms. Roslyn White to approve the quote from Homeowner's Construction in the amount of \$6,160.00 for repairs to structures at various parks that were damaged as a result of Hurricane Delta. The motion carried unanimously.

Touchet/Plaisance Resolution R20-25

A resolution to authorize the Mayor to execute an intergovernmental agreement with Sheriff Mike Couvillon to create the Vermilion Parish/City of Abbeville Major Crimes Task Force.

The motion carried unanimously.

Plaisance/White Resolution R20-26

A resolution adopting the legal holidays for the City of Abbeville for calendar year 2021.

The motion carried unanimously.

Mayor Piazza discussed the proposed electronic billboard to be located on Park Avenue. The location is at the intersection of Highway 14 and Highway 167 at the Bypass. It is a little bit setback from the corner. It is between the white house on the corner and Riverfront. It will be an electronic flashing billboard. He is concerned about the safety of the public. This intersection has already been a dangerous intersection. These signs can be blinding at times and a distraction. We have had a lot of accidents at that intersection. The City has ordinances that prohibit these kinds of signs. That particular piece of property is not in the City limits. We have 5 or 6 sections of property or islands that are surrounded by the corporate limits of the City. That piece of property is not under the jurisdiction of the City's ordinances. They do not apply. They applied either to the State or the parish for their permit. Mr. Primeaux stated they received their permit from the State. They received their electrical permit from the parish. The parish does not have a sign ordinance. Councilman Touchet stated that Councilman Plaisance has been screaming this for years. This is a prime example of why islands within the City are things that we can't control. The state and the parish never communicated with the City about this situation. If something happens at that intersection, it is the state's fault. The state gave them the permit. If something happens then go after DOTD. He can't believe that the parish did not look at the location of this knowing the relationship that we have and try to communicate this to the Mayor. We could have tried to stop this. If something happens at that intersection then the parish is responsible too. Councilwoman White stated that we asked them to honor our ordinances at that intersection. Councilman Plaisance stated he has brought up the issue of unincorporated islands many times in the 14 ½ years he has served. Suppose they put another one up by Langlinais Tractor? That is not in the City. There have been several fatalities in front of Walmart. What if they put one up by the old skating rink on North John Hardy? There have been several accidents at that intersection. He has asked lke to look into what can be done for these types of islands. This has created a serious problem on the corner of Highway 167 and Highway 14. This will continue unless

we don't box in these islands since we have no control over them. Councilman Broussard asked if the Council has noticed that there are two sets of rules that DOTD applies to business and applies to the City of Abbeville. We are treated lesser. Why do we have to have a Styrofoam Welcome Sign yet a business can put a metal pipe? We are told that we had to have a collapsible sign next the highway but business can put something that can kill somebody. Councilman Touchet stated he spoke to the owner of that particular property. He has a 15-year lease with two additional renewal terms after that with a very lucrative monthly payment. The lease is done and the permits have already been issued. The sign will be up this week. Mr. Gene Sellers stated he believes that there is case law that these islands have to abide by the laws of the corporate limits that surround them. Also, if you have an island, you don't have to have a petition to annex it. Mayor Piazza asked if Councilman Broussard had reached out to a couple of jurors. Councilman Broussard stated he did and those juror's think it would be a good idea for these unincorporated islands to follow the ordinances of the City. Councilwoman White stated this sign is in her district and 90% of the time she believes people own their property and the government shouldn't tell them what to do with it but she thinks this comes down to being a good neighbor. If your neighbors don't want it and no one around you wants it and we have ordinances against it but you take the dollar over it, it is extremely disappointing. She is disappointed in the land owner in putting their financial situation and the dollar over the community. Every child that goes to school there will be subject to whatever is on that billboard. It is a distraction to drivers and to our community. We work so hard to keep our historic authenticity but then you have a huge digital billboard right there. We worked hard to try to discourage the land owner from doing it and to try to get the Police Jury to work with us but unfortunately, we failed at that. A constituent that was in the audience stated that when she saw the big truck there this morning, she was very distressed. She is a property owner on Park Avenue. This is not only a distraction to drivers but it disrupts the aesthetic view of our community. We try to beautify our community and the Community Foundation just gave us some money to try to beautify the community and then we have something like this coming up in the most inappropriate place. Right when you drive into Abbeville, that is what you will see. She supports the opposition the Council is showing. She went online and read the ordinances and asked if there is anyway you can put a perimeter around to show that you don't want this kind of sign to come in. She understands that the City's ordinances do not apply in this case because the sign in on an unincorporated island.

-04 introduced by Mr. Francis Plaisance and seconded by Ms. Roslyn White to oppose the sign that is going on the unincorporated island at the corner of Highway 14 and Highway 167 and to send a letter to the State and the Vermilion Parish Police Jury requesting that the City be notified of a proposed sign prior to the granting of permits on these islands that are in close proximity of the City limits.

-05 introduced by Mr. Brady Broussard, Jr. and seconded by Ms. Terry Broussard to table the request for a variance from the sign ordinance for 115, 117 and 119 Concord Street. The motion carried unanimously.

Mayor Mark Piazza

- Wished everyone a Merry Christmas and a Happy New Year. 2020 has been the worst year since he has become Mayor with COVID and two hurricanes. Bring on 2021.
- He asked Councilman Broussard about the upcoming Park and Recreation Board meeting. Councilman Broussard stated the meeting will be held on January 12, 2021 and it will be advertised. Councilwoman White requested formal proposals so they could examine them before the meeting.

Kelly Mire, Assistant Fire Chief

- The unincorporated islands cause a problem for the fire department. We have had issues with them burning trash and we are being told to get off their property because they reside outside the City limits.
- We have been looking at a different type of rescue boat. It is all plastic. In 2016 flood we could not run the fire trucks through the streets. There is a grant they applied for with the Rotary Club for \$13,400.00. We will buy the boat with the trailer with the grant funds and we will buy a small motor for it with our funds. The Rotary Club will pay for the boat directly then donate it to the Fire Department. Mayor Piazza asked Chief Kelly to thank the Rotary Club for this. The Rotary Club has been a tremendous help with a lot of City projects.

Councilwoman Terry Broussard

- Wished everyone a Merry Christmas. May God continue to bless you.

Councilwoman Roslyn White

- Received three resumes for the digital media assistant. These are three very good candidates so far. We put it out to the schools, SLCC and ULL.

-06 introduced by Ms. Roslyn White and seconded by Mr. Francis Plaisance to enter into executive session to discuss pending or threatened litigation and the state of emergency for COVID issues. The motion carried unanimously.

-07 introduced by Mr. Francis Touchet, Jr. and seconded by Ms. Terry Broussard to reconvene the regular meeting from executive session. The motion carried unanimously.

Mr. Funderburk reported that during the executive session we discussed possible policies in regards to vaccinations of City employees once the COVID vaccine becomes available. We also discussed the situation with regard to the placement of a digital billboard within an island of unincorporated land within the corporate limits of the City of Abbeville. He has laid out the plan that he asks the Council to consider and if approved, authorize him to move forward with the plan. He would like the Council to authorize him to send a letter to Rue Outdoors Advertisers ordering them to cease and desist the construction of this billboard because it violates our existing ordinances and to further inform them that it is the intention of the City of Abbeville to annex that subject property by any means that is lawfully available to the City. In which case, once the annexation is complete, they will have to take down their non-conforming billboard. Councilman Plaisance added that we need to annex all the other islands too.

-08 introduced by Mr. Francis Plaisance and seconded by Mr. Francis Touchet, Jr. to authorize the City Attorney to send a letter to Rue Outdoors Advertisers ordering them to cease and desist the construction of this billboard because it violates our existing ordinance and to further inform them that it is the intention of the City of Abbeville to annex that subject property by any means that is lawfully available to the City. The motion carried unanimously.

Mayor Piazza stated that he would like to continue to pursue, with the assistance of our State delegation and the Vermilion Parish Police Jury, to help us with the unincorporated islands of the City and to potentially for the Jury to piggy back and recognize the ordinances of the City of Abbeville for these specific islands in the meantime until we can get the State legislature to act and if we can't that they would continue to recognize our ordinances within the City of Abbeville. Councilman Broussard stated the Jury is waiting for their attorney to talk to Ike and then they will be ready to present that. The attorneys have to give the language. Mayor Piazza added that we

may be able to get the Jury to act quicker than the legislature. The legislature will not convene until April or May. Even if the Jury's actions are temporary.

-09 introduced by Mr. Francis Touchet, Jr. and seconded by Mr. Francis Plaisance to continue to pursue, with the assistance of our State delegation and the Vermilion Parish Police Jury, to help us with the unincorporated islands of the City and potentially for the Jury to piggy back and recognize the ordinances of the City of Abbeville for these specific islands in the meantime until we can get the State Legislature to act and if we can't that the Jury continue to recognize our ordinances within the City of Abbeville. Mayor Piazza asked Mr. Charles Dill to lead those assembled in prayer. Mayor Piazza asked Mr. Andrew Dozier to lead the assembly in the Pledge of Allegiance.

Mayor Mark Piazza presented Mrs. Darlene Fontenot a certificate of recognition for her years of service to the City of Abbeville. Darlene worked at City Hall and has retired after 36 ½ years of service. She has been a devoted and faithful employee for many years. She is also the wife of our Water Plant Superintendent, Roger Fontenot.

Mayor Piazza asked if there were any comments from the public on any agenda item prior to action. There were none.

Mr. Onezieme Mouton was requesting a variance from the sign ordinance for his properties located at 115, 117 and 119 Concord Street. He distributed pictures of the properties prior to the renovation of the properties and after renovations were complete. He also distributed pictures of the sidewalk view of the banners and other banners on other historic buildings. Mr. Mouton stated he is here tonight because the banners are not in compliance with the City's Sign Ordinance because of the type of material they are printed on not because of their size or location. As it is, it is considered a banner and has a 14-day limitation that is can be displayed. He put the signs up before applying for a permit due to his negligence because he did not know there was such an ordinance. He did look on the website regarding the historic area but he did not see it there. He knows ignorance is not an acceptable excuse for not complying. It is not the tenants' fault, it is his. Once he was alerted by Mr. Funderburk about the non-compliance, he filed the application for the permit. They were rejected because they are not in compliance with the ordinance because

they are a fabric material. That is why he is here today to present a case and request in the hopes the City will consider granting a variance on these signs in this particular location. There is something happening in this building on Concord Street. He started this project 12 years ago and since that time we have had the most tenants ever in its history. Recently, up until a year ago, we had one tenant occupying the whole building. Once they left, he has had one tenant occupying the downstairs floor for one year and then another tenant started a business that came from her home office to the retail and is on the ground level. She is having a measure of success as a start up business. Even as remarkable as that is, we have a retail business located on the second floor. We have three tenants in the building right now. We actually have a second-floor women's boutique that is doing as well or better than they were on the ground floor in the historic downtown area. It was his hope and inspiration so that these banners could alert the public to the existence of these businesses at these locations in a way that is very tasteful and respectful to the architecture of the building and in some way enhance their building. It is their hard work that is making their business exist. His role is to give them a place and to maintain the building. He put a lot of effort to maintain the historic attributes of the building. Please take it into consideration tonight that these businesses are doing well in a historic building. We need more of that in Abbeville, not less. He is hopeful that is considered tonight. The architecture of these buildings is very permanent. They have been here forever and they will last forever. The nature of the banner is a very temporal thing in nature. They are very temporary. We have them on these steel powder coated flagpoles. It fluctuates in the wind ever so slightly but it causes attention to those passing by. It shows that there is something going on there as opposed to a fixed sign mounted to the building. The retail businesses there need a fluctuation to show there is something fun happening here. It is not like an attorney's office that would have a permanent sign attached to the wall to show they are here permanently. There is very minimal invasion with these banners in terms of the historical facade of the building. It is not permanently damaging the building in any way. It is a way to give these businesses an opportunity to identify themselves and enhance relationships on the people passing by on the street. It is meant to bring in traffic into their businesses. This is not unprecedented in terms of a variance. Ten years ago, we submitted a letter to the State Fire Marshal requesting a variance to scrap the entire national building code and let us adopt the national life safety code because it has a provision in it for historic buildings. The Fire Marshal understood, with this letter, looked at it and realized what we were trying to do. If we try to apply codes that are meant to be applied to modern buildings and try to apply those to historical buildings, it will not enhance what we are trying to do. They understood that we had something special here and they allowed us to take the entire code book, throw it out and adopt another code book that had provisions for historical buildings in it. Thankfully that prevented us from not having to do something very inappropriate for the inside of these buildings to make is compliant with the code. In some regards, we have the same situation here. He understands that codes and ordinances are written to prevent bad things from happening but he thinks, in this case, we might have an ordinance that would prevent something really good from happening. He hopes this is part of the solution for getting more businesses in the downtown buildings. Mr. Andrew Dozier stated their job on the Planning Commission is to look at the application and other documents as the final review. When it came to us, we reviewed the City's ordinance and the one that was adopted in 2014 said no banners. We consulted legal to make sure we had interpreted it correctly and we did. A sign for a business has to be a sign, not a banner. We have no issue about the quality. He loves them. He has been all over the world and you see them everywhere. We based our decisions on the ordinance and now Mr. Onezieme has the right to come before the City Council to request a variance. Councilman Plaisance thanked the Planning Commission for coming tonight. We have these ordinances for signs and businesses have to conform to our ordinances. He is concerned that if we grant a variance then we will set a precedent. The banners are very nice and he has no problem with them but it is a problem with the ordinance. We have to decide to adhere to our ordinances or not. Mr. Andrew Dozier stated

that all five members of the Commission agreed that is did not meet the threshold of the ordinance. They put it back on the table and maybe the ordinance needs to be looked at again. Mr. Charles Dill stated that we put this ordinance in place because of banners. Over a period of time banners can deteriorate and they are not meant to last. Where do you draw the line? If we give a variance here, somebody else may make the same request with banners that are not made of this quality. We have to draw the line somewhere. We based our decision on the ordinance. Councilman Broussard stated that we cannot say enough good things about what Mr. Mouton has done for our downtown. It is never a good thing when an ordinance is either deliberately or accidently ignored and it sets a bad precedent. Speaking of banners, there are a lot of smart people in our City who spent years developing the sign ordinance. Those people study communities across Louisiana and Ike has presented examples of similar sized communities. We did not adopt a sign ordinance that was extreme either way. We are in the era of banners now. He does not believe it is fair to pick on Mr. Mouton when we have a number of banners down Charity Street with no enforcement. We have many banners on the By-pass that are not enforced. He has the most attractive banners. There has been a lack of enforcement of the sign ordinance and everyone is guilty of that. He hopes that we would look at this opportunity to adjust our ordinance for what is now an era of banners. The classy banners not the trashy banners. Some of these banners have become permanent attachments of businesses even though they are supposed to be up for only 14 days. These are cheap banners. If we are not enforcing those now that distract from our beauty why are we going to try to stop what enhances our beauty. Mayor Piazza stated that he agrees. Charlene Beckett stated she was in the beginning stages of creating the sign ordinances with the Center for Planning Excellence out of Baton Rouge. We spent many hours trying to do the right thing. She has been the Main Street Manager for 25 years and there is a Community Preservation District that does address signage and it is on the website. She and Onezieme have worked together on many projects but she also works with the Planning Commission. She knows how hard and serious they take their jobs. It is very difficult to say the signs are beautiful and we like them but they are going against our ordinance. She is grateful that she doesn't have to make that decision. She has to support the Planning Commission because she works with them on a regular basis and they do their research and they try very hard. She is not against Mr. Mouton, and she thinks he knows that, but the Council has to make a decision as to how the ordinance will read in the future. She has been photographing signs that have been damaged as a result of the hurricanes and they will be coming to the permit office. It will be tough. Mayor Piazza stated he agrees the Planning Commission is there to do a job and they are doing their job and what they have done is that they have brought to light, to the Mayor and Council, a flaw in our ordinances. These banners are very tactful and are very nice looking in our downtown area and they promote our businesses. We want to help do that. Not all ordinances fit all businesses in all areas. The reason we created the ordinance to begin with is because of some of the bigger businesses on the By-pass. It has nothing to do with downtown. He thinks we need to look at changing this ordinance and modify it. The ordinance can be curtailed so that your ordinance is different for different areas of the City. Mr. David Ashley stated a few months back they had a big discussion about signs in regards to what is appropriate and what is inappropriate. We got into a big discussion to see who was going to step up and say what is appropriate. We are doing the same thing here. Mr. Onezieme has put up some very nice banners and that is not the problem but who is to say that someone else wants to put up a banner and recognizes that this variance was granted. If you guys are going to do that, then what is the Planning Commission here for? It is not that it is inappropriate but it is made out of material that is not right. Councilman Touchet believes we should not be making changes to ordinances. If we have to address that with enforcement then we will. If we have issues with things on Charity Street and on the By-pass then we need to turn those things in. He thinks we need to deny the request based upon what the ordinance is saying and if we want to make changes then we adopt something different for this particular area. We can't determine what is nice and what is not nice.

Once we make the changes, it can be brought back to the Planning Commission. Mr. Funderburk stated that he tries to be as neutral to things as possible, but he has told the Planning Commission several times that they are not arbiters of good taste. Just because something is tacky doesn't mean it is not legal. The reverse of that is also true. Just because something is done in good taste doesn't mean that it is legal. We have an ordinance that has been adopted and has been complied with by everybody that has filed a sign application. He has no problem with going back in and fine tuning the ordinance. We didn't do everything right the first time. It took years to figure out some of the formulas we had to have for footage. The three gentlemen here from the Planning Commission are passionate about the work that they do and the other two members that are not here tonight are maybe even more passionate. We need to support them and we need to support our ordinances. Ms. Natalie Arabie is a merchant whose business in in one of the locations on Concord. When she first opened, she had a sticker sign. It wasn't anything that attracted business. This banner is made out of a mesh and can last up to 15 years. Since the banners have been up, we have had a lot more attraction downtown. There are more people in the downtown area. They love the signs and they love seeing business downtown. The banners are the era and they are attracting more people to come downtown. That is important. Councilwoman White asked what would it take to take the signs down. Mr. Mouton stated they are designed to be installed easily and easily taken down. It has potential because they are easily interchanged. Councilwoman White was concerned about how much are we hurting those businesses. Mayor Piazza stated that Mr. Onezieme brings up an interesting subject. Are we in violation of our ordinance with our banners for the Omelette Festival and other festivals? Mr. Funderburk stated no because we have specific allowances for festivals and they are on our telephone poles and they are not permanent. They are not banners for a business. They are banners for either a festival or an event. Councilwoman White asked Mr. Mouton if the cost of material enhanced the decision. Mr. Mouton stated it did as well as the nature of the business. With this type of business this is an appropriate material. Councilwoman White stated she appreciates the volunteer work from the Planning Commission. It is so important. This discussion is not to undermine the Planning Commission's authority. We know more and more businesses are dying in Abbeville and we have buildings across from St. Mary Madgalen Church that are falling apart and we are not addressing that. In this unprecedented time that we are in, we need to give special considerations to the few businesses that are trying to survive in our City. We have a responsibility to make sure we are not killing or creating a hurdle that businesses can't get over and can't operate. It is our job to continue to look at our ordinances as print materials change. She believes in upholding the ordinances but she would like to see us give them a temporary stay while we reconsider the ordinance. If we come to the conclusion that we will not have banners then at that time you would have to take them down and change the material. But if we come to the conclusion that we will allow them, then you haven't hurt those businesses and caused more work for them. Mr. Funderburk suggested that we table this item and then bring it back up after he has had an opportunity to get with the Council and see what they want to do as far as revising our ordinance. Let them continue to fly the banners until we bring it back up.

-01 introduced by Mr. Francis Plaisance and seconded by Mr. Francis Touchet, Jr. to deny the request for a variance from the sign ordinance for 115, 117 and 119 Concord Street as discussed and to move the ordinance back to the ordinance committee for modification.

SUBSTITUTE MOTION: Introduced by Mr. Brady Broussard, Jr. and seconded by Ms. Roslyn White to table any action regarding the request for a variance from the sign ordinance for 115, 117 and 119 Concord Street and to request the City Attorney to meet with the Council to determine if any modifications on the ordinance are needed regarding banners. The substitute motion was put to a vote and the vote thereupon was as follows:

Pastor Crystal Randle could not attend the meeting tonight to discuss the upcoming Dr. Martin Luther King, Jr. celebration so Councilwoman Broussard discussed the topic. Councilwoman Broussard shared the information that Mr. Elbert Dawson gave to her regarding the celebration. At 10:00 AM on January 18, 2021 there will be a Stomp Service as in the past. Then there will be a motorcade. The route will be short and Mr. Dawson has already spoken to the Police Department regarding this. From 11:00 AM to 12:30 PM they will be at McKinley Scott Park. Because of COVID they are not going inside the building and will not have the breakfast. Mayor Piazza stated he spoke to Mr. Dawson last night. Mayor Piazza stated there are a couple of things he wanted to be clear on. He is fine with the Stomp Service as long as everyone has on their mask and socially distances. We are calling it a motorcade and not a parade. There is nothing that can be thrown. No candy or any other throws. We will not send people to clean up after this. The *City can take very little part in this activity. We cannot be part of something that could possibly* spread COVID. We have to comply with the Governor's orders. The Governor's orders say that there is a maximum of 150 people for an outdoor event as long as they can socially distance themselves. You will only be able to let so many people in at a time when you get to the park. You will have to be spread out and we can't have three hundred people gathered at the park. Councilwoman Broussard stated she would notify Mr. Dawson about the requirements discussed.

The motion carried unanimously.

Richard Primeaux, Engineer

- We are currently bidding out the Flood Reduction Project.

Ike Funderburk, City Attorney

 Yesterday, he, the Mayor, Councilwoman White and Councilman Broussard attended the Vermilion Parish Police Jury meeting because there was an agenda item on there wherein we had hoped that the Police Jury would adopt our sign and billboard ordinances to be applied uniformly in the five unincorporated islands within the City limits. These are not part of the City but they are surrounded by the City limits. An electronic billboard recently went up on one of those islands near the intersection of Highway 167 and Highway 14. This would not have been authorized by our current billboard ordinance but since it is not in the City limits, our ordinances do not apply. The Police Jury tabled our request for them to do this so we will be working with the Abbeville delegation to see if we can't find some type of common ground to make this happen.

Mayor Mark Piazza

We have two department heads that are out. One was positive for COVID and the other one is out because her husband was positive with COVID. We have two electrical people that are out. That department is extremely shorthanded. It is still going around City employees so there are a lot of departments that are shorthanded. We are dealing with it the best we can. Jude Mire, Fire Chief

- The Moderna vaccine for COVID was administered to 13 fire department personnel on 12/29/20 and the second dose is scheduled for 1/13/21. Right now, we have 4 out with COVID issues.

Councilwoman Roslyn White

- She is upset by the lack of action by the Police Jury and the complete disrespect they showed the Mayor when he spoke on behalf of the City. She was disappointed that none of the Jurors for the City spoke on behalf of the citizens they represent. The motion was tabled therefore no action was taken. She went home and researched and if your property is within 500 feet of a billboard your property value is decreased by \$30,000. To say that people can do what they want with their property and we shouldn't tell them better is a poor excuse because it does affect your neighbors monetarily as well as environmentally and personally. The Mayor did a very good job but it was very obvious very quickly that there was going to be no consideration for it. She was contacted by residents who live in unincorporated islands next to where this billboard went up and they want to write a letter to the Police Jury asking them to follow our ordinance. She encouraged them to do so. We as a City should ask residents to reach out to their Police Juror to let them know if they are for it or against it. We also learned that there is another billboard going up on Highway 167 at Sandpit Road. This affects our businesses.
- We will interview for the Digital Media Assistant position immediately following this meeting.

Councilman Francis Plaisance

- Unincorporated islands and abandoned buildings are hurting our City.

Councilman Francis Touchet, Jr.

He asked Ike to make the issue of unincorporated islands a priority. See what we can do. We need to do what we can. We have to have control over those particular areas. Ike stated he has done a lot of research on this subject and he has spoken to the Mayor extensively. He would like to have a series of meetings with the Mayor and one or two Council Members at a time where we can get our goals and objectives in order and he can give them the benefit of the research that he has done up to this point. This information would be inappropriate in a public meeting on his part. He invites the Council to find time in their schedule in order to coordinate this so we can move on this quickly. We don't have much time to get this done.

Councilman Brady Broussard, Jr.

- Agree with the sentiment that what the Police Jury did was predictable but disappointing. Abbeville, as the Parish seat, is know as Somewhere Special on the River not Somewhere Average on the River. What we fight for is worth fighting for and together we can improve our community for our citizens.

There being no further business to discuss, Mayor Piazza declared this meeting adjourned.

Mayor Piazza stated we are here for a Finance Committee meeting chaired by Councilman Francis Touchet, Jr. He turned the floor over to Councilman Touchet. Councilman Touchet stated we are here to introduce the proposed budget for 2021 and amended budget for 2020. He asked Mr. Steve Moosa to present the information.

Mr. Moosa stated the Mayor has put the budget together for 2021 with Council members and department heads. Page one is the Mayor's letter. Mr. Moosa discussed the details of the letter. The third paragraph of the letter discusses that the full -time employees of the City will receive a 2% pay raise on their anniversary date. Page two shows the general fund and special fund revenues. These total \$4.9 million. The expenditures in the general fund are about \$10.8 million. We fund this with transfers from the Utility System Fund. The 2012 debt service will be paid off early in 2022. That will free up some money in the Sales Tax Fund for capital outlay projects. Mayor Piazza discussed specific items in the budget that he wanted to highlight. We will have a 2% pay raise for our employees. The general fund does include reimbursement from FEMA for the two hurricanes in 2020 and also Hurricane Barry in 2019. This is something we hope to receive. We have depleted our FEMA fund and have used Sales Tax and Utility System Fund reserves to pay those expenses. He will try to get a breakdown of those three storms and what the costs of the storms are. Kathy is working on Hurricane Laura right now and those project worksheets. In 2021 we have allocated \$25,000 to complete the splashpad and \$50,000 for the walking trail at LaFitte Drive-In Park. We have received a \$50,000 grant for the walking trail and hope to receive another \$50,000. We have \$10,000 for park equipment. The Mayor and City Council discretionary budgets have been increased to \$6,000. The flood protection grant will include \$115,000 in Sales Tax money, \$10,000 coming from economic district #1 and \$375,000 from the state grant. Resurfacing and bridge repairs on Hollingsworth will be \$75,000 and the Police Jury has agreed to match that same amount so the entire project will cost \$150,000. We hope to purchase property adjacent to the Abbeville RV Park for \$16,000. We have allocated \$5,000 for the completion of the new website and City video. The proposed City action and city plan will have a budget of \$5,000. The LCDBG demolition grant program is a \$20,000 City match with a \$250,000 grant. The streetscape phase two project is a \$50,000 City match and the remainder is a state grant. There is no additional money in the 2021 budget for police units because we are still paying off the lease for the units they purchased last year. There is \$71,000 for police department cameras in various areas of the City. We have budgeted \$30,000 for repairs and clean up of the concrete coulee. We hope to get the drainage board and the police jury involved to help us in that project. There was one project that was not put in the budget because he needs to wait to see what will happen with the reimbursements from the hurricanes. Once we know for certain what we will be reimbursed he would like to bring that back up to the table because it is a worthwhile project. He hopes to have that answer in the

summertime and we can do a budget amendment then. That project is to raise the pavilion at McKinley Scott Park. That is about \$130,000 to \$150,000. He knows that Councilwoman Broussard was disappointed that this did not get put into the budget. He is the one who has to be fiscally responsible and with the funds depleting and the balances going down and getting low, he got very worried about it. Councilman Touchet stated it may take years for us to get the money back from the hurricanes so he is not sure we will know more in the summer. Councilman Plaisance stated we cannot spend money we do not yet have. The Mayor is correct that we have to be fiscally conservative. Mayor Piazza stated he is in charge and responsible for the budget and the Council can vote yes or no. They don't have line-item veto and cannot change it as they see fit. He proposes the budget. Terry has gone to bat for her district but he cannot present a budget right now that will say that sales tax will have that \$150,000 in it. We will certainly have it in 2022 because we will be finished paying the 2012 debt service. Felicia Williams stated that the pavilion has been this way for a long time and this should be priority number 1. The foundation is unlevel and causes a safety issue. This should be ahead of some of the other projects like the tennis courts. The foundation needs to be attended to. We need to find money and allocate it to the project. Councilman Touchet asked if we could fix the foundation and asked Clay to assess the foundation. Mayor Piazza asked if the Council wants to explore the cost to fix the foundation first.

-01 introduced by Ms. Terry Broussard and seconded by Mr. Francis Plaisance to explore the costs associated with fixing the foundation of the pavilion at McKinley Scott Park. The motion carried unanimously.

Mayor Piazza stated we have introduced the budget tonight and we will have a special meeting on December 22, 2020 at 5:30 PM to hold a public hearing and to adopt the budget. The budget is available for viewing at this time and it has been advertised in the newspaper.

There being no further business to discuss, Mayor Piazza declared this meeting adjourned.

Mayor Piazza stated we are here tonight for a special City Council meeting to adopt the annual budget for 2021 and to approve an engagement letter for Darnall, Sikes & Frederick. It is the appropriate process before we adopt the budget to go into a public hearing to receive comments from the public regarding the budget.

-01 introduced by Mr. Francis Plaisance and seconded by Ms. Roslyn White to enter into a public hearing to receive public comments for the proposed 2021 budget and the amended budget for 2020. The motion carried unanimously.

Public Hearing

Ms. Marilyn Mitchell wanted to know if the manager's salary for the Park and Recreation budget is included in the budget. Mayor Piazza stated the amount is in the budget. It is located on the very top line, Salaries, and it is \$30,000. That is for the Park Director. Ms. Mitchell asked if the vacant position has been filled. Mayor Piazza stated it has not yet been filled. At a meeting in January, the Park and Recreation Board will receive proposals from QSA and there will be a public hearing during that meeting to talk about whether or not they want to continue the process we have in place or if we want to go in a different direction. Councilman Broussard stated the meeting is scheduled for January 12, 2021 at 11:00 AM. Ms. Mitchell asked if QSA has submitted a proposal. Mayor Piazza stated they have not submitted a proposal in writing. We have requested that they do so. We will have a written proposal by the 12th. Ms. Mitchell asked if someone else can submit a proposal. Mayor Piazza answered yes that anyone can make a proposal to the board. Ms. Mitchell asked how much money is allocated to the Parks and Recreation Department. She wanted to know how much we spend there. Mayor Piazza stated it is on page 10 and the amount is \$329,000 in General Fund and \$135,000 in the Sales Tax Fund (page 13). The general fund expenditures are not supported by a tax. Councilman Broussard stated the City does not have a recreation tax or for the parks. That has to come out of the funds that support roads, sidewalks and public safety. Lafayette has different funding than the City of Abbeville. Mayor Piazza added that the \$329,000 comes from the same pot of money that you have to pay firemen and police from. Every nickel I spend in that department is that much less than I can spend in the fire department or the police department or the street maintenance department and any other department. Ms. Mitchell asked why are we spending money there if there are no kids due to COVID. Mayor Piazza stated they are currently taking basketball registration and they will have basketball. They are registering until the end of December. This

year, for the first time, a lot of the games will be played at Abbeville High School. The City purchased proper goals so more kids from Abbeville could play. Mr. Mark Campbell stated there is a gap between Abbeville and Erath when it comes to recreation. He has the tools to deal with Parks and Recreation. We have to have something here. He sees a lot in the community. The community is scared to come out. We have to take over now. We don't have anything for the kids here. He wanted to make a proposal. We need to have activity at night to make them feel good about themselves. Its not about stopping Tommy Picard. He is doing a good job. We can work with him. We are fighting too much in Abbeville. We need to catch kids 8 years and older and bring them here. Our children are lost right now. Councilman Broussard thanked Mark and everyone else for coming. If we look at recent history, before Tommy Picard, we got to a point where Mrs. Denise Mire had to make the same children play each other every week. That is not what you call a league. Before Tommy Picard ran the recreation, the kids would not come out. That was Babe Ruth, a City operation and the children were not here. When you have a dozen people who can only play themselves several times a week, that is not what you call a league. Mr. Mark Campbell stated everybody knows him in this City and they trust him. Mayor Piazza stated that this is a hearing about the budget. It is not a hearing about recreation. If anyone wants to talk about recreation then they need to attend the Park and Recreation Board meeting.

WITNESSETH

WHEREAS, Article VII, Section 14(c) of the Constitution of the State of Louisiana provides that "for a public purpose, the state and its political subdivisions may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private association, corporation, or individual"; and

WHEREAS, the City of Abbeville and Gravity Drainage District #2 have determined that certain property located within the City, which is subject to overlapping jurisdiction is in need of drainage repairs, and

WHEREAS, the City of Abbeville has let a contract to the lowest responsible bidder to perform the scope of work identified as items 1 and 3 of the bid sheet prepared by Sellers &

Associates, dated 02/12/2021, a copy of which is attached hereto and made a part hereof, identified as Exhibit "C;" and

WHEREAS, Gravity Drainage District #2 has let a contract to the lowest responsible bidder to perform the scope of work identified as items 2 and 4 of the bid sheet prepared by Sellers & Associates, dated 02/12/2021, a copy of which is attached hereto and made a part hereof, identified as Exhibit "C;" and

WHEREAS, the City of Abbeville shall also provide a dump truck to bring materials to the worksite on an as needed basis; and
