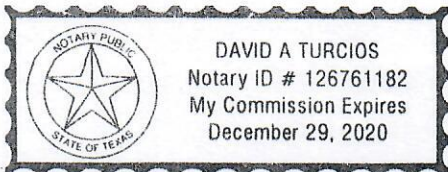

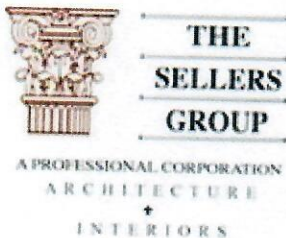
Mayor:

Please find attached a proposal from JJE Contracting, LLC to remove the Asbestos Containing Floor and Adhesive Materials found in the existing Terminal Building. While these materials are not considered friable asbestos, I recommend they be removed from the facility while they are exposed and not beneath the future floors to be installed in the project. We note that some tiles are not well adhered to the slab and could prove to be a long term problem for the new floor to be applied to, creating issues with it's adherence to the floor.

Please review and advise if we can instruct this independent contractor to remove and dispose of these materials in accordance with LDEQ Standards. Note the proposal is for \$4,420.00 for removal and \$1,000.00 for all required air monitoring and clearance testing.

- 1). Provide for ADVF (permit) as required by LDEQ
- 2). Erect containments as needed to abate approximately 327 square feet of 12 inch by 12 inch VCT tile overlaid over 9 inch by 9 inch asbestos containing VCT tile and asbestos containing black mastic adhesive
- 3). Erect containments as needed to abate approximately 530 square feet of 12 inch by 12 inch VCT tile that is overlaid over asbestos containing black mastic adhesive
- 4). Provide for proper asbestos waste disposal as required by LDEQ
- 5). Provide for Third Party daily air monitoring and final PCM air testing

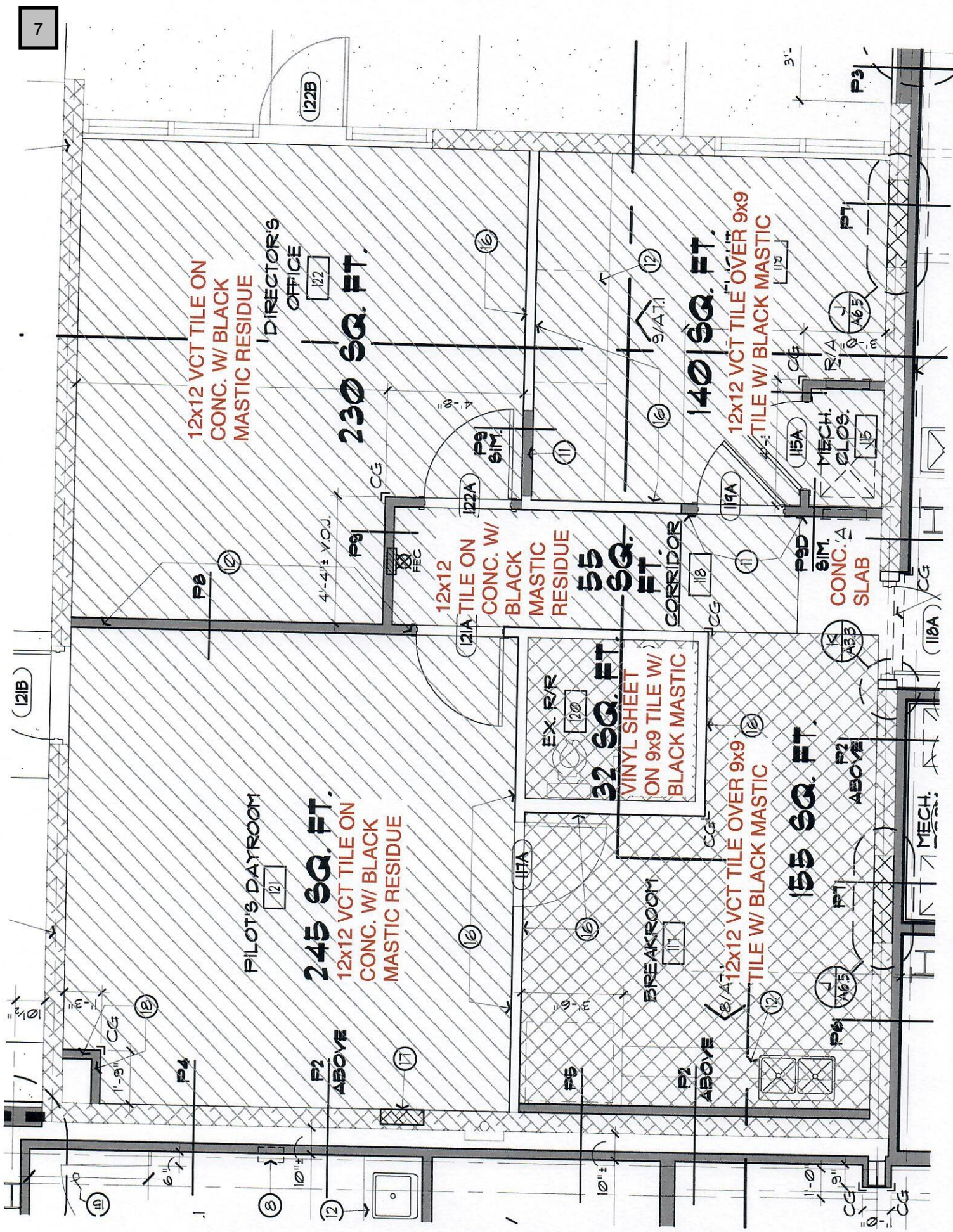

A resolution authorizing the Mayor to execute an Agreement with the Louisiana Department of Transportation and Development (LA DOTD) for improvements at the Abbeville Chris Crusta Memorial Airport.

WHEREAS, Act 451 of the 1989 Regular Session of the Louisiana Legislature authorized the financing of certain airport improvements from funds appropriated from the Transportation Trust Fund; and

WHEREAS, the City of Abbeville has requested funding assistance from the LA DOTD to/for Rehabilitate Main Hangar; and

WHEREAS, the stated project has been approved by the Louisiana Legislature and the LA DOTD is agreeable to the implementation of this project and desires to cooperate with the City of Abbeville according to the terms and conditions identified in the attached Agreement; and

WHEREAS, the LA DOTD will provide the necessary funding for the Rehabilitate Main Hangar and reimburse the sponsor up to \$200,564.00 of project cost.

NOW THEREFORE, BE IT RESOLVED by the City of Abbeville that it does hereby authorize the Mayor to execute an Agreement for the project identified as SPN H.013655, more fully identified in the Agreement attached hereto, and to execute any subsequent related documents, including, but not limited to, amendments to said agreement.
