1. Call to order.

2. Invocation and Pledge.

Marshal Dietrich offered the invocation, and all stood for the pledge.

3. Visitors to be heard.

4. Workshop.

A. Discuss the fiscal year 2021-2022 budget.

This item was turned over to the City Administrator and Treasurer. The City Treasurer states they have just started the budget process and that she just got numbers for the property insurance and those have already been plugged in. Mayor Pro Tem Gibson was wondering about going over sections at a time and each department. She would like to see more dialogue about each department. There was some questions about the longevity schedule in the Marshal's Office. Marshal Dietrich explained this was voted on years previous with a different Council. There was some discussion about why it was just for the Marshal's Office and not all departments. Marshal Dietrich suggested if they don't like it to replace it with something better. Councilmember Kunz would like dollar amounts to tie back to the amounts.

 - A. Update from Ben Rosenberg on the Texas Water Development Board funding for Flood Infrastructure Fund project.

Mr. Rosenberg spoke on the Flood Infrastructure project and provided the bond summary for the \$2.9 million, zero interest loan for 30 years with the Water Development Board. Sale date will be June 17, 2021 and close on July 20, 2021. The payment will begin in 2 years for \$99,000.00 a year for 30 years. There was no action on this item.

B. Discussion and possible action on an Ordinance amending Section 1.03.061, Place and time, of the Bandera Code of Ordinance to change the day, time, and/or location of the regular meetings of City Council.

Mayor Pro Tem Gibson moves to confirm the appointment of Max Westbook and his firm to appoint a interim City Administrator on or before June 20, 2021
