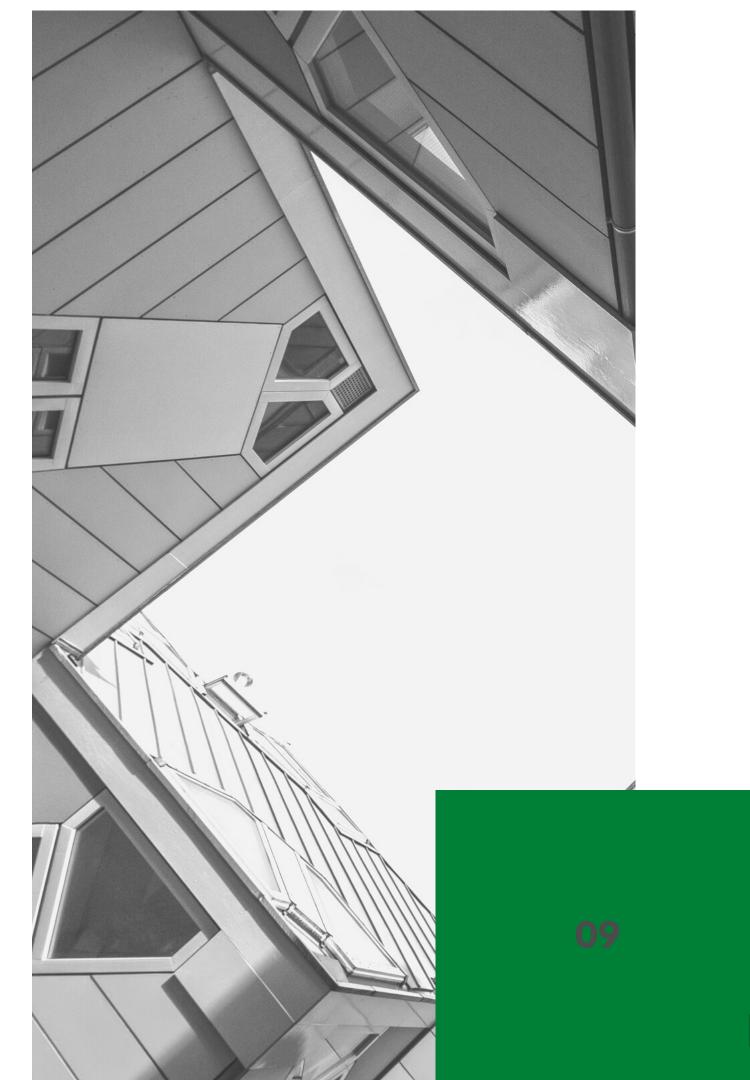

TIRZ #2 Opportunities to spur development

Development Challenges

Creation of TIRZ 2 provides great tool for development, but...

- Multiple landowners/tracts leads to piecemeal development
- Lack of deep outfall channel/regional detention results in many small, inefficient and un-amenitized detention ponds
- Uncertain reimbursement framework / financing plan challenges development funding
- The "clock is ticking" on TIRZ 2– already 6 years into a 30-year TIRZ
