Jessica Russell, Executive Director of Bay City Community Development, presented a proposal for the Bay City Community Development to take over the Texas Theater and office building development with a developer. Property will need to change hands and goal to revitalize and get back on tax roll. Ms. Russell added that the City is not putting in money. Councilwoman Brown asked if the City would be asked to participate in Tax Incentive after development and Ms. Russell answered no. Mayor Pro Tem Folse stated that he did not see anything in the immediate future to do anything with the building so he didn't see why not. Anne Marie Odefey, City Attorney, stated that there are two ways to divest ourselves; appraise and buy at market value or list it with a realtor for 30 days. Ms. Russell gave another option of turning over the property to BCCDC but Ms. Odefey stated that she does not see that in the statute. Councilman Westmoreland asked if anybody will have the opportunity to give a proposal and Ms. Russell stated yes through an RFP and written agreement. Councilwoman Sitz stated that she loves the public/private partnership.

17. Report ~ Discuss TCEQ Order received regarding arsenic.

Shawna Burkhart, City Manager, stated on April 12th the TCEQ Order passed and we have 3 years to resolve. Garver Engineering was directed to do the well sighting.

18. Budget ~ Discuss, consider, and/or approve funding towards repairs of streets located at 4th and LeTulle, Tepeyac Avenue, and Tepeyac side roads.

Shawna Burkhart, City Manager, stated that there is \$250,000 that was set aside and is available to fund repairs to streets located at 4th and LeTulle, Tepeyac Avenue, and Tepeyac side streets in San Jose addition. Crews will learn chip sealing from Matagorda Concrete who will be chip setting small section on 4th. City has all the equipment to do chip sealing and then crew will go to San Jose addition to chip seal in house. Estimate cost of \$50,000 which will leave \$200,000 to consider paying up to 30% engineering services for Nile Valley Phase #2. Only 2 more years for IIJA funds and we need to tap into that source.

Motion made by Councilwoman Sitz to approve the funding, Seconded by Mayor Pro Tem Folse. Voting Yea: Mayor Nelson, Councilwoman Brown, Mayor Pro Tem Folse, Councilwoman Sitz, Councilman Westmoreland. Motion carried.

19. Discuss ordinance changes in relation to Drainage District #1.

Shawna Burkhart, City Manager, currently the city is working with Anne Marie and the Drainage District to get Maddox plans approved. Mayor Pro Tem Folse stated that the drainage ordinance is redundant since dictated by State and if not dictated by State why are we tying ourselves to it. Anne Marie Odefey, City Attorney, replied that Chapter 98 developer obligated to get approval from district. Ms. Odefey also added that Chapter 46-21 of the Flood prevention ordinance says the city has a program in connection with the drainage district. Mayor Pro Tem Folse stated that he doesn't see the need to codify in our ordinance and would like removed or modified. Ms.Odefey replied that we can certainly do that and the city will go ahead and approve our plats, adding that the city be well advise to be very cognizant on what they are going to implement on what they are going to be their rules. Ms. Odefey recommended to get a local engineer who is familiar with the area to review. Shawna Burkhart directed to bring an amended ordinance back to council.

Unique Vehicles

Unique vehicles include off-highway vehicles, Golf Carts, and Neighborhood Electric Vehicles (NEVs). Off-highway vehicles include All-Terrain Vehicles (ATVs), Recreational Off-Highway Vehicles (ROVs), Utility Vehicles (UTVs), and Sand Rails. The unique vehicles in each tab below have different types of operation. Click on each tab to find more information about these vehicles and the different types of operation.

Off-Highway Vehicles

Golf Carts

Neighborhood Electric Vehicles (NEV)

A Golf Cart is a motor vehicle designed by the manufacturer primarily for use on a golf course. TxDMV does not title and register Golf Carts, but Golf Carts are eligible to receive a Golf Cart license plate. You may obtain a Golf Cart license plate from your county tax assessor-collector's office. The county will require a Form 130-U Application for Texas Title and/or Registration.

Golf Carts with a Golf Cart license plate may be operated on roads in the following situations:

- In a master planned community with a uniform set of restrictive covenants and a county or municipality approved plat
- On a public or private beach that is open to vehicular traffic
- On a highway with a posted speed limit of 35 mph, during the daytime and not more than two miles from the location where it is usually parked for transportation to and from a golf course
- To cross intersections, including an intersection with a highway that has a posted speed limit of more than 35 mph.

Golf Carts must have the following minimum equipment:

- Headlamps
- Tail lamps
- Reflectors
- Parking brake
- Mirrors

Additionally, cities or certain counties may authorize operation of Golf Carts on roads within the boundaries of the city or within unincorporated areas of certain counties. The Golf Cart must display a Golf Cart license plate when operated on roads authorized by the city or county. Operation may be authorized only on roads with a speed limit of 35 mph or less.

If operated on the roads at a speed of 25 mph or less, a Golf Cart is required to display a slow-moving vehicle emblem.

A person is not required to register an NEV operated in compliance with Transportation Code, Sec. 551.304.

12.3 Golf Cart

Transportation Code, Sec. 551.401. Definitions.

In this subchapter, "golf cart" means a motor vehicle designed by the manufacturer primarily for use on a golf course.

Transportation Code, Sec. 551.402. Registration Not Authorized; License Plates.

- (a) The Texas Department of Motor Vehicles may not register a golf cart for operation on a highway regardless of whether any alteration has been made to the golf cart.
- (b) A person may operate a golf cart on a highway in a manner authorized by this subchapter only if the vehicle displays a license plate issued under this section.
- (c) The Texas Department of Motor Vehicles:
 - (1) shall by rule establish a procedure to issue license plates for golf carts; and
 - (2) may charge a fee not to exceed \$10 for the cost of the license plate, to be deposited to the credit of the Texas Department of Motor Vehicles fund.
- (d) A golf cart license plate does not expire. A person who becomes the owner of a golf cart for which the previous owner obtained a license plate may not use the previous owner's license plate.

Transportation Code, Sec. 551.403. Operation Authorized in Certain Areas.

- (a) An operator may operate a golf cart:
 - (1) in a master planned community:
 - (A) that is a residential subdivision as defined by Section 209.002(9), Property Code, or has in place a uniform set of restrictive covenants; and
 - (B) for which a county or municipality has approved one or more plats;
 - (2) on a public or private beach that is open to vehicular traffic; or
 - (3) on a highway for which the posted speed limit is not more than 35 miles per hour, if the golf cart is operated:
 - (A) during the daytime; and
 - (B) not more than five miles from the location where the golf cart is usually parked and for transportation to or from a golf course.
- (b) Notwithstanding Section 551.402(b), a person may operate a golf cart in a master planned community described by Subsection (a) without a golf cart license plate on a highway for which the posted speed limit is not more than 35 miles per hour, including through an intersection of a highway for which the posted speed limit is more than 35 miles per hour.

Transportation Code, Sec. 551.4031. Prohibition of Operation on Highway by Municipality, County, or Department.

- (a) A county or municipality may prohibit the operation of a golf cart on a highway under Section 551.403 if the governing body of the county or municipality determines that the prohibition is necessary in the interest of safety.
- (b) The Texas Department of Transportation may prohibit the operation of a golf cart on a highway under Section 551.403 if the department determines that the prohibition is necessary in the interest of safety.

Transportation Code, Sec. 551.404. Operation on Highway Authorized by Municipality or Certain Counties.

- (a) In addition to the operation authorized by Section 551.403, the governing body of a municipality may allow an operator to operate a golf cart on all or part of a highway that:
 - (1) is in the corporate boundaries of the municipality; and
 - (2) has a posted speed limit of not more than 35 miles per hour.
- (b) In addition to the operation authorized by Section 551.403, the commissioners court of a county described by Subsection (c) may allow an operator to operate a golf cart on all or part of a highway that:
 - (1) is located in the unincorporated area of the county; and
 - (2) has a speed limit of not more than 35 miles per hour.
- (c) Subsection (b) applies only to a county that:
 - (1) borders or contains a portion of the Red River; or
 - (2) borders the Gulf of Mexico and has a population of less than 500,000.

Transportation Code, Sec. 551.4041. Equipment.

A golf cart operated under Section 551.404 must have the following equipment:

- (1) headlamps;
- (2) taillamps;
- (3) reflectors;
- (4) parking brake; and
- (5) mirrors.

Transportation Code, Sec. 551.405. Crossing Intersections.

A golf cart may cross a highway at an intersection, including an intersection with a highway that has a posted speed limit of more than 35 miles per hour.

Transportation Code, Sec. 551.403 allows golf carts to be operated:

- in a master planned community with a uniform set of restrictive covenants and a county or municipality-approved plat;
- on a public or private beach that is open to vehicular traffic; or

• on a road with a posted speed limit not more than 35 mph if operated during the daytime and the golf cart is driven not more than five miles from the location where it is usually parked for transportation to and from a golf course.

A golf cart may be operated in a master planned community without a Golf Cart license plate for which the posted speed limit is not more than 35 miles per hour, including through an intersection of a highway for which the posted speed limit is more than 35 miles per hour.

Transportation Code, Sec. 551.404, allows a city or certain county to authorize operation of golf carts on certain highways within the city's or county's boundaries. A city may authorize operation when the highway is within the boundaries of the city and the posted speed limit is 35 mph or less. Certain counties may authorize operation on county highways that are located in an unincorporated area of the county and the posted speed limit is 35 mph or less. The golf cart must be equipped with head lamps, tail lamps, reflectors, a parking brake, and mirrors. The counties that may authorize operation in an unincorporated area of the county authorize operation in an unincorporated area of the county must:

- border or contain a portion of the Red River; or
- border the Gulf of Mexico with a population less than 500,000.

Golf carts operated on highways where operation is authorized must display a Golf Cart license plate.

There is a one-time license plate fee of \$10, and there will be no expiration date for the license plate and no license plate sticker issued. The Golf Cart license plate is not proof of registration for operation on a public highway. Effective September 1, 2009, the TxDMV stopped titling and registering golf carts.

Note: Issuance of Golf Cart license plates is done through the RTS Title Application event by selecting Non-Titled.

12.4 Package Delivery Vehicles

Transportation Code, Sec. 551.452. License Plates for Package Delivery Vehicles.

- (a) The Texas Department of Motor Vehicles may issue distinguishing license plates for a vehicle operated by a motor carrier for the purpose of picking up and delivering mail, parcels, and packages if the vehicle:
 - (1) is a golf cart, a neighborhood electric vehicle, or an off-highway vehicle; and
 - (2) is equipped with headlamps, taillamps, reflectors, a parking brake, and mirrors, in addition to any other equipment required by law.
- (b) The Texas Department of Motor Vehicles by rule shall establish a procedure to issue the license plates to be used only for operation in accordance with this subchapter.
- (c) The license plates must include the words "Package Delivery."
- (d) The Texas Department of Motor Vehicles may charge a license plate fee not to exceed \$25 annually to be deposited to the credit of the Texas Department of Motor Vehicles fund.

Transportation Code, Sec. 551.453. Limited Operation.

- (a) A motor carrier may operate, for the purpose of picking up or delivering mail, parcels, or packages, a vehicle bearing license plates issued under Section 551.452 on a public highway that is not an interstate or a limited-access or controlled-access highway and that has a speed limit of not more than 35 miles per hour.
- (b) The Department of Motor Vehicles may not require the registration of a vehicle operated under Subsection (a) unless the registration is required by other law.

Golf carts, NEVs, and off-highway vehicles (ATVs, ROVs, UTVs and sand rails) operated by a motor carrier for the purpose of picking up or delivering mail, parcels, and packages are eligible for Package Delivery license plates.

The license plate fee is \$25 annually, and NEVs pay registration fees in addition to the license plate fee.

Operation of the vehicle is limited to a public roadway with a speed limit of 35 miles or less, unless crossing on or through a road or street.

For operation in a subdivision or condominium, the Package Delivery vehicle must comply with any applicable rules adopted by the property owner's association that manages the subdivision or condominium.

For operation on all or part of a public highway allowed by a municipality or county, the Package Delivery vehicle must operate in the corporate boundaries of the municipality or unincorporated areas of the county with a speed limit 35 miles or less.

Initial issuance of the license plates must be purchased through the county tax assessor-collector's office. Renewal may take place at the county, online, or through a subcontractor.

12.5 Pocket Bike or Minimotorbike

Transportation Code, Sec. 551.353. Application of Subchapter to Pocket Bike or Minimotorbike.

This subchapter may not be construed to authorize the operation of a pocket bike or minimotorbike on any:

(1) highway, road, or street;

(2) path set aside for the exclusive operation of bicycles; or

(3) sidewalk.

12.6 Motor Assisted Scooter and Minimotorbike

Transportation Code, Sec. 551.351. Definitions.

In this subchapter:

- (1) "Motor-assisted scooter":
 - (A) means a self-propelled device with:
 - (i) at least two wheels in contact with the ground during operation;
 - *(ii) a braking system capable of stopping the device under typical operating conditions;*

ARTICLE IV. GOLF CARTS

Sec. 17-51. Definitions.

The following words, terms and phrases when used in this article, shall have the meanings ascribed to them in this article except where the context clearly indicates a different meaning:

Driver means the person driving and having physical control over the motorized cart.

Motorized cart means those electric and gasoline powered carts, commonly referred to as golf carts, but which must have a minimum of four (4) wheels and which have an attainable top speed not greater than twenty-five (25) miles per hour on a paved level surface and which is manufactured in compliance with those federal motor vehicle safety standards for low-speed vehicles. Specifically excluded from this definition are those motorized conveyances commonly referred to as ATVs, four-wheelers, mules, and gators.

Owner means the person holding title to the motorized cart.

Parking area means those areas accessible to the public by motor vehicular traffic and which are designated for temporary parking of motor vehicles, usually in places referred to as parking lots.

Street means the public roadways of the City of Nassau Bay by whatever name (e.g., road, alley, avenue, highway, route, boulevard, etc.) that:

- a) Has a posted speed limit of thirty-five (35) miles per hour or less; or
- b) Provides for no more than two (2) lanes of vehicular traffic per direction; or
- c) Is not designated as part of either the state of federal highway system.

(Ord. No. 2009-656, § 1, 11-9-09)

Sec. 17-52. Electric and gasoline motorized cart required equipment.

Every motorized cart must be equipped as mandated by the Texas Transportation Code, H.B. No. 2553 Section 551.404 Subsection (a) and/or required by the City of Nassau Bay the following:

- (1) Operational headlamps;
- (2) Operational tail lamps;
- (3) Side reflectors;
- (4) Operational parking brake; and
- (5) Rearview mirror(s).

(Ord. No. 2009-656, § 2, 11-9-09)

Sec. 17-53. Gasoline carts.

Every motorized cart powered by gasoline shall at all times be equipped with an exhaust system in good working order and in constant operation and meeting the following specifications:

- (1) The exhaust system shall include the piping leading from the flange of the exhaust manifold to and including the muffler and exhaust pipes or including any and all parts specified by the manufacturer.
- (2) The exhaust system and its elements shall be securely fastened with brackets or hangers, which are designed for the particular purpose of fastening motorized cart exhaust systems.
- (3) The engine and powered mechanism of every motorized cart shall be so equipped, adjusted and tuned so that the exhaust is the amount of a motorized cart in good working order.
- (4) It shall be unlawful for the owner of any motorized cart to operate or permit the operation of such cart on which any device controlling or abating atmospheric emissions which is placed on a cart by the manufacturer is rendered unserviceable by removal, alteration or which interferes with its operation.

(Ord. No. 2009-656, § 3, 11-9-09)

Sec. 17-54. Operation regulations.

- (a) All drivers of motorized carts shall hold a valid driver's license and shall abide by all traffic regulations applicable to vehicular traffic when using the authorized streets and parking areas of the city.
- (b) Motorized carts shall not be operated on sidewalks at any time.
- (c) All motorized carts are entitled to a full use of a lane on the authorized streets and parking areas of the city and no motor vehicle shall be driven in such a manner as to deprive any motorized cart of the full use of a lane.
- (d) The driver of a motorized cart shall not overtake and pass in the same lane occupied by the vehicle being overtaken.
- (e) No driver shall operate a motorized cart between lanes of traffic or between adjacent lines of rows of vehicles.
- (f) The driver of a motorized cart with a current and valid driver's license operating the cart on a street (as defined herein) may cross a multi-lane or a county or state route only at a signalized intersection.

(Ord. No. 2009-656, § 4, 11-9-09; Ord. No. O2013-714, 8-12-13)

Sec. 17-55. Liability.

Nothing in this article shall be construed as an assumption of liability by the City of Nassau Bay for any injuries to persons, pets or property which may result from the operation of a motorized cart by an authorized driver.

Owners are fully liable and accountable for the actions of any individual that they provide permission to operate and drive said motorized cart, both on personal and/or city and public properties. This described liability responsibility especially applies to personal injuries or property damage resulting from motorized cart drivers who are minors under the age of twenty-one (21) with or without a current and valid Texas drivers license.

Sec. 17-56. Penalties.

Any person who violates the terms of this article shall be penalized as follows:

The maximum penalty allowed by law for such a misdemeanor and in addition to traffic violations the driver of the motorized cart may be subject to pursuant to Texas Law, the owner of the motorized cart shall be subject to the following civil penalties:

- (1) For the first offense, a fine of not less then twenty-five dollars (\$25.00);
- (2) For the second offense, a fine of not less than fifty dollars (\$50.00).

GOLF CART REGULATIONS

As of April 2021, there are new updates to golf cart laws and regulations in the City of Nassau Bay.

Highlights: Golf carts need to have a special golf cart license plate to drive on public roadways Also, a driver's license is also REQUIRED to operate a golf cart.

CHANGES

to golf cart operation requirements:

GOLF CARTS OPERATING ON PUBLIC ROADWAYS MUST DISPLAY A SPECIAL LICENSE.

The golf cart license plate does not change where and when golf carts are allowed to operate on public roads.

ITEM #7.

Golf carts must have a minimum of four wheels and operate no faster than 25 miles per hour. Motorized vehicles commonly referred to as ATVs, four-wheelers, mules, and gators are specifically prohibited from use on Nassau Bay roadways and parks.

Golf carts are not allowed to be operated on state highways, which would include NASA Rd 1/NASA Parkway. Golf carts are not allowed to be driven on sidewalks or in city parks, except for park roads and parking areas. No carts are to be driven or parked on the grass areas of the city parks. Golf carts cannot overtake another vehicle in the same lane of traffic and cannot pass between lanes of traffic or adjacent lines of rows of vehicles.

Slow-moving emblems are still required on golf carts within the City. Each golf cart must have the following working equipment, operational headlights and taillights, side reflectors, parking brake, and rear-view mirrors.

In general, golf carts in the City are regulated by Chapter 17, Article IV - GOLF CARTS of the City's Code of Ordinances. You can view this section of the Code by clicking here: Chapter 17, Article IV - Golf Carts (link)

Golf Cart Information

The City of Kemah is a fantastic area to enjoy a golf cart ride with friends and family. It's no secret that residents and visitors use this method of transportation to explore our city and be a part of our year round events and activities, including parades.

Below you will find a list of things you should be aware of concerning the safety, rules, and regulations surrounding the use of your golf cart:

- A golf cart is a motor vehicle designed by the manufacturer primarily for use on a golf course.
- The TxDMV does not title and register golf carts, but they must display a license plate when operated on roads authorized by the city or county. A license plate is required if you travel outside of the city or cross a state highway, such as FM 518.
- To request and obtain a golf cart license plate, take the following to your county tax assessor-collector's office:
 - 1. Form 130-U (Found <u>here</u>)
 - 2. Evidence of ownership

- 3. Proof of insurance
- 4. Driver's License

• Golf carts may be operated only by persons with a valid driver's license.

Golf Carts must have the following minimum equipment:

- Headlights
- Tail lights
- Reflectors
- Mirrors
- Parking brake
- Slow-moving vehicle emblem (If operated on the roads at a speed of 25 mph or less)

ORDINANCE NO. 2022-O-14

AN ORDINANCE REGULATING THE USE OF GOLF CARTS, NEIGHBORHOOD ELECTRIC VEHICLES, AND OTHER TYPES OF RECREATIONAL OFF-HIGHWAY VEHICLES; PROVIDING FOR CODIFICATION; FIXING A PENALTY FOR FAILURE TO COMPLY WITH SUCH ORDINANCE; REPEALING ANY CONFLICTING ORDINANCES; AND SETTING AN EFFECTIVE DATE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PALACIOS, TEXAS.

<u>SECTION 1.</u> Chapter 12 of the City of Palacios Code of Ordinances is hereby amended to add new Article 12.11, Golf Carts, Neighborhood Electric Vehicles and other Types of Recreational Off-Highway Vehicles, as follows:

ARTICLE 12.11 GOLF CARTS, NEIGHBORHOOD ELECTRIC VEHICLES AND OTHER TYPES OF RECREATIONAL OFF-HIGHWAY VEHICLES

Sec. 12.11.001. Definitions.

These terms shall have the following meanings:

All-terrain vehicle means a motor vehicle that is:

- 1. Equipped with a seat or seats for the use of:
 - a. The rider; and
 - b. A passenger(s), if the motor vehicle is designed by the manufacturer to transport a passenger(s);
- 2. Designed to propel itself with three or more tires in contact with the ground;
- 3. Designed by the manufacturer for off-highway use;
- 4. Not designed by the manufacturer primarily for farming or lawn care; and
- 5. Not more than 50 inches wide.

City means the City of Palacios, Texas.

Daytime means the period beginning one-half hour before sunrise and ending one-half hour after sunset.

Golf cart shall have the meaning assigned by Texas Transportation Code § 502.001, as amended, which currently defines it as a motor vehicle designed by the manufacturer primarily for transporting persons on a golf course. It must have a minimum of four wheels and have an attainable top speed not greater than 25 miles per hour on a paved level surface and be manufactured primarily for transporting persons on a golf course and in compliance with those federal motor vehicle safety standards for low-speed vehicles. The term "Golf cart" shall not include those motorized conveyances commonly referred to as All-terrain vehicles ("ATVs"), offroad vehicles (also known as "ROVs"), four-wheelers, mules, gators, and designaltered Golf carts which have been altered to allow them to travel at a speed greater than 25 miles per hour.

Neighborhood electric vehicle (NEV) (includes low speed vehicles "LSV") means a vehicle that can attain a maximum speed of 35 miles per hour on a paved

level surface and otherwise complies with the definition of a "Neighborhood Electric Vehicle" as defined by Tex. Transp. Code §551.301 or with Federal Motor Vehicle Safety Standard No. 500; Low-Speed Vehicles (Effective Sept. 5, 2017). This standard specifies requirements for low-speed vehicles. A low-speed vehicle is a gasoline or electric powered four-wheeled motor vehicle, other than a truck, whose attainable speed is more than 32 km/h (20 mph) and not more than 40 km/h (25 mph). The standard requires ten specific items of safety equipment. [Not listed. See Texas Transportation Code § 551.301] ** Has a normal maximum speed of 20—25 mph (LSV) or 20—35 mph (NEV). The term "Neighborhood electric vehicle" shall not include those motorized conveyances commonly referred to as All-terrain vehicles ("ATVs"), off-road vehicles (also known as "ROVs"), four-wheelers, mules, or gators.

Nighttime means the period beginning one-half hour after sunset and ending one-half hour before sunrise.

Operate shall mean driving.

Operator means any person driving and having physical control over the motor vehicle.

Park or *Parking* means the standing or stopping of a vehicle, whether occupied or not, other than temporarily for the purpose of and while actually engaged in loading or unloading merchandise or passengers.

Parking area means those areas accessible to the public by motor vehicular traffic and which are designated for temporary Parking of motor vehicles, usually in places referred to as Parking lots.

Recreational off-highway vehicle means a motor vehicle that is:

- 1. Equipped with a seat or seats for the use of:
 - a. The rider; and
 - b. A passenger or passengers, if the vehicle is designed by the manufacturer to transport a passenger or passengers;
- 2. Designed to propel itself with four or more tires in contact with the ground;
- 3. Designed by the manufacturer for off-highway use by the Operator only; and
- 4. Not designed by the manufacturer primarily for farming or lawn care.

Street means a public roadway in the City of Palacios, Texas by whatever name (e.g., road, alley, avenue, highway, route, boulevard, etc.) that is open to vehicular traffic.

Sec. 12.11.002. Limited operation.

- A. Golf carts and NEV's are permitted to be Operated on:
 - 1. Streets where the posted speed limit is 35 miles per hour or less,
 - 2. A Parking area as defined by this article.
- B. A Golf cart/NEV may be driven across intersections where the cross Street has a posted speed limit of more than 35 miles per hour.
- C. Nighttime driving of a Golf cart/NEV is prohibited. A Golf cart/NEV may only be driven during the Daytime.
- D. A NEV/ Golf Cart may drive across intersections where the cross-Street has a posted speed limit of more than 35 miles per hour, even if the cross-Street is otherwise a prohibited Street under this article.

E. Notwithstanding anything in this section 12.11.002 to the contrary, Golf Carts and Neighborhood Electric Vehicles may be operated on public streets for activities related to parades permitted under this chapter and events organized or sponsored by the City of Palacios.

F. The operation of a Golf Cart/NEV shall be prohibited on any sidewalk, seawall, or beach.

Sec. 12.11.003. Required equipment—Golf cart/NEV's.

- A. A Golf Cart/NEV Operated under this article must be equipped, at a minimum, with the following equipment as mandated by the Texas Transportation Code § 551.404(b), as amended, and/or required by the City to Operate on permitted locations:
 - 1. Operational headlamps;
 - 2. Operational tail lamps;
 - 3. Side reflectors;
 - 4. Operational Parking brake; and
 - 5. Rearview mirror(s).
 - 6. Turn signals;
 - 7. Horn;
 - 8. Brake lights;
 - 9. Seat belts;
 - 10. A safety-orange flag on a six-foot fiberglass whip pole; and
 - 11. Windshield
- B. A Golf cart that is Operated at a speed of not more than 25 miles per hour shall display a "slow-moving-vehicle emblem" as defined by Texas Transportation Code § 547.703.
- C. Equipment, and its installation and maintenance, must meet standards provided by the Texas Transportation Code, as amended.
- D. Golf Carts/NEV's must be inspected by the Palacios Police Department not less than once per year for compliance with this section. The fee for inspection is \$10.00, to be paid by the owner prior to the inspection, such fee shall not be refunded if the golf cart fails the inspection. Upon verification of compliance with this section, the Palacios Police Department shall affix a decal to the vehicle, indicating the date of inspection, the inspector's name and signature, and a statement that the vehicle complies with this section.

Sec. 12.11.005. Operator regulations.

- A. All Operators of Golf carts or NEVs shall:
 - 1. Be licensed to Operate a motor vehicle as provided by Texas Transportation Code § 521.021, as amended, and carry a valid Driver's license as provided by Texas Transportation Code § 521.025, and all state law Driver's license permissions and restrictions shall apply to the operation of a Golf cart or NEV;

- 2. Abide by all state and local traffic regulations applicable to vehicular traffic;
- 3. Not Operate or park on a sidewalk or hike and bike trails at any time;
- 4. Not use the vehicle to pull any object or person at any time;
- 5. Not exceed the seating capacity of the vehicle as designed by the manufacturer;
- 6. Remain seated at all times while the vehicle is in motion, and ensure the same for passengers. Passengers can be issued a citation for not remaining seated while vehicle is moving;
- 7. Maintain financial responsibility as defined in Texas Transportation Code § 601.051; and
- 8. Not intentionally or knowingly allow an unlicensed Operator to Operate the vehicle.
- 9. Use headlights at all times the Golf Cart or Neighborhood Electric Vehicle is in operation.

Sec. 12.11.006. All-terrain vehicles, Recreational off-highway vehicles.

It shall be unlawful for a person to Operate an ATV or ROV on a Public Street or location except as provided by state law and this section. A person may only drive across a public Street or highway that is not an interstate or limited-access highway, if done so in accordance with state law. (See Texas Transportation Code § 663.037, and as amended.)

Sec. 12.11.009. Penalties.

Only warning citations may be issued for the first 30 days following the effective date of this article so that an educational effort by the City may be conducted to inform the public about the importance and requirements of this article. In addition to traffic violations for which the owner or driver of the Golf cart or NV may be subject to pursuant to state law, any person who violates this article shall be guilty of a misdemeanor punishable by a fine of \$200.00;

Each day's violations shall constitute a separate and distinct offense. Any prior conviction under this article will count towards a second and third charge regardless of when it occurred.

<u>SECTION 2.</u> It is the intention of the City Council that this ordinance shall become a part of the Code of the City of Palacios, Texas, and it may be renumbered and codified therein accordingly, in the manner approved by the City Attorney.

<u>SECTION 3.</u> Failure to comply with any provision of this ordinance shall be punished by a fine not to exceed Two Hundred and No/100 (\$200.00) per day that said person is in violation of this Ordinance.

<u>SECTION 4.</u> If any part of this ordinance is, or should be held invalid for any reason, then that fact shall not invalidate the entire ordinance, but the balance thereof shall remain in full force and effect.

<u>SECTION 5.</u> All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 6. The City Secretary shall publish this Ordinance as required by City Charter.

SECTION 7. This ordinance shall become effective upon the final passage date shown below.


