#### **SURPLUS PROPERTY**

#### **RESOLUTION NO. DRAFT**

A RESOLUTION OF THE CITY OF BAY CITY, TEXAS, DECLARING CERTAIN REAL PROPERTY OWNED BY THE BAY CITY TO BE SURPLUS AND AUTHORIZING THE MAYOR TO INSTITUTE PROCEEDINGS IN ACCORDANCE WITH TEXAS LOCAL GOVERNMENT CODE SECTION

**WHEREAS**, the City has ownership of certain lots parcels or tracts of land that is serving no purpose currently or for the foreseeable future; and

**WHEREAS**, Council desires that those lots parcels or tracts of land be put to a productive purpose; and

**WHEREAS**, Section 272.001 of the Texas Local Government Code prescribes the method by which municipalities may sell or exchange land owned by the municipality; and

**WHEREAS,** Council adopts this Resolution to declare the land identified herein as surplus and avail itself to authority prescribed in Section 272.001 for the conveyance of such surplus land so that it can be put to a productive use.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BAY CITY, TEXAS, THAT:

#### Section one.

**Land declared surplus**: City Council hereby declares as surplus the lots parcels and tracts of land that follow:

#### Section two.

Commencement of sale or exchange procedures authorized. The Mayor is hereby authorized to initiate procedures to facilitate the sale or exchange of the properties declared in this resolution to be surplus. Such sale or exchange shall comply with the requirements of Section 272.001 of the Texas Local Government Code; applicable provisions of federal and state statutes and laws; the city charter and ordinances.

#### Section three.

Closing on Sale. The Mayor is hereby authorized to execute all required instruments of conveyance and ancillary documents required to complete the close of a sale of any property declared surplus by this resolution; without further action by Council required; provided that such sale complies with all bidding requirements of Section 272.001(a) of the Texas Local Government Code. Any sale or exchange of property declared surplus by this resolution, offered for sale pursuant to Section 272.001(b), (g). (h), (i), (j), or (l) must be approved by Council before such sale may be closed.
