1. Ratify Professional Service Agreement with Maddox Developer

Shawna Burkhart, City Manager, requested a ratification of an agreement between Maddox and the City regarding development fee. Anne Marie Odefey, City Attorney, added that the fees are for permits and to replenish expenditure. Maddox has deposited \$25000.

2. Project ~ Discuss, consider, and/or approve the Hamman Road Drainage Project.

Alyssa Dibbern, Engineering Tech, presented an exhibit, left out survey so new cost is \$200100. Phase 1a to gather water from apartments surface and redirect and put in ditch and hopefully collect water in backyards off Chateaux. This is a temporary fix. Mayor Pro Tem Childers asked about amount of whole project - \$600000+. Ms. Dibbern stated that the water was not sheeting as they thought, so there is sheeting off the apartment complex at an angle and is why engineers went with phase 1a. Mr. Ryman, Chateaux Drive resident, showed pictures of Chateaux Drive, and stated that it does not matter how many culverts the city puts in but need to get the majority of water redirect to Cottowood Creek. He recommended dig ditch until it can be done correctly. Jerry Smidt, 31 year resident on Chateaux, added that when they filled ditch and put in 36in pipe is when the flooding started. Mayor Nelson stated that he wants to get with engineers and Mayor Pro Tem Childers also wants to meet with them and believe we need to move quickly at moving water.

Motion made by Mayor Pro Tem Childers to fund the Hamman Road Drainage Project, Seconded by Councilwoman Brown. Voting Yea: Mayor Nelson, Mayor Pro Tem Childers, Councilwoman Brown, Councilman Folse, Councilwoman Sitz. Motion carried.

3. Resolution ~ Discuss, consider, and/or approve a Resolution supporting "Bay City Southern Trailway" application to the Texas Department of Transportation's 2021 Transportation Alternatives Set-Aside (TA) Call for projects.

Alyssa Dibbern, Engineering Tech, presented a resolution for application to extend safe routes from Cottonwood to Moore on old railway line providing the community for pedestrian and cyclist paths. 100% grant funded.

Motion made by Councilwoman Brown to approve the Resolution, Seconded by Councilwoman Sitz.

Samantha Denbow, Library Director, presented 2020 Texas Municipal Library Directors Association (TMLDA) Achievement in Library Excellence Award, the 4th consecutive year. Ms. Denbow discussed the requirements to win the award and what they submitted. Ms. Denbow also presented a video that was viewed regarding the award.

Motion made by Councilwoman Brown to approve the minutes of May 11, 2021 Regular meeting, Seconded by Mayor Pro Tem Childers. Voting Yea: Mayor Nelson, Mayor Pro Tem Childers, Councilwoman Brown, Councilman Folse, Councilwoman Sitz. Motion carried.

PUBLIC COMMENTS

David Torrez, 1616 Cottonwood, is discouraged by City not maintaining their mowing. Mr. Torrez also spke regarding high water bills, pot holes, and what to do with excess trash.

Jerry Schmitt, Chateaux Drive, hasn't seen the mosquito fogger.

Ernestine Evans, 3407 Weinletrap Dr., spoke about her high water bill, giving a background of past amounts. She had called the City who told her she has a leak, but she did not find any leaks.

Scotty Jones, City Finance Director, addressed Council regarding the recent water bills. Ms. Jones explained that the meter collectors were down for two months and the City had to do estimate meter readings. Consumption from the February freeze where residents left water running also was a contributor. The City is giving credit plans, sewer caps for hardships, and doing a physical meter reading. So far they have done up to 161 sewer credits and bill adjustments as well. Mayor Pro Tem asked to put this discussion on the June 22nd agenda to discuss calculations of water billing.

4. Discussion ~ Hamman Road Drainage.

Matt Breazeale, PE; Jones & Carter, gave a presentation of the Hamman Road drainage showing the water sheeting and directional flows. Mayor Pro Tem Childers asked about Holly Lane and would a ditch help. Mr. Breazeale replied that the south is higher and would be going agaist grade. Mr. Breazeale also added that to put ditch along Hamman would be deep and wide 24' wide and poses a traffic safety issue. He advised to increase inlet at Chateaux and Hamman. Mr. Breazeale also proposed to capture, reroute and upsize inlets.

5. Presentation ~ Feasibility study of Public Safety Headquarters.

Stephen Lucchesi with Ziegler Cooper Architects presented Council the feasibility of the proposed location for the Public Safety Headquarters and space utilization.

Shawna Burkhart, City Manager, stated that they will bring a comparison to rebuilding versus building new.

Anne Marie Odefey, City Attorney, recommended that the four names submit a resume, put an add in the paper for more interested candidates. Deadline to receive resumes will be Friday, June 18th. Candidates may give brief introduction at next June 22nd meeting. Ms. Odefey continued that Council could select the candidate of their choice in the Executive Session and swear in the candidate afterwards.

Executive Summary of Item:

EASEMENT AND RIGHT OF WAY

BAY CITY ("Grantor"), for and in consideration of Ten & 00/100 Dollars (\$10.00), and other good and valuable consideration to Grantor in hand paid by **AEP TEXAS INC.**, a Delaware Corporation, whose address is P.O. Box 2121, Corpus Christi, Texas 78403 ("Grantee") the receipt and sufficiency of which is hereby acknowledged and confessed, has GRANTED, SOLD, and CONVEYED, and by these presents does GRANT, SELL, and CONVEY unto Grantee, its successors and assigns, a perpetual easement and right of way for electric distribution lines, consisting of poles made of wood, metal, or other materials, cross arms, static wires, guys, wire circuits, underground cables and conduits, communication circuits, metering equipment and all necessary or desirable appurtenances (including, but not limited to, transformers, meters, vaults, and service pedestals) over, under, across, and upon a portion of the following described land located in Matagorda County, Texas, to wit:

A tract of land containing 14.33 acres of land, more or less, out of the Thos. Cayce League, Matagorda County, Texas, and being a portion of Lot No. 5 of the Subdivision of the Elliot Lands, Matagorda County, Texas, being further described in Volume 99, Page 102, Deed Records of Matagorda County, Texas.

More specifically, the strip of land covered by this Easement and Right of Way shall be 15 feet in width, 7.5 feet on each side of a centerline as described by GPS waypoints and as depicted on Exhibit "A", attached hereto, made a part hereof and incorporated herein for all applicable purposes. Notwithstanding the foregoing, the actual as-built location of the electric line shall locate, define and establish the centerline of the easement. (the "Easement Area")

Together with the right of ingress and egress over, under, across and upon the Easement Area and Grantor's adjacent land for the purpose of constructing, operating, reconstructing on poles or burying and replacing underground cables and conduits (including necessary ditching and backfilling), enlarging, inspecting, patrolling, repairing, maintaining, upgrading and removing said lines, circuits, underground cables and conduits, poles, wires and appurtenances; the right to relocate along the same general direction of said lines, cables, and conduits; and the right to remove from the Easement Area all structures, obstructions, trees and parts thereof, using generally accepted vegetation management practices, (whether from the Easement Area or that could grow into the Easement Area) which may, in the reasonable judgment of Grantee, endanger or interfere with the safe and efficient operation and/or maintenance of said lines, cables, conduits or appurtenances or ingress and egress to, from or along the Easement Area.

Grantor reserves the right to use the Easement Area subject to said Easement and Right of Way in any way that will not interfere with Grantee's exercise of the rights hereby granted. However, Grantor shall not construct or permit to be constructed any house or other above ground structure on or within the Easement Area containing Grantee's improvements without the express written consent of Grantee.

TO HAVE AND TO HOLD the above described easement and rights unto the Grantee, its successors and assigns forever. Grantor binds itself, assigns, and legal representatives to warrant and forever defend all and singular the above described easement and rights unto the said Grantee, its successors and assigns, against every person whomsoever lawfully claiming or to claim the same or any part thereof.
