RECOMMEND APPROVAL TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT BETWEEN BEAUFORT COUNTY AND THE SOUTH CAROLINA DEPARTMENT OF TRANSPORTATION FOR BEAUFORT COUNTY TRANSPORTATION PROGRAM PROJECTS. ***(FISCAL IMPACT: The County shall reimburse SCDOT for costs incurred as part of SCDOT's reviews, coordination, and oversight per project throughout development.***

**SCDOT will invoice the County no more often than quarterly for these costs. Typically, the amounts are nominal and do not require approval further than the ACA for approval) - Jared Fralix, Assistant County Administrator**

RECOMMEND APPROVAL OF A RESOLUTION TO ACCEPT THE TRANSPORTATION ALTERNATIVE SET ASIDE PROGRAM FUND GRANT FROM THE US DEPARTMENT OF TRANSPORTATION'S FEDERAL HIGHWAY ADMINISTRATION (FHWA) IN THE AMOUNT OF \$1,177,868,.71 FOR THE ALLJOY ROAD SIDEWALK PROJECT ***(FISCAL IMPACT: The grant is an 80/20 match: 80% from USDOT FHWA and 20% Local Match. The grant award is for a total of \$1,177,868.71 that will be refunded from the 2018 One Cent Transportation Sales Tax account 4705-80-0000-54500 to be used for the construction of the Alljoy Road Sidewalk Pathway project. With a total project estimated cost of \$1,472,335.89, the County's match is \$294,467.18 from account number 4705-80-0000-54500)*** - Jared Fralix, Assistant County Administrator
