RECOMMEND APPROVAL OF AN ORDINANCE FOR A PROPOSED TEXT AMENDMENT TO ARTICLE 7, DIVISION 7.4, SECTION 7.4.50 (PUBLIC HEARING SCHEDULING AND NOTICE) AND SECTION 7.4.70 (PUBLIC HEARING PROCEDURES) TO CLARIFY THAT PUBLIC COMMENT IS NOT TAKEN FOR APPEALS TO THE PLANNING COMMISSION OR THE ZONING BOARD OF APPEALS

**Motion:** It was moved by Council Member Passiment, seconded by Council Member McElynn, to recommend approval of an ordinance for a proposed text amendment to Article 7, Division 7.4, Section 7.4.50 (Public Hearing Scheduling and Notice) and Section 7.4.70 (Public Hearing Procedures) to clarify that public comment is not taken for appeals to the Planning Commission or the Zoning Board of Appeals.

**Discussion:** Planning and Zoning Department Director Merchant commented that: the amendment came at the recommendation of the County Attorney. Both the PC and ZBA hear appeals and take on a quasijudicial process. When looking at an appeal, typically appealing a decision made by staff. When hear an appeal, only look at the evidence that staff used in making that determination. Ran into ambiguity in ordinance language that could be interpreted as allowing public comment when there is an appeal. The amendments are to provide more clarity - public not offering additional info that will be used in decision-making.

RECOMMEND APPROVAL OF AN ORDINANCE FOR A ZONING MAP AMENDMENT/REZONING REQUEST FOR 71.54 ACRES (R600 013 000 0008 0000 AND R600 013 000 0050 0000), LOCATED AT 1691 OKATIE HIGHWAY, FROM T2 RURAL (T2R) TO T4 NEIGHBORHOOD CENTER (T4NC) AND T3 NEIGHBORHOOD (T3N) USING A VILLAGE PLACE TYPE OVERLAY (PTO) (ARTICLE 3 DIVISION 4 SECTION 80, ARTICLE 7 DIVISION 3 SECTION 50).

Motion: It was moved by Council Member Passiment, seconded by Council Member Bartholomew, to recommend approval of an ordinance for a Zoning Map Amendment/Rezoning Request for 71.54 acres (R600 013 000 0008 0000 and R600 013 000 0050 0000) located at 1691 Okatie Highway, from T2 Rural (T2R) to T4 Neighborhood Center (T4NC) and T3 Neighborhood (T3N) using a Village Place Type Overlay (PTO) (Article 3 Division 4 Section 80, Article 7 Division 3 Section 50).

11. RECOMMEND APPROVAL OF AN ORDINANCE ADOPTING AMENDMENTS TO CH 38. ARTICLE II. TRASH AND LITTER CONTROL OF THE BEAUFORT COUNTY CODE OF ORDINANCES

**Motion:** It was moved by Council Member Cunningham, seconded by Council Member Tabernik. to recommend approval of an ordinance adopting amendments to CH 38. Article 11. Trash and Litter Control of the Beaufort County Code of Ordinances.

**Discussion:** Council Member Tabernik asked how to notify residents about the changes and the fine increase (up to 500 dollars) - how to do that when there is so much language.

ACA Atkinson stated the process for enforcement is multi-layered. First time as code enforcement employees is notify the customer about the issue and help them find a solution. First thing in code enforcement is education. Will notify before penalties. The penalties are defined by the South Carolina Code of Laws and they are updating the Chapter to match (has not been updated since 1980).

Council Member Bartholomew stated code enforcement entering the property, is there a court order to do so.

ACA Atkinson stated that falls under search and seizure laws. Typically, if we can observe it from the public way/plain view - we can go where ever the UPS guy goes. All search and seizure laws apply, and we do not violate them.
