Chairman Passiment led the Pledge of Allegiance.

FOIA

Chairman Passiment stated notification of this meeting had been published, posted and distributed in compliance with the South Carolina Freedom of Information Act.

APPROVAL OF AGENDA

ADMINISTRATOR'S REPORT

Ashley Jacobs stated that absentee voting precincts were open and the last day for in-person absentee voting is November 2, 2020. She announced that Whitney Richland had accepted the position of CFO for Beaufort County and ended her report announcing the cancelation of the Veterans Day Parade.

Senator Tom Davis stated he sent a letter about the scope of work that was prepared with comments from the community in reference to the quantitative estimate of cost, a public oversite committee, and landscape architect.

Alex Brown, 278 Committee, stated there is support of a 3rd party consultant being brought forward concerning the scope of work for 278 Corridor.

Council Member Rodman asked what the path is going forward since the estimated cost is \$120,000 and \$40,000 was approved.

Jared Fralix, Assistant County Administrator, stated HTR is on an existing contract, this will be an extension of that.

AGENDA REVIEW

Chairman Passiment stated the consent agenda had several second readings and resolutions and that Public Hearing would have to be done at third reading due to the lack of time for proper notice. He further stated the agenda also included the mask ordinance and school impact fee.

Ashley Jacobs stated the IGA from the school is not done.

Chairman Passiment stated this item will be removed from the agenda with a recommendation.
