ITEM BACKGROUND:

- In July 2020, Creech and Associates began a comprehensive space needs assessment and master plan
- The County owns 104 facilities of which the main 52 buildings were assessed
- The **2020** department staff totaled **1,389** employees.
- The Space Needs Assessment included **53 county departments** that currently reside in approximate **600,000 sf of building space**
- The projected 30-year plans based on population trend identifies a county employee growth of 60% (2,277 employees) and 100% need of additional space totaling 1,200,000 sf.
- The facility master plan provides multiple site and building options with overall improvements totaling approximately **\$300M**






Shell Point Area


