Debbie Farmer, General Manager – Wintergarden Groundwater Conservation District introduces Dr. Ron Green to Council.

Dr. Ron Green presented the Council with the Wintergarden Groundwater Conservation District Drought Contingency Plan.

22. ORGANIZATIONAL UPDATES

City Manager Azalia Garcia presented council with her monthly report.

Water Dept – Major leak repair at the intersection of Hwy 83 and Thompson St with the assistance of Uvalde Water Department and a major water main break on North 6th St. Octavio Sierra, Dexter McNiel, Ramsey Castillo and John Camarillo attended the Wintergarden Water Association in regards for proper placement of antennas on water towers.

Wastewater Dept – As of August 2023, our WWTP has brought down our e-coli reduction from over 1500 mg/L. to a 1, 3,1,5, mg/L. Received one new truck.

Gas Dept- South 5th street line replacement project is ongoing. Met with Texian Geospatial Company to plan the mapping of the gas lines to occur in November 2023.

Landfill Dept – Met with several vendors for bids for compactor and dozer. Received a 4x4 truck for the department.

Street/Parks/Rec Dept - Brush pickup in sections A, B, C were completed.

Public Safety Dept – Coordinated with county to ensure the safety of everyone who participated in Halloween. Participated in the DRH Trunk or Treat.

Administration – City Manager visited each city department and met all staff. Also, started introductions with county staff and met with Commissioner Urenda, Commissioner Carmona, and County Emergency Preparedness Coordinator. Received one new truck for administrative use.
