The Christmas Night Parade was a huge success thanks to the teamwork of city employees.

Mario Vargas provided the City with Active Shooter Course at the Civic Center on Monday, Nov 27, 2023 and scenarios at City Hall.

The new rates for the residents of Carrizo Hill are completed.

The Tax Note Series 2023 was approved, the city will be purchasing new vehicles for the Public Works Department and new equipment for the landfill.

The new supervisor's office has been painted and new tile has been installed on the floors.

Street/Park/Recreation Departments

Decorations at City Park were completed and look amazing. Materials have been ordered to begin the underlayment of potholes, potholes have been patched and the route for the Christmas Night Parade is being cleaned.

Contractors have been selected by city council for the balcony deck project at the civic center.

Water Department

Water Department Supervisor Octavio Sierra and Public Works Director John Camarillo worked together to resolve several water leak issues.

Wastewater Treatment Plant
