Committee of the Whole July 15, 2019



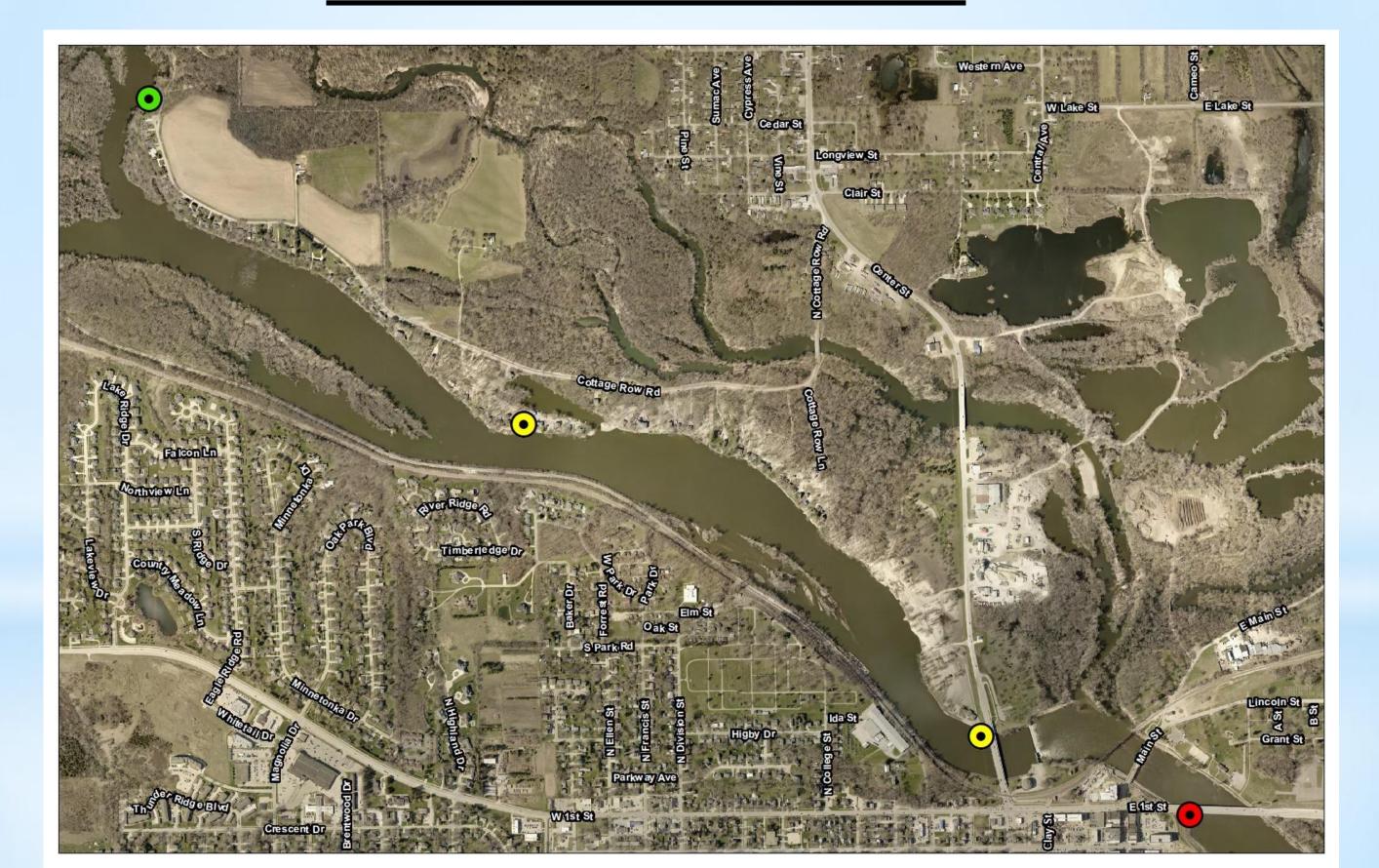
River Gauge

- Full River Gauge displays predictions & volume information (current system)
- Stage Only Gauge only provide current river elevations
 - Operated by United States Geological Survey (USGS)

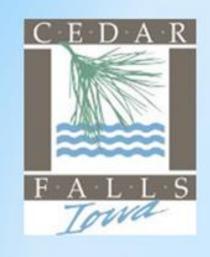




Locations Reviewed







Challenges

- Structure Sizing (height above record flood, exposure to ice, etc)
- FEMA review/approval process, 90 day minimum after submittal to Iowa Homeland Security
- Datum (elevations differences)
- Cost vs Benefit
- No additional tributary streams and inflow





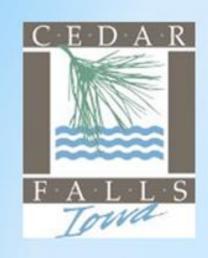


Agreement & Cost

Agreement – Installation cost \$22,000 with annual cost of \$5,500 thereafter

The agreement includes periodic inspection on equipment, data entry, yearly maintenance





Conclusion

- Datum (elevation)
- FEMA review process
- Ice Jams
- Provides minimal benefit
- Only 1 location has the potential for placement, contingent upon FEMA approval
 - Installation Cost \$22,000 (Flood Reserve)
 - Annual \$5,500 (Engineering Budget)

Snow Removal - Typical Schedule

- Plowing of priority street routes.
- Clearing sidewalks/parking lots/trails around public buildings and schools.
- Clearing of remaining trails in high pedestrian areas.
- Total time up to two full days depending on weather conditions and accumulation amounts.

Trail Snow Removal - Current Policy

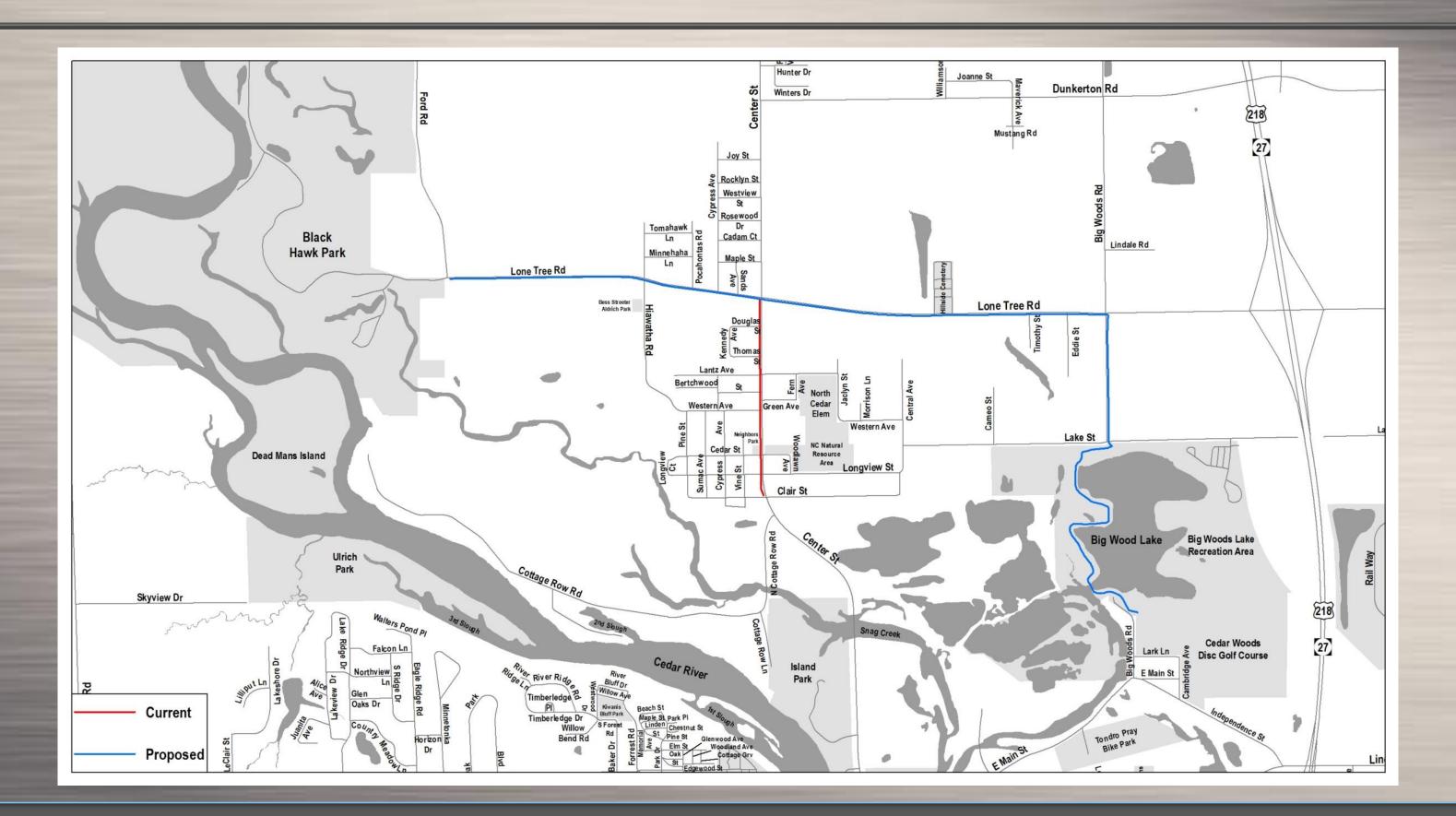
- Clear 7.3 miles mainly in front of city owned property and near schools.
- 39 man-hours to clear a typical 3 inch snowfall.
- \$30,000 annually for manpower, equipment, fuel per year for average winter snow event.

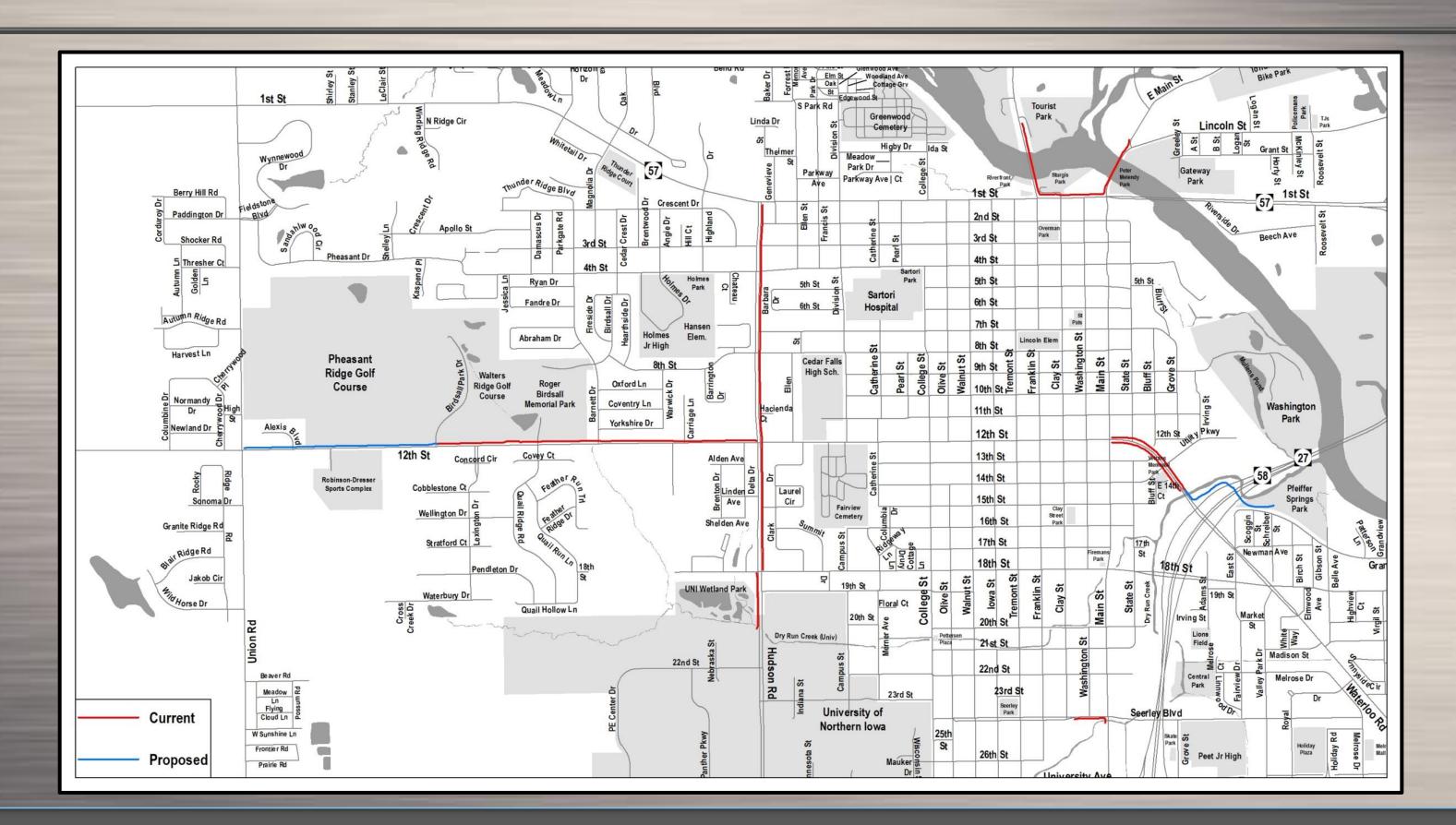
Trail Snow Removal - Additional Request

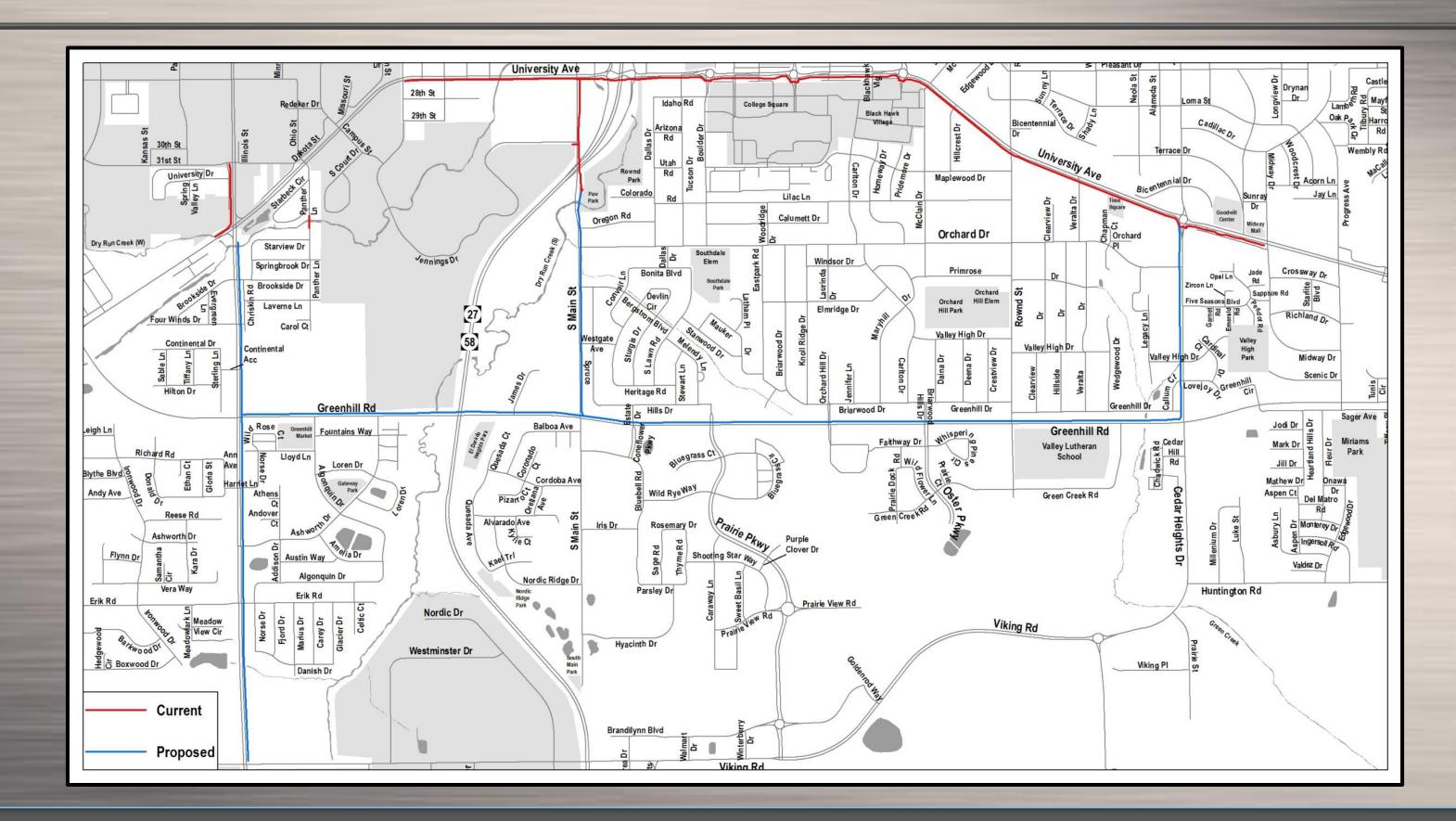
- Clear another 9.5 miles in more remote locations.
- 51 more man-hours needed to clear additional miles.
- \$38,000 annually to clear additional 9.5 miles.

Trail Snow Removal - Total

- Clear 16.8 miles of recreation trails total.
- · 80 man-hours to clear a 3 inch snow.
- \$68,000 annually for manpower, equipment, fuel for average winter snow event.
- \$80,000 -\$100,000 in additional equipment required.







Benefits

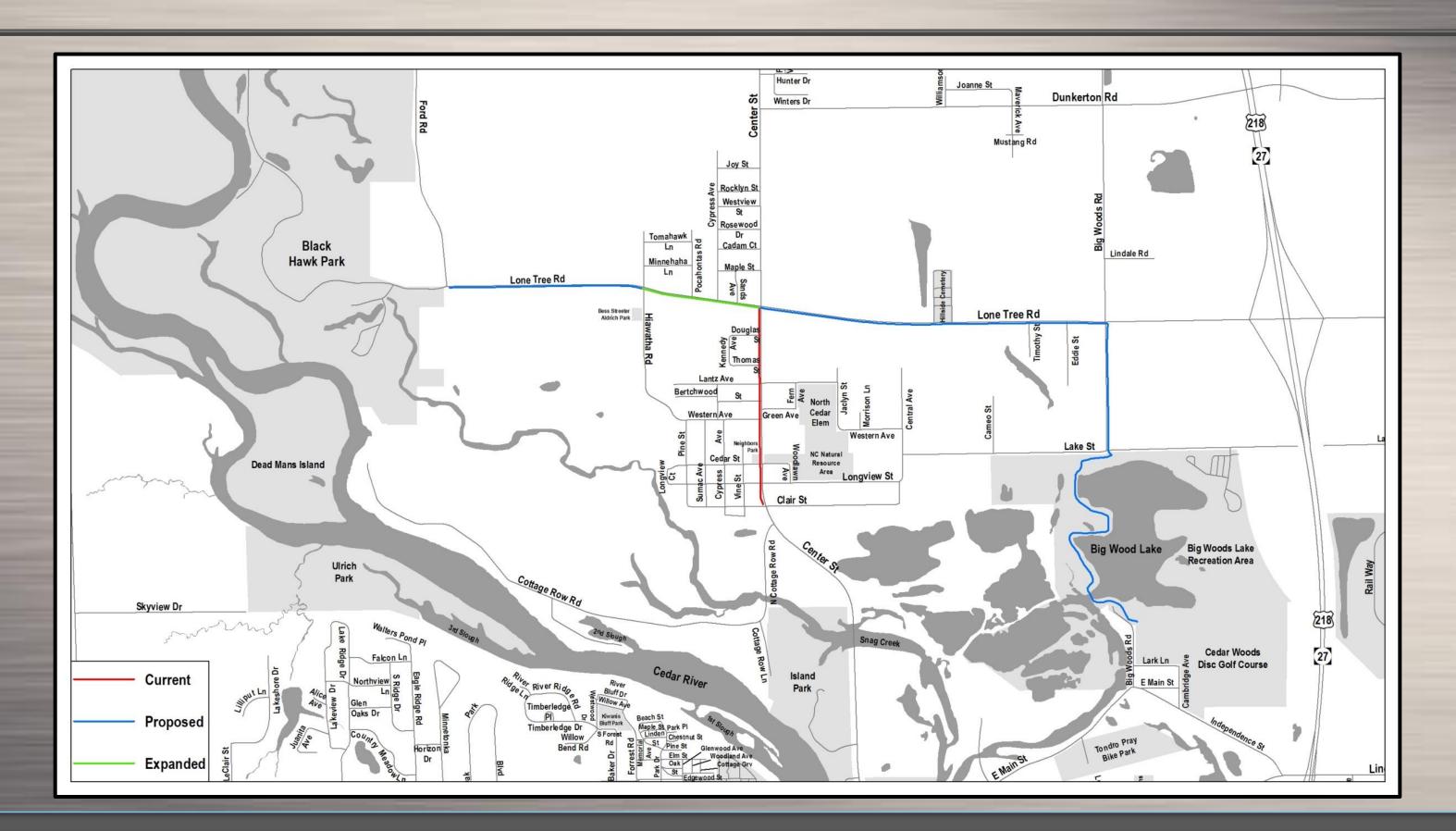
 Additional cleared trails to allow for what are typically warm weather uses (running, biking, etc.) in the winter.

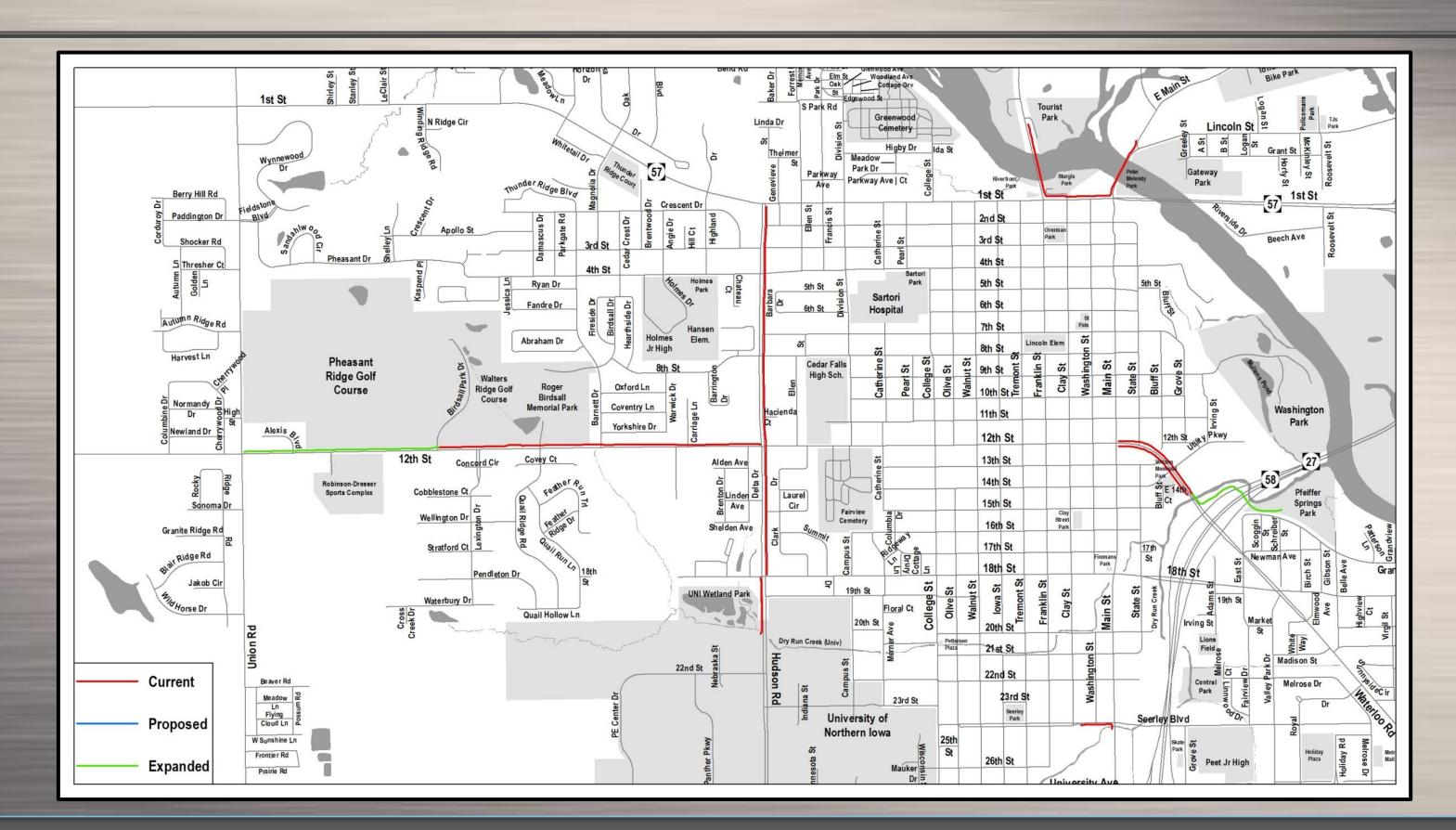
Challenges

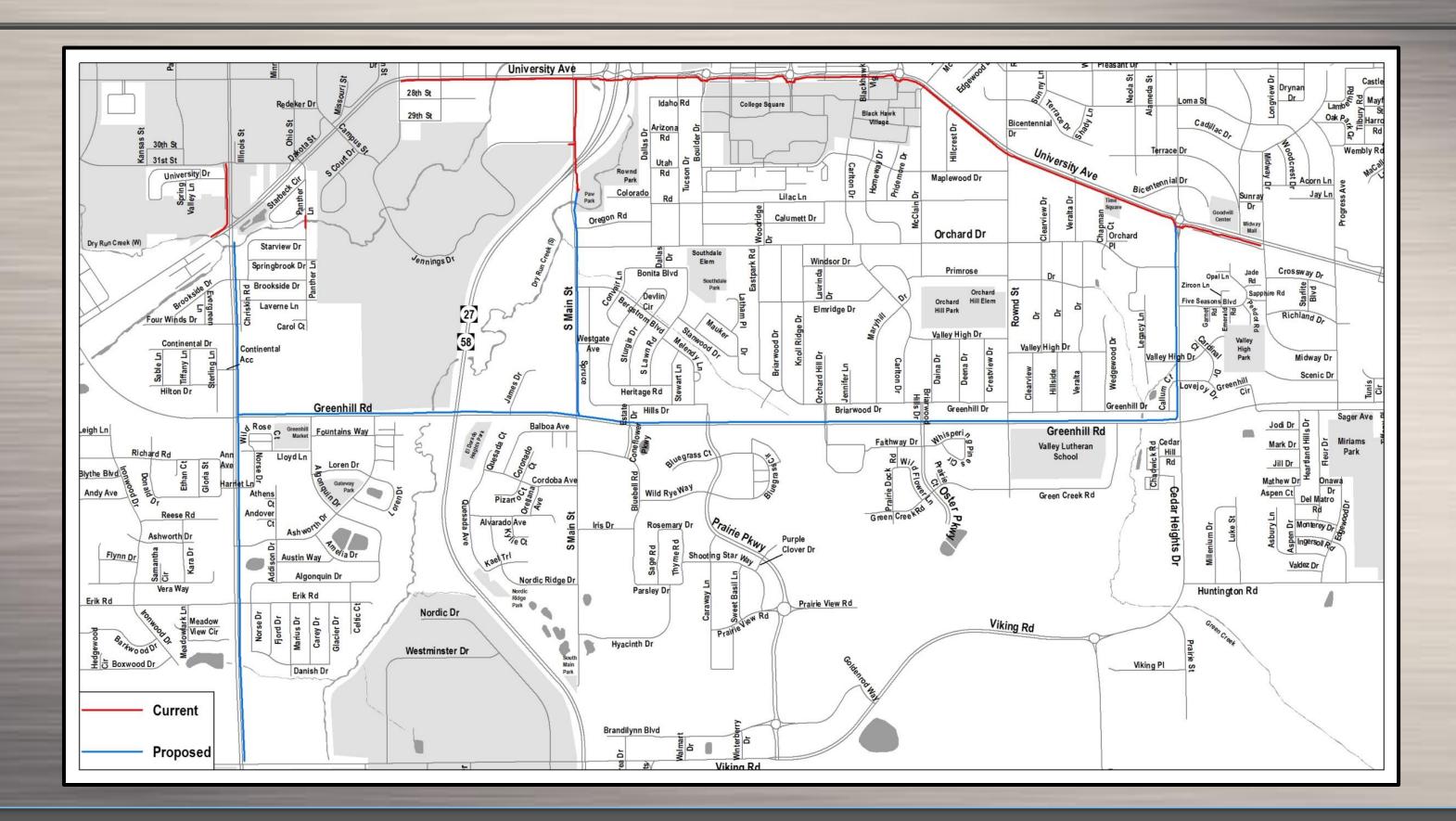
- Takes staff away from roadway ice and snow control, which is a priority.
- Additional areas requested are subject to high winds and snow storage during large snow events which will drive up costs.
- Increased liability due to difficulty keeping trails cleared.
- Will require additional equipment purchases.
- · High costs for a low number of users.











Staff Recommendation: This year, expand trail snow removal as indicated on the maps which meet current policy to clear recreation trails that are needed for more frequent pedestrian use in the winter. Continue to utilize other trails for winter activities. For goal setting, provide City Council with costs from contractors to remove snow on the remaining trails shown in blue.
