History of Committees

- Prior to 1986 there were 7 standing committees
- There have been 3 Standing Committees since 1986
 - Administration
 - Public Works
 - Community Relations & Planning
- Before 2015, Committees were not televised and were more of a casual conversation in the Conference room. Assume public expectation would be to continue to televise committee meetings and hold prior to the Council meetings.



History of Committees

- In Goal Setting in October 2006, the City Council wanted to "experiment with seven(7) member committees in an attempt to include all City Council members in discussions and determine the political likelihood of passage on any given issue before the City Council in formal session"
- This resulted in the City Council adopting Ordinance #2605 in 2006 changing the number of council members on each committee from 5 to 7.



History of Committees

- In 2014, Administrative Policy No. 7 (No. 70) was changed to formally put in the Administrative Policy what City Council decided several years ago.
- On October 6, 2014 City Council adopted Resolution 19-230, which revised City Council Meeting procedures (Administrative Policy No. 7) to refer all items that would have otherwise have gone to one of the three standing committees to the entire City Council sitting as a Committee of the Whole, where all seven members could participate in each committee item.



Reasons for Committee of the Whole

- There was debate about which committee an item should go in front of
- Annual debate about who the chair for each committee should be
- The Mayor was left out of the committee debates since not the chair and not part of the committee



Reasons for Committee of the Whole

- With committees of 5 something could pass 3-2 in committee, but then get defeated 4-3 at City Council. Therefore a concern about double the work of staff.
- With committees of 7 how is that different than a Committee of the Whole at that point

All of these reasons is how we got to a Committee of the Whole format



Other Communities

- Reached out to 10 other cities comparable in size to Cedar Falls
 - 2 cities have standing committees (Waterloo & Cedar Rapids)
 - 2 cities have some special committees for particular topics (ex. CIP review committee)
 - Most cities do not have standing committees, use work sessions or committee of the whole meetings.

Administrative Policy No. 07

Subject: City Council Meeting Procedures

Part VIII. Committee Structure

Rule 70. Appointment of committees; standing committees enumerated. All standing committees shall be appointed by the mayor and all special committees shall be appointed by the mayor unless specifically directed by the council. All standing committees of the council shall be appointed by the mayor annually at the first regular meeting of the council in January of each year, or as soon thereafter as practicable, and the first person named on each committee shall be the chair of such committee. The following shall be the standing committees:

- a) Administration.
- b) Committee of the Whole:

Except for matters which the Cedar Falls Code of Ordinances, or the express provisions of these rules, specifically direct be submitted to the Administration Committee, or except as otherwise directed by the council, it is the desire and intent of the council that all matters which are referred, or which are to be referred, to a committee of the council, shall be referred to the council's Committee of the Whole.

Rule 71. Number of committee members.

The standing committees of the council shall consist of all seven members, with the Mayor serving as non-voting chair of the committee of the whole. All special committees shall consist of five members each, unless some other number is specified. (Sec. 2-62)

ORDINANCE NO. 2605

AN ORDINANCE REPEALING SECTION 2-62, NUMBER OF MEMBERS, OF DIVISION 1, GENERALLY, OF ARTICLE II, CITY COUNCIL, OF CHAPTER 2, ADMINISTRATION, OF THE CODE OF ORDINANCES OF THE CITY OF CEDAR FALLS, IOWA, AND ENACTING IN LIEU THEREOF A NEW SECTION 2-62, NUMBER OF MEMBERS, DEALING WITH THE NUMBER OF COUNCIL MEMBERS ON STANDING COMMITTEES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CEDAR FALLS,

IOWA:

Section 1. Section 2-62, Number of members, of Division 1, Generally, of Article II, City Council, of Chapter 2, Administration, of the Code of Ordinances of the City of Cedar Falls, Iowa, is hereby repealed in its entirety, and the following new Section 2-62, Number of members, is enacted in lieu thereof:

Sec. 2-62. Number of members.

- (a) The standing committees of the council shall consist of seven members each.
- (b) All special committees of the council shall consist of five members each, unless some other number is specified by the resolution which appoints such special committee.

Sec. 2-68. - Appointment; standing committees.

- (a) All standing committees of the council shall be appointed by the mayor, and all special committees shall be appointed by the mayor unless specifically directed by the council. All standing committees of the council shall be appointed by the mayor annually at the first regular meeting of the council in January of each year, or as soon thereafter as practicable, and the first person named on each committee shall be the chairperson of such committee.
- (b) The following shall be the standing committees:
 - Administration.
 - (2) Public works.
 - (3) Community relations and planning.

Sec. 2-69. - Number of members.

- (a) The standing committees of the council shall consist of seven members each.
- (b) All special committees of the council shall consist of five members each, unless some other number is specified by the resolution which appoints such special committee.
