Sec 4-2-3- (b)

Failure to comply with a notice to remove debris, trash, junk and litter from a property within seven days of notification will constitute a violation of this section. The town manager shall be authorized to remove such material from a property and bill the property owner for the expense of such. Failure to pay for the removal of above material within 15 days of notification will constitute a lien against the property for the amount so billed.

Motion made by Council Member Whitaker, Seconded by Council Member Mull to approve as a first reading to Code Section 4-1-11 Sidewalks the following changes.

Sec. 4-1-11. - Obstructions—Generally.

No person shall obstruct or block any street or sidewalk in the town.

Businesses may display no more than 3 items in front of the property. The displayed items must be abutted to the building. Sidewalks are to remain unobstructed to pedestrian traffic at all times.

Any business that wants to place tables and chairs in front of the business must obtain a special permit from the town manager.

No person shall conduct any public meeting or deliver an address on or near any street or sidewalk of the town which may cause congregation on the sidewalk or street without first obtaining a permit from the Town Manager.

13. Planning Commission Procedures

Motion made by Council Member Whitaker, Seconded by Council Member Keeton to approve the changes to the procedures for rezoning applications and conditional use permits.

**Planning Commission Procedures** 

1. Upon receipt of an application for rezoning or a conditional use permit, Council will forward the matter to the Planning Commission for review.

2. The Planning Commission will make a recommendation and ask Council to set a public hearing date.

3. Council will set the matter for public hearing.

4. At the public hearing, council will immediately vote on the matter if there are no objections. If citizen concerns or objection are raised during the public hearing, the matter will be sent back to the Planning Commission for further review.

#### **Mayor/Council Comments**

Mayor Fahringer let everyone know that the meeting agenda is available on the Town website for everyone to have access. He gave highlights of the Public Works, CCPD and CCVFD and commended them all for their hard work. He also reminded everyone that Bike Safety Day will be held on Saturday, July 19, 2021.

Council Member Wilson asked about changing the time of the meeting. She stated that she has spoken with several of the regular attendees and they are fine with moving to an earlier time. Town Manager Forbes stated that sending out a survey is not feasible because of the cost. He suggested that a Facebook poll be done around the beginning of July to have results at the next meeting. Council Member Mull agreed with the survey on Facebook and he also suggested placing the survey in the newspaper.

Council Member Whitaker asked if the airport lights have been repaired. Public Works Superintendent Jim Wilson replied that the lights are working now. Council Member Whitaker asked Chief Jordan if the police officers patrolled the airport daily. Chief Jordan replied that they did not patrol daily at the airport. Council Member Whitaker then asked Chief Jordan if people are allowed to ride mini bikes on the street. Chief Jordan stated if they are caught riding on the streets or sidewalks they will be cited. Council Member Whitaker then asked what can be done about all the street lights out in town. Public Works Superintendent Jim Wilson stated that citizens can call and report the pole number to Dominion or they can call the Town Shop with the pole number and we will call in to the Dominion. Chief Jordan stated that he will ask the officers to stop and take down the pole number if they see a light out in Town. Council Member Whitaker then asked what the rules about semi-truck parking in Town. Town Manger Forbes indicated that these trucks should not be parked in residential areas.

#### **Town Manager's Oral Report**

Town Manager Forbes said he was glad to see everyone. Chief Jordan stated that Community Watch will resume in September. Town Manger Forbes told everyone that he met with Sergeant Will Stembridge concerning National Night Out. National Night Out will now be held in each Town in August. This event is now in the planning stage.

AN ORDINANCE ADOPTING TITLE 46.2 AND ARTICLE TWO 18.2-266-18.2-273,

Code of Virginia of 1950 as amended

WHEREAS, the <u>TOWN OF CHASE CITY</u>, Virginia, a municipal corporation, pursuant to Authority duly invested therein, has the responsibility to control, govern, and direct motor vehicular laws and regulations and laws and regulations concerning the health and safety of persons,

WHEREAS, the Commonwealth of Virginia has heretofore enacted legislation concerning the control and operation of motor vehicles and the health and safety of persons, and

WHEREAS, pursuant to Section 46.2-1313, and Section 1-13.39:2 Code of Virginia, of 1950 as amended, the Town Council of the **TOWN OF CHASE CITY**. Virginia, has the authority to adopt and to incorporate by reference various provisions of the Code of Virginia, and may include future amendments to the state statutes, and, after thorough and mature consideration thereof, the Town Council deems such adoption and incorporation to be in the best interest:

#### THEREFORE BE IT RESOLVED:

1. Pursuant to authority duly vested, the <u>TOWN OF CHASE CITY</u> hereby adopts and incorporates by specific reference thereto Title 46.2, Code of Virginia, 1950, as amended, and the **2021** Cumulative Supplement, relating to motor vehicle laws, and as amended in the future. In addition, the <u>TOWN OF CHASE CITY</u> hereby adopts and incorporates express reference thereto, Article Two, Chapter 7, of 18.2, Code of Virginia, 1950, as amended, commencing with section 18.2-266 through 18.2-273 as in force on July 1, 1994, and as amended in the future.

2. The **TOWN OF CHASE CITY** hereby adopts and incorporates by specific reference thereto any and all amendments, additions and deletions as may from time to time be made by the General Assembly of the Commonwealth of Virginia which may be entered subsequent to the adoption and incorporation thereof as authorized by Virginia Code Section 1-13.39:2.

3. By adoption and incorporation of the foregoing provisions of the Code of Virginia regulating motor vehicular operation and control and the health and safety of it citizens, the **TOWN OF CHASE CITY** hereby has and shall have the authority to enforce the revisions adopted by reference and incorporated herein.

# Department of Public works report June 2021

**The street crew:** June was a very good month. The street crew completed a lot of tasks in the month of June.

The crew cleared some overhanging limbs that were obstructing roadways. And cleared some signs that were obstructed and put up signs that needed to be put up.

The grass cutting has resumed since the sidewalks were completed. They have struggled a bit getting to everything. Although they will step up to the challenge.

Hauled loads of gravel and dirt that were bought by citizens.

Donnie filled in on the Dumpster truck when necessary.

Cleared several deceased animals from Main Street. As well as helped to remove a skunk caught in a trap by a citizen.

Also helped with meter reading and fixing a couple of leaking meters as well as replaced a few meters.

Worked on fixing some of the graves in the cemetery filling in low spots and sowing grass.

### Water and sewer crew:

Have fixed quite a few spots as far as water leaks and sewer problems. They have curbed over 150,000 gallons of I&I problems thus far.

They had 40 miss utility request and 5 emergency Requests.

Pumped and dumped leachate from the landfill tank 3 different times minimum was three trucks and maximum was seven trucks.

Did some flushing of sewer line problem areas.

Did the normal hydrant flush.

Marked and dug graves and covered when funeral services were complete.

Used the camera system to inspect some of the sewer line that was identified during smoke testing.

Had multiple sewer clean outs.

Still working with B&B on the Endly street project

Fixed a water leak on Ogburn Street.

Helped out at WWTP putting in a new line for the bathroom there.

Helped dig a ditch for a citizen that had a spring keeping their back yard wet and was making it almost impossible to mow grass.

Also are helping identify things in our inventory that are no longer in use.

# **Building and Grounds:**

Inspects the Robert E Lee building and airport on a regular basis.

Keeps paper products in all of the buildings of the town and does what work is needed such as light bulbs, fixing doors etc...

Checked and signed fire extinguishers for the month.

Replace several street light bulbs and all air filters in the town buildings.

Worked on lights on the runway at the airport. Keeps an eye out for leaks after storms on hangers and other buildings. He also has replaced some of the receptacles and breakers in the cafe area.

Carried the dump truck to the landfill for the WWTP.

Chris has been helping out with WWTP in many aspects as well as doing his normal duties.

Chris has helped out with painting at WWTP and hauling sludge from Boydton.

# Shop:

Worked on police dept. cars to include changing oil, belts, tires, inspection, air conditioning, seats, batteries, etc...

Fixed tires on several police cars and the garbage truck.

Sharpened and worked on chainsaws on several occasions.

Working on the Chevy dually and the jetter truck brakes.

Fixed a broken hose on the garbage truck.

Fixed Brakes on the garbage truck. Working on the never ending blade sharpening and lawn mower maintenance.

# Sanitation crew:

Completed trash rounds twice per week.

Guys did an outstanding job on trash removal. Facing many different weather related obstacles.

It has been noticed that there seems to a lot more trash since the pandemic started most likely because people are home more.

# **Commercial:**

David is doing a great job keeping the dumpsters cleared. Donnie has jumped in on occasion to help with late call ins.

# WWTP:

Cleaned water clarifiers and sand filters on a daily bases.

Completed daily, weekly, and monthly water tests.

Checked on pumping stations every day and added grease remover as needed.

Things at WWTP are starting to smooth out since we have cut the flow in half with the corrected I&I problems.

They have painted one of the clarifiers, and have started the other.

They have figured out and corrected several problems in the basin however there are more things that need correcting.

**Projects completed:** The pavement rejuvenation on Marshall St and Berry St has been completed. A round of brush pick up has been completed. The flow meters from the EPA have been read and data supports what we thought during rain events.

Projects underway: Still have a couple of I&I spots to correct however we have corrected a lot. Still have a couple of places that need to be slip lined, I am awaiting quotes on those. There will be some patching done in the near future. The 500,000 gallon water tower on Boyd St will be painted inside during July.

Superintendent statement: In the almost 2 years I have been here I have seen a lot of things happen, some good and some not so well but all necessary to move ahead in the world. In my opinion this town is moving in the right direction. I am proud to be a part of the new life that is being kindled in this town. I just hope we can continue to move forward from here. The world around us is changing some of the changes we need to grab onto. Others we need to set aside. We have a great town with great people and we need to keep it that way. #### Sec 4-1-11

Item: To update Code Section 4-1-11

Discussion:

1. The current sidewalk ordinance does not allow businesses to display merchandise or to place any items on the sidewalk in front of the business.

2. The ordinance needs to be updated to allow businesses to advertise using Town sidewalks.

**Recommendation:** 

1. Town Council approves as second reading and adopts the following updates to the Code Section:

Sec. 4-1-11. - Obstructions—Generally.

No person shall obstruct or block any street or sidewalk in the town.

Businesses may display no more than 3 items in front of the property. The displayed items must be abutted to the building. Sidewalks are to remain unobstructed to pedestrian traffic at all times.

Any business that wants to place tables and chairs in front of the business must obtain a special permit from the town manager.

No person shall conduct any public meeting or deliver an address on or near any street or sidewalk of the town which may cause congregation on the sidewalk or street without first obtaining a permit from the Town Manager.

#### General Election Changes

Item: To adopt the new election changes as required by the Commonwealth.

Discussion:

- 1. The General Assembly changed the date of general local elections from the 2<sup>nd</sup> Tuesday in May to the second Tuesday in November each year.
- 2. Town Council must adopt the changes to reflect the new election law in the Town Charter.

Recommendation

1. Town Council adopts the following ordinance:

NOW, THEREFORE, BE IT ORDAINED by the Council of the Town of Chase City, Virginia:

1. That Section 4 Paragraph 3 of the Code of the Town of Chase City, Virginia, election and terms of members of the Council of the Town of Chase City, Virginia is hereby amended and re-ordained as follows:

Town Government; generally

Section 4

Paragraph 3

Except as set forth herein, the mayor and members of the town council shall be elected as provided in the Town Charter. Notwithstanding any provision of the Town Charter to the contrary for any election held after January 1, 2022, elections of the mayor and members of the town council shall be held at the time of the general election for terms to commence on January 1. The inaugural meeting of a newly elected council, as set forth in § 4-3 of the Town Charter, shall take place on the date of the first regularly scheduled meeting of the town council in the month of January following the November election.

No term of a mayor or a member of council shall be shortened in implementing this change to the November election date. The mayor and members of the town council who were elected at a May general election and whose terms are set to expire as of June 30 shall continue in office until their successors' terms commence on the January 1 following their election at the November general election.

2. That this ordinance shall be effective on and after July 1, 2021.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Town of Chase City, Virginia:

1. That Section 4 Paragraph 3 of the Code of the Town of Chase City, Virginia, election and terms of members of the Council of the Town of Chase City, Virginia is hereby amended and re-ordained as follows:

Town Government; generally

Section 4

Paragraph 3

Except as set forth herein, the mayor and members of the town council shall be elected as provided in the Town Charter. Notwithstanding any provision of the Town Charter to the contrary for any election held after January 1, 2022, elections of the mayor and members of the town council shall be held at the time of the general election for terms to commence on January 1. The inaugural meeting of a newly elected council, as set forth in § 4-3 of the Town Charter, shall take place on the date of the first regularly scheduled meeting of the town council in the month of January following the November election.

No term of a mayor or a member of council shall be shortened in implementing this change to the November election date. The mayor and members of the town council who were elected at a May general election and whose terms are set to expire as of June 30 shall continue in office until their successors' terms commence on the January 1 following their election at the November general election.

2. That this ordinance shall be effective on and after July 1, 2021.

#### ARPA Funds

Item: To update and approve purchase of items with ARPA funds.

- 1. Town has received first round of money for ARPA.
- 2. Complete the electronic installation of SCADA with the additional equipment needed for the WWTP at a cost of \$84,456.00
- 3. Upgrade to all digital water meters at a cost of 472,420.00. This will allow accurate and timely meter reading and the program will integrate with our billing system.
- 4. Slip line for sewer line from Grove Avenue to the ballpark at a cost of \$109,222.00. This liner will prevent infiltration of the sewer line and will fill in all the cracks, holes, etc.
- 5. Two new pumps for WWTP at a cost of \$44,900.00 each.

#### Recommendation

Dorsett Controls (DC) is pleased to provide a scope and cost proposal to design, build, and install additional SCADA controls and monitoring on the Town of Chase City's Wastewater Treatment Plant and Collection System. All efforts included in this scope of work will be added to Chase City's existing InfoScan platform.

The proposed approach at the WWTP is to add the plant's grit chamber, influent screen, and portable back-up pump's desired I/O to the Main Control RTU located in the control building. The Main Controls RTU has adequate I/O channels available to add the desired I/O. All wire, conduit, and field terminations associated with this process is to be installed by Chase City or others.

A dissolved oxygen sensor and PH sensor will be installed in the west basin, by others. These conductors will be connected to SCADA at the Blower Building RTU. Available channels on existing hardware exists enabling Dorsett to simply add these new conductors to the system without adding additional hardware. Dorsett Controls' scope includes two 4-20 mA isolators. All shielded wire, conduit, and field connections associated with these sensors is to be installed by others.

The sludge press building includes a J-Press (sludge press) unit that will be added to the existing system through hardwired connections. In addition to the sludge press unit, Chase City will be installing a flow meter on the sludge press that will also be picked up on SCADA. Currently, there is not an RTU in this portion of the plant and the current design includes adding a new 1 card RTU at this location. This RTU is designed to communicate with the Control Building RTU via a wireless bridge set.

Chase City's collection system consists of 4 pumping stations that deliver wastewater from commercial and residential areas to the treatment facility. The proposed approach is to build, test, and install cellular communicating RTUs at all 4 pumping stations. Dorsett's scope is to also include graphical displays, programming, database management, reporting agent, and historical data for these four sites.

The four wastewater pumping stations included in this scope are as follows: Thyndale PS, Oakwood PS, Butchers Creek PS, and Jonbil PS. A points list for each site has been generated by DC and approved by Chase City. Should the attached appendix A, the points list, be modified from its current form may induce a change in price.

The current hardware design is to include MS5 UNV one card panels at each remote site. The Butcher Creek PS RTU will be the only RTU installed inside a structure. The remaining 3 RTUs will be stainless steel and will be mounted in an outdoor environment. Dorsett Controls will build, test, and ship the SCADA control panels to the Town of Chase City. Town of Chase City's electrician will be responsible for mounting each RTU.

Each pumping station's RTU will be equipped with a 4G cellular modem. The cellular data plans for each of these cell modems will be added to the Town of Chase City's existing Verizon account. There are two options on the networking of the cellular communications network; public facing cellular network and a private cellular network. The difference in these two options is the private cellular private network will require an additional hardware component, an access point. This access point will be a 4G cellular modem that will route all traffic from the field modems before touching the server. Verizon typically requires a onetime private network setup fee (\$500); however, this fee may potentially be waived based on the Town's existing Verizon account.

Dorsett Controls' scope herein does not include electrical installation of the new SCADA RTUs. The Town of Chase City shall either use in-house personnel or contract with a qualified electrical contractor to complete the electrical installation.
