Comment: Honorable City of Clovis Council Members,

I have been made aware of a recent vote of denial made by your body concerning the proposal to fly only three flags from Clovis city government buildings; i.e., the United States flag, State of California flag and the City of Clovis flag. This proposal was intended to negate potential division within our community concerning the displaying of flags. It apparently had wide support of the community at large.

As a retired Marine officer, I was flabbergasted, to say the least, that a generally conservative community such as ours must even argue the point of what flags we should fly over our city government buildings. I have watched our military become an increasingly social experiment for the past 50 years. This is inherently wrong! Our military's sole purpose is to protect and defend our Nation. There is only one flag to be considered here - our national colors. Social experiments, if they must be done at all, should not be connected to our military. The same sentiment should go for state and local government buildings. State and local flags represent those entities which include all its' citizens regardless of race, creed, color, gender or beliefs, religious or otherwise. Any other flags should be welcome to be flown from citizen's yards and businesses, but have no place with respect to our government buildings.

I sense that the majority of the council was afraid of offending someone or some organization within the community. You cannot make all the people happy all the time. We have allowed ourselves to be increasingly ruled by the minority of any given issue. Where did the term "the majority rules" go? I am greatly disappointed by the failure of this council to stand up for what you know is right. I voted for you, but I will remember this on the next election day. Please reconsider your stance and stand up for what you know to be right. This country, state and community do not deserve less.
