CONFLICT OF INTEREST

Councilmembers should consider recusal if a campaign contribution exceeding \$250 has been received from the project proponent (developer, applicant, agent, and/or participants) since January 1, 2023 (Government Code 84308).

RECOMMENDATION

That the City Council approve the requests from Clovis Senior Activities Center and Fresno Street Eats for street closures in the City of Clovis for the calendar year 2023 to hold special events.

EXECUTIVE SUMMARY

Staff requests street closure simultaneously, and in advance, to allow for proper event planning. Since the events in this request are not routine in nature, or their routine model has changed, they were not included in the list of requested street closures presented to City Council on January 9, 2023.

BACKGROUND

Attached is a matrix of proposed events (Attachment 1), sponsored by Clovis Senior Activities Center and Fresno Street Eats for closure of streets in Clovis during the calendar year 2023. Each activity has a unique street closure request. The boundaries and time of street closure has been reviewed by staff member from each department.

On January 20, 2023, a letter was sent to neighboring residents, business operators, and property owners (Attachment 2), soliciting comments/concerns regarding the subject street closure requests. Staff has received no comments or concerns on these events.

FISCAL IMPACT

The City of Clovis is positively impacted by the proposed events. Local businesses benefit from large numbers of people visiting their neighborhood and the City of Clovis benefits from the increased tax revenue.

The promoters of each of these events will bear the cost of additional City services and any other additional services.

REASON FOR RECOMMENDATION

In previous years, more than 300,000 people have attended the various events held in Clovis annually, many of whom have returned to Clovis to patronize local businesses. In the past, Clovis Senior Activities Center and Fresno Street Eats requested street closures to hold events in Clovis on an individual basis, prior to the event. There have been several occasions where the requests were not processed in time to allow for proper planning from the City's perspective. Therefore, staff is requesting street closure simultaneously for all the special events to ensure adequate time for event planning.

ACTIONS FOLLOWING APPROVAL

- 1. Staff will notify Clovis Senior Activities Center and Fresno Street Eats of Council's decision.
- 2. Staff will work with Clovis Senior Activities Center and Fresno Street Eats to ensure that the sponsors provide security and cleanup of the events on an individual basis.

CONFLICT OF INTEREST

RECOMMENDATION

For the City Council to authorize the submission of an application to the California State Department of Housing and Community Development (HCD) for funding under the CalHome Program; and authorizing the City Manager, or his designee, to execute the Standard Agreement if selected for funding, any Amendments thereto, and any related documents necessary to participate in the CalHome Program.

EXECUTIVE SUMMARY

On January 6, 2023, California HCD released a Notice of Funding Availability (NOFA) for the CalHome Program. Staff is seeking authorization to submit an application in the amount of \$5,000,000.

BACKGROUND

The City of Clovis has continuously sought grant funding to provide for critical programs and improvements in the community. Staff received a NOFA from California HCD regarding the CalHome program and is seeking authorization to submit an application in the amount of \$5,000,000 to fund an owner-occupied rehabilitation loan program, a mobile home replacement loan program, and a mortgage assistance program. Staff will target assistance, if awarded, as follows:

Owner-Occupied Rehabilitation Assistance - \$3,500,000 to be used to provide rehabilitation loans to owner-occupied, low-income households in the City of Clovis; also, to be used to provide loans to low-income households to replace severely-dilapidated mobile homes located in the City of Clovis. Staff anticipates providing assistance to approximately 30 homeowners.

Mortgage Assistance with Substantial Rehabilitation - \$1,500,000 to be used to provide financial assistance to low-income first-time homebuyers to acquire, or acquire and rehabilitate a home located in the City of Clovis. Staff anticipates providing assistance to approximately 10 homebuyers.

FISCAL IMPACT

There would be no impact to the City's General Fund, and the program would provide funding for affordable housing projects in the City of Clovis. If the application is funded by California HCD, a budget amendment in the amount of the grant award would be submitted for Council approval.

REASON FOR RECOMMENDATION

California HCD requires City Council approval before an application can be submitted under the CalHome program.

ACTIONS FOLLOWING APPROVAL

Staff will prepare and submit the CalHome grant application to California HCD before the application due date of February 28, 2023.

ANY RELATED DOCUMENTS, THERETO, IF SELECTED FOR FUNDING, AS MAY BE
NECESSARY TO PARTICIPATE IN THE CALHOME PROGRAM AS IDENTIFIED IN THE
2022 HOMEOWNERSHIP SUPER NOFA (HOSN) DATED JANUARY 6, 2023

WHEREAS, the California Department of Housing and Community Development (hereinafter referred to as "HCD") has issued a Notice of Funding Availability ("NOFA") on January 6, 2023, for the CalHome Program established by the Affordable Housing Bond Act Trust Fund of 2018 implemented and interpreted by Chapter 6 (commencing with Section 50650) of Part 2 of Division 31, of the California Health and Safety Code and Chapter 2 (commencing with Section 54006) of Part 16 of Division 31, of the California Health and Safety Code (the "statute"). Pursuant to the statute, HCD is authorized to approve funding allocations utilizing monies made available by the State Legislature to the CalHome Program as implemented by CalHome Program Final Guidelines adopted by HCD on December 30, 2022; and

WHEREAS, the City of Clovis wishes to submit an application to HCD for an allocation of CalHome funds in the amount of \$5,000,000.

NOW, THEREFORE, BE IT RESOLVED, that the City of Clovis has reviewed and hereby approves the submission to the State of California of an application in the aggregate amount of \$5,000,000, for the following HOSN activities pursuant to the 2022 HOSN Notice of Funding Availability:

Owner-Occupied Rehabilitation Assistance - \$3,500,000 to be used to provide rehabilitation loans to owner-occupied, low-income households in the City of Clovis; also to be used to provide loans to low-income households to replace severely-dilapidated mobile homes located in the City of Clovis.

Mortgage Assistance - \$1,500,000 to be used to provide financial assistance to low-income first-time homebuyers to acquire a home, or acquire and rehabilitate a home located in the City of Clovis.

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the City of Clovis hereby authorizes and directs the City Manager, or designee, to execute and deliver the application, and act on the City of Clovis' behalf in all matters pertaining to such application.

EXECUTIVE SUMMARY

The Economic Development Corporation serving Fresno County (EDC) has submitted their Second Quarter Report of activities for the City Council to receive and file, as required per the 2022-2023 Agreement with the City.

BACKGROUND

In the summer of 2022, the City of Clovis and the EDC entered into a contract for the 2022-2023 fiscal year to provide regional marketing and business services to Clovis businesses. The contract provides for \$40,000 in baseline funding and provides \$10,000 for a medical attraction study implementation plan to be completed. This allows Clovis to be part of a regional effort in attracting commercial and industrial businesses to Clovis. Attached is a report detailing the progress of their activities to provide information to industrial/commercial representatives not currently located in Clovis for recruiting purposes, and continue to assist existing Clovis businesses with informational and/or technical assistance to access statewide business support programs.

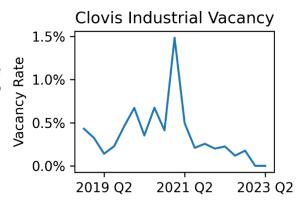

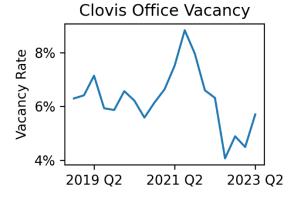
November 2022 Unemployment Rates

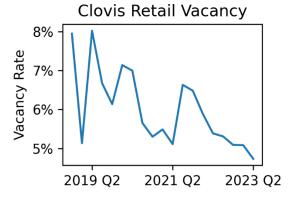

Realizing the current labor demands among our local businesses, the EDC, Department of Social Services and educational partners have worked with industry stakeholders to develop customized trainings to fulfill today's workforce needs. Utilizing input from various industry practitioners, each training curriculum is developed to create career pathways to meet tomorrow's industry needs, help businesses grow, and put individuals back to work. Below is a list of customized training programs underway:

Valley Apprenticeship Connections

Pre-Apprenticeship Program. The partnership between Fresno County EDC, the Department of Social Services, and Fresno EOC will provide a 12-week program comprised of classroom and construction-based training.

John Lawson Truck Driving

Class A Truck Driving Class. The 10-week training is a partnership between Fresno County EDC, the Department of Social Services, West Hills Community College, and Lawson Rock and Oil.

Central Valley Training Center

Pre-Apprenticeship Program. The partnership between Fresno County EDC, the City of Selma, and High-Speed Rail Authority will provide a 12-week program comprised of classroom and construction-based training.

Highlights

October 2022

Project Telecom | All

A new lead came in for an organization looking to establish training grounds for a program that will target telecommunications. Spain FDI | City of Fresno

Miguel Ruelas and Tiffany Louk organized a site tour of three small, industrial sites for the CEO of H2B2, Pedro Pajares, in conjunction with Kyle Riddering of Newmark Pearson Commercial. Two of the sites were along the 99 corridor near Ashlan Ave, and the third was located near the Fresno Airport. An FDI lead, H2B2 is looking for small industrial sites to assemble imported equipment. The goal is to hire 30-50 graduates to work on the broadband construction project that will run 10,000 miles spreading across southern and northern California.

An introductory call was made with Leads from CWA and Fresno County EDC's Director of Special Projects on 11/29/2022. Both parties were able to have a conversation to learn more about the training programs that are being offered.

Bioeconomy Steering Committee | All

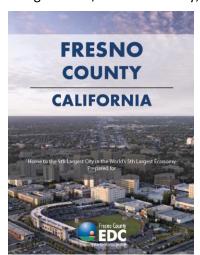

EXECUTIVE SUMMARY

Attached is the Investment Report for the month of September 2022. Shown in Attachment 1 is the distribution of investments which lists all the individual securities owned by the City with the book and market values. Book value is the actual price paid for the investment. Market value is the amount that the investment is worth if sold in the open market. The market value (which fluctuates daily) that is used in the report is as of the last working day of the month. Attachment 2 reflects the monthly investment transactions for the month of September 2022. Attachment 3 lists the certificates of deposit. Attachment 4 lists the municipal securities. Attachment 5 is a graph of Treasury rates on September 30, 2022.

The investment of the City's funds is performed in accordance with the adopted Investment Policy. Funds are invested with the following objectives in mind:

- 1. Assets are invested in adherence with the safeguards and diversity of a prudent investor.
- 2. The portfolio is invested in a manner consistent with the primary emphasis on preservation of the principal, while attaining a high rate of return consistent with this guideline. Trading of securities for the sole purpose of realizing trading profits is prohibited.

- 3. Sufficient liquidity is maintained to provide a source for anticipated financial obligations as they become due.
- 4. Investments may be made, consistent with the Investment Policy Guidelines, in fixed income securities maturing in three years or less and can be extended to five years with the City Manager's approval.

The Finance Department invests the City's assets with an expectation of achieving a total rate of return at a level that exceeds the annualized rate of return on short-term government guaranteed or insured obligations (90-day Treasury bills) and to assure that the principal is preserved with minimal risk of depreciation or loss. In periods of rising interest rates, the City of Clovis portfolio return may be less than that of the annualized 90-day Treasury bill. In periods of decreasing interest rates, the City of Clovis portfolio return may be greater than the annualized 90-day Treasury bill. The current 90-day Treasury bill rate (annualized) is 0.86%. The rate of return for the City of Clovis portfolio is 1.68%. The goal for the City of Clovis investment return is 120% of the 90-day Treasury bill rate. The current rate of return is 196% of the Treasury bill rate.

In accordance with the Investment Policy, the investment period on each investment does not exceed three years and can be extended to five years with the City Manager's approval. As of September 2022, the average investment life of the City's investment portfolio is 1.50 years.

Current Investment Environment and Philosophy

During the month of September 2022, the federal funds rate increased to 3.00%-3.25%. On September 30, 2022, the Treasury yield curve increased from 3-month to 3-year notes, then decreased to 10-year notes.

Certificates of Deposit (CD's)

The City purchases both negotiable and non-negotiable Certificates of Deposit (CD's). Although negotiable CD's can be traded, it is the City's policy to buy and hold all CD's. Negotiable CD's are held by U.S. Bank, a third party custodian. Non-negotiable CD's are held in the City's safe.

Purchases and Maturities

- 1 government security totaling \$2,000,000 was purchased.
- 1 government security totaling \$6,000,000 matured.
- 11 certificates of deposit totaling \$2,750,000 were purchased.
- 2 certificates of deposit totaling \$500,000 matured.
- 4 municipal securities totaling \$4,315,000 were purchased.

Market Environment

- During September the federal funds rate increased to 3.00%-3.25%.
- On September 30, the yield curve increased from 3-month to 3-year notes, then decreased to 10-year notes. See Attachment 5, Graph of Treasury Rates on September 30, 2022.

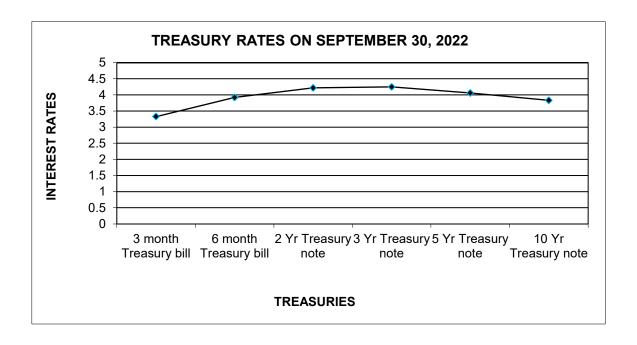

EXECUTIVE SUMMARY

State law (Government Code Section 66006) requires that local agencies shall make available to the public certain information relative to development impact fees.

BACKGROUND

Per law, the City is providing account information relative to development impact fees. This information includes the following:

- 1. A description of the fee.
- 2. The amount of the fee.
- 3. The beginning and ending balance of the fee account.
- 4. The amount of the fee collected and interest earned.
- 5. Identification of the public improvements for which the fee was expended, the amount of the expenditure and the percentage funded by the fee.
- 6. The date by which construction will begin if sufficient funds are available.
- 7. A description of each fund transfer or loan from the account.
- 8. The amount of refunds made of unexpended funds once all projects for which the fee was imposed are complete.

The City of Clovis has established the following development fees that are collected at various stages of the development process:

- 1. Sewer Major Facilities Fee
- 2. Sewer Oversize Acreage Fee
- 3. Sewer Front Footage Fee
- 4. Water Major Facilities Fee
- 5. Water Oversize Acreage Fee
- 6. Water Front Footage Fee
- 7. Water Supply Fee
- 8. Community Sanitation Fee
- 9. Park Acquisition and Development Fee
- 10. Major Street Fees

The following is the required information provided for each of the above fees for fiscal year 2021-22:

1. Sewer Major Facilities Fee: The Sewer Major Facilities Fee is for the construction of the Clovis Sewage Treatment Water Reuse Facility (STWRF) and the capital improvement costs required for upgrading of the Regional Sewer Treatment Plant, as well as debt service payments related to the bond issues to construct the improvements. The fee for 2021-22 was \$8,109 per equivalent dwelling unit (EDU). Most of these funds are committed to repayment of Sewer Bonds.

The fee for 2021-22 was \$1,035 per gross acre. The fee is used to reimburse developers who have installed the lines. Disbursement is made based on the developer's claim.

3. Sewer Front Footage Fee: The Sewer Front Footage Fee is for the reimbursement of sewer mains previously installed. The fee for 2021-22 was \$19.69 per linear foot. The fee is used to reimburse developers who have installed the lines. Disbursement is made based on the developer's claim.

4. Water Major Facilities Fee: The Water Major Facilities Fee is for the construction of water wells, well site acquisitions, well head treatment, auxiliary power systems, reservoirs, surface-water treatment facilities, and debt service payments related to bond issues to construct the improvements. The fee for 2021-22 was \$5,206 per unit. The transfer in from the Water Enterprise represents the Enterprise customers' share of debt service on the surface water treatment plant.

6. Water Front Footage Fee: The Water Front Footage Fee is for reimbursement of water mains previously installed. The fee for 2021-22 was \$23.83 per linear foot. The fee is used to reimburse developers who have installed the lines. Disbursement is made based on the developer's claim.

7. Water Supply Fee: The Water Supply Fee pays for the cost to acquire additional water supply for properties with development intensities that will exceed the current water entitlement. For properties within the Fresno Irrigation District (FID), the entitlement is 2.1 acre-feet/year. The current cost to acquire annual water supply is \$5,500 per acre-foot.

Major Street Fees: The Street fees include fees for center travel lane improvements, outside travel lane improvements, construction of bridges, construction of traffic signals, under-grounding of utilities, quad intersections, and administration. The fees are specific to certain areas within the City based on the infrastructure requirements and development characteristics of the areas.

Outside Travel Lane Fee: The fee is to reimburse developers for Outside Travel Lane improvements that were constructed with their project in excess of the development's proportionate share.

Center Travel Lane Fee: The fee is to reimburse developers for Center Travel Lane improvements that were constructed with their project, in excess of the development's proportionate share.

Traffic Signal Fee: The fee is for the reimbursement for the cost to install traffic signals either by the City or developers in excess of the development's proportionate share.

Bridge Fee: The fee is for the reimbursement for the cost to construct bridges and culverts either by the City or developers in excess of the development's proportionate share.

Quad Intersection Fee: The fee is for the reimbursement for the cost to construct quad intersection improvements either by the City or developers in excess of the development's proportionate share.

Undergrounding Overhead Utilities: The fee provides a funding source for the City to underground existing overhead utilities or to reimburse developers for the undergrounding of existing overhead utilities in excess of the development's proportionate share. Under-grounding of existing overhead utilities includes the undergrounding along certain arterial and collector streets.

CONFLICT OF INTEREST

Councilmembers should consider recusal if a campaign contribution exceeding \$250 has been received from the project proponent (developer, applicant, agent, and/or participants) since January 1, 2023 (Government Code 84308).

RECOMMENDATION

For City Council to approve a resolution authorizing amendments to the City's Classification and Compensation Plans by revising the Sanitation Operator classification with a salary range of \$4,692 to \$5,704 per month and revising the Senior Sanitation Operator classification.

EXECUTIVE SUMMARY

It is necessary to revise both the Sanitation Operator and the Senior Sanitation Operator classifications to more clearly define the definition, class characteristics, education and experience requirements of each position. The Sanitation Operator is the entry level classification for the refuse collection classification series but has not been used in many years and therefore is being updated. The recommended salary range for the Sanitation Operator is \$4,692 to \$5,704 per month. After several years in the entry level classification, the incumbent may be eligible to flex into the Senior Sanitation Operator position. The Sanitation Operator position was previously approved in the FY 22-23 Position Allocation Plan.

BACKGROUND

An analysis of both the Sanitation Operator and the Senior Sanitation Operator classifications recently conducted identified a need to revise both classifications. The Sanitation Operator is an existing classification to the refuse collection classification series, that has not been filled in many years. This classification was previously added to the FY 22-23 City Position Allocation Plan to

allow for additional training and experience prior to promoting into the Senior Sanitation Operator position. The Sanitation Operator classification has been updated to comply with current practices with a recommended monthly salary range of \$4,692 to \$5,704.

It is also recommended that the Senior Sanitation Operator Classification be updated to reflect the current duties, experience and qualifications needed to perform in the position with an unchanged salary range of \$5,473 to \$6,653. During labor negotiations with the Clovis Public Works Employees Association (CPWEA) it was agreed upon to allow for the Senior Sanitation Operator classification to be a flexible staffed position. This allows the Sanitation Operator the opportunity for a promotion after the employee has been in the position for three (3) years and passes a written and practical exam.

The classification revisions have been reviewed by the Clovis Public Works Employees Association (CPWEA) bargaining unit who agree to the revisions. Revisions to these classifications are included in Attachment A of Attachment 1.

FISCAL IMPACT

The Sanitation Operator classification was added to the FY 22-23 Position Allocation Plan which now provides a mid-level position in the refuse collection series thereby allowing employees to obtain additional experience and training prior to a flex promotion to Senior Sanitation Operator. This entry level position will be approximately a \$9,400 savings in salary and benefits annually per employee hired in this position compared to the prior practice of testing and hiring straight into a Senior Sanitation Operator position.

REASON FOR RECOMMENDATION

The classifications listed will be revised to update the job duties, education and experience required for the classifications. Council approval is required to modify the current City's Classification and Compensation Plan. The ability to promote between the two classifications is specified in the Clovis Public Works Employees Association (CPWEA) Memorandum of Understanding (MOU).

ACTIONS FOLLOWING APPROVAL

The City's Classification and Compensation Plans will be updated to include the revised classifications.

City of Clovis SANITATION OPERATOR Monthly Salary \$4,692 to \$5,704

DEFINITION

Under close supervision, to perform manual labor in the loading and unloading of trucks used in the transportation of combustible and non-combustible refuse; to perform semi-skilled duties in the area of solid waste collection; to operate a solid waste collection truck in a residential or commercial zone; and to perform related work as required.

CLASS CHARACTERISTICS

Positions in this class are distinguished from the Senior Sanitation Operator in that the sanitation operator does not operate at an experienced level; and is assigned a lesser level of responsibility in the areas of driver duties, competency, safety and training. Incumbents may operate solid waste collection vehicles such as rear-loaders, front-loaders, side-loaders, sweepers, and the metal truck. Incumbents will also assist other crew members with solid waste operations. Positions in this class perform work which is highly structured, which seldom varies, and which is performed in accordance with established instructions. Incumbents receive thorough instructions when tasks are initially assigned and after training are expected to perform duties without constant supervision. Work is reviewed frequently upon completion and while in progress. Incumbents are expected to refer most variations in work to supervisor for instructions.

EXAMPLES OF DUTIES

Assist in the collection of residential and commercial refuse; perform manual labor as assigned to assist in solid waste operations; dump garbage and refuse into refuse trucks while covering a designated route in a residential or commercial zone; unload refuse trucks at the City landfill; service and perform repairs on refuse bins replace parts, welding and painting and inspecting bins for cracks, chipped paint, rust or missing parts; operate compaction and lift equipment on solid waste trucks, drive refuse trucks; move and empty trash bins using truck hydraulics; maneuver bins into lifting position; sweep and pick up litter; clean trucks and equipment; wash and wax trucks; grease lubricate equipment to keep in good working condition; tag overloaded bins; discuss service problems with supervisors and individuals along the assigned route; avoid and may remove road hazards or obstructions; perform a variety of manual duties as required; operate City vehicles; and perform related work as required.

TYPICAL QUALIFICATIONS LICENSE REQUIRED

Possession of a valid Class B California Driver's License and a good driving record.

EDUCATION AND EXPERIENCE

Education:

High school diploma or equivalent.

One (1) year work experience in maintenance operations.

QUALIFICATIONS

Knowledge of:

- Simple record keeping;
- Personal computer operation;
- Proper methods, materials, tools and equipment used in sanitation services and maintenance work;
- Appropriate safety precautions and procedures.

Ability to:

- Perform semi-skilled maintenance and repair and construction work;
- Follow a designated refuse collection route;
- Perform minor service and maintenance to refuse bins and equipment;
- Operate solid waste collection vehicles such as front-load, side-load, rear-load, sweeper, and the metal truck, while observing legal and defensive driving practices;
- Maintain simple and accurate records;
- Understand and carry out oral and written instructions;
- Establish and maintain effective relationships with those contacted in the course of work.

SUPPLEMENTAL INFORMATION PHYSICAL DEMANDS AND WORKING CONDITIONS

• Strength: Heavy work – lifting, carrying and/or pushing 100 pounds with frequent lifting and/or carrying of objects weighing up to 60 pounds.

City of Clovis SENIOR SANITATION OPERATOR

DEFINITION

Under supervision, to lead and participate in the work of a crew assigned to collect combustible and non-combustible refuse along a designated route in a residential or commercial zone; to operate a solid waste collection truck in a residential or commercial zone; and to perform related work as required.

CLASS CHARACTERISTICS

Positions in this class are distinguished from Sanitation Operator by the assignment of a greater level of responsibility in the areas of driver duties, competency, safety, training, and experience level truck operation and successful route completion. Incumbents assigned to a one-person solid waste collection vehicle regularly complete a route as sole operator. Positions in this class perform work which is highly structured, which seldom varies, and which is performed in accordance with established instructions. Incumbents receive thorough instructions when tasks are initially assigned and after training are expected to perform duties without constant supervision. Work is reviewed periodically upon completion and while in progress. Incumbents are expected to refer most variations in work to supervisor for instructions.

EXAMPLES OF DUTIES

Leads and trains members of a refuse collection crew; completes work logs and other paper work; performs minor service on refuse bins and toters; reports mechanical, operational and route problems; drives and operate front-loaded, rear-loaded, and side-loaded, loader, metal and refuse and dump trucks; collects and dumps garbage and refuse into refuse trucks while covering a designated route in a residential or commercial zone; tags overloaded residential trash containers; informs customer of weight limitations; places tags on doorknobs; refers problems to office by two-way radio; weights trucks and submits weight reports to supervisor; unloads refuse trucks at the City landfill; cleans, washes and waxes collections trucks; grease equipment to keep in good working condition; operates compacting and lift equipment on solid waste both side-loading and rear-loading refuse trucks; moves and emptyies large trash bins and toters using truck hydraulics; discusses service problems with customers and supervisors; avoids and may remove road hazards or obstructions; operates City vehicles; and performs related work as required.

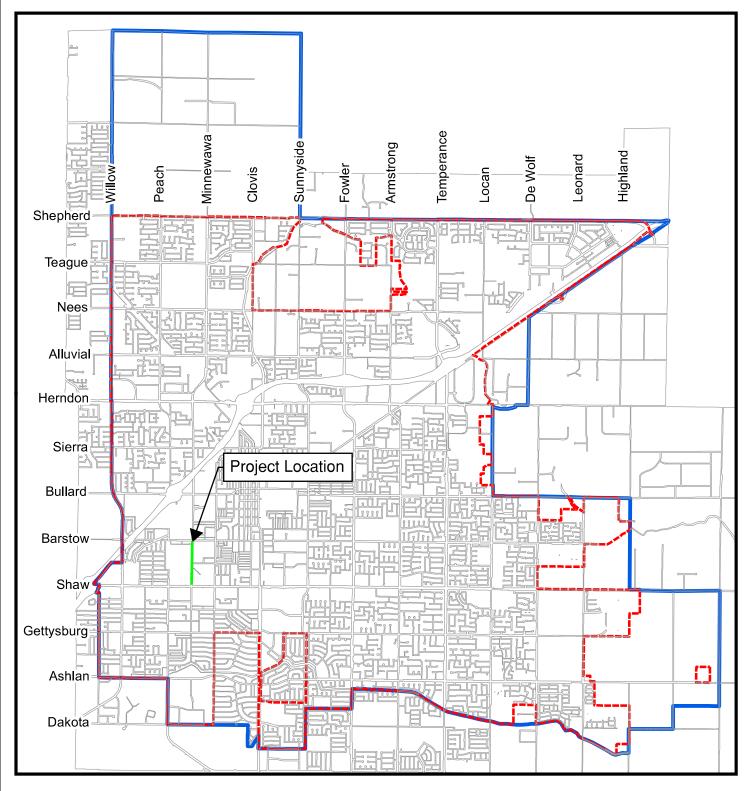

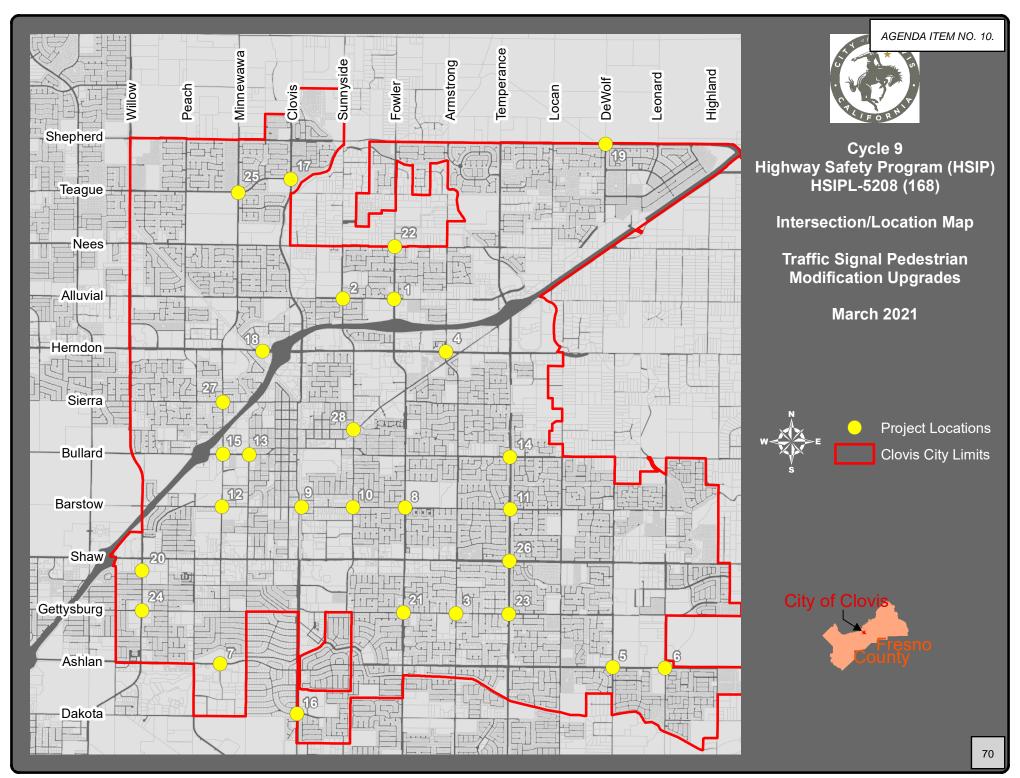

EXECUTIVE SUMMARY

Staff is recommending that City Council authorize the City Manager to award and execute the contract to Strickland Enterprises, Inc., who staff negotiated a price with after the bid opening. There were no bid proposals received from the bid opening that took place on October 25, 2022. Public Contract Code Section 22038 allows the City to pursue quotes from vendors/contractors and negotiate a price if no bids are received. Staff reached out to four contractors and decided to move forward with Strickland Enterprises, Inc.

The work to be completed under this Contract shall consist of furnishing all permits, materials, labor, equipment, fuel, tools, transportation, services and incidentals for the drilling, soil sampling, and logging of a test hole, sieve analyses, construction, water sampling, zone testing, and test-hole abandonment in accordance with these specifications. Locations of the proposed wells lie within the City of Clovis sphere of influence and may include other jurisdictions. The

proposed future site of City Reservoir T-10 is in the southeast area of Willow and Behymer Avenues, on the property north of Derrel's Mini Storage. The actual depth of test-hole drilling shall be determined by the City's Geologist based on the results from the lithologic logging.

BACKGROUND

The following is a summary of the bid results of October 25, 2022:

The project was first advertised on October 3, 2022, but there were no bids received at the bid opening on October 25, 2022. This project is budgeted in the 2022-2023 Community Investment Program. The project is funded by the Water Capital – Enterprise fund through the City Community Investment Program.

Strickland Enterprises, Inc. is a responsible contractor. There are sufficient funds available for the anticipated cost of this project.

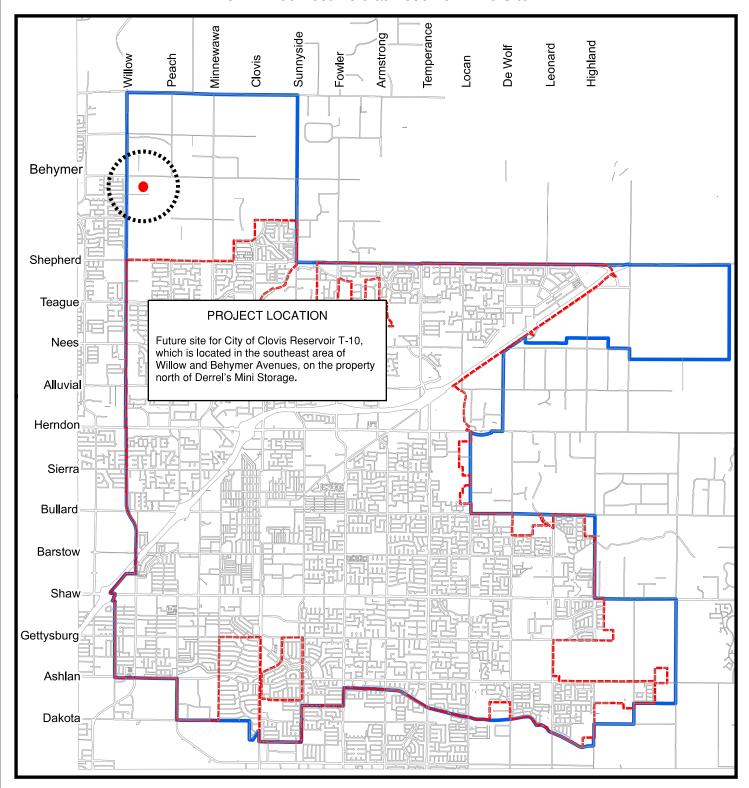

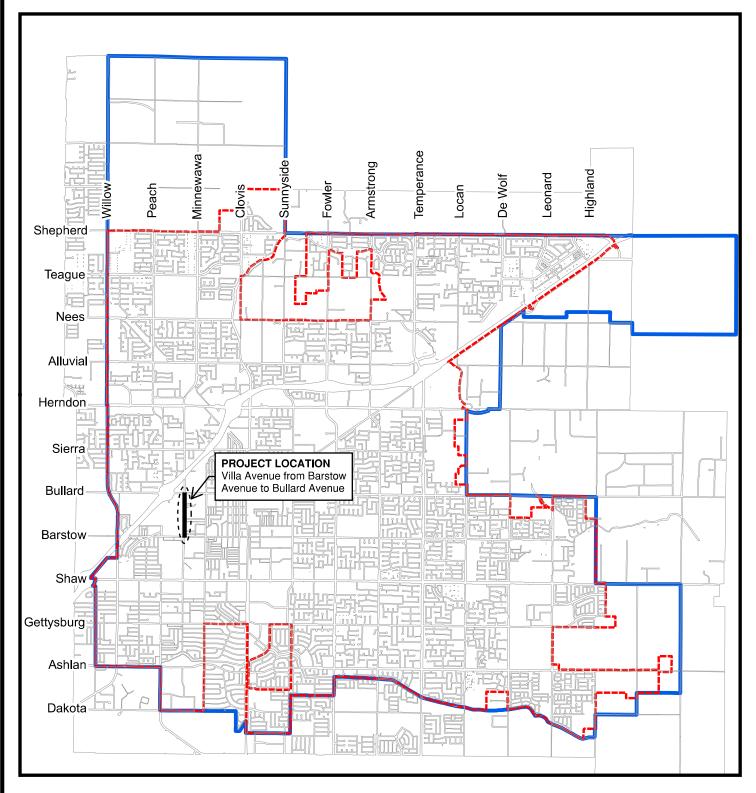

RECOMMENDATION

Staff recommends that the Planning Commission and City Council consider the information provided by staff and the City's consultant on this project and provide feedback regarding the City's current general plan.

EXECUTIVE SUMMARY

The City is considering the initiation of a general plan update and hired the DeNovo Planning Group in May of 2022 to perform an initial review of the current General Plan before establishing a work plan and scope for a subsequent update. The purpose of this review is to evaluate the current General Plan against new legislative requirements as well as local goals and objectives and then develop a set of options, strategies, and recommendations that will inform the Council as it decides how to proceed. As part of the current work effort, input from a variety of local stakeholders is being collected. The discussion at the joint meeting will provide an opportunity for Commission and Councilmembers, as well as the public in attendance, to provide feedback on key topics, issues, and local priorities that should be addressed if a new general plan update is initiated. DeNovo will assemble the information described above into a report that will be presented to the Council this spring, at which time the Council may provide direction regarding the initiation of a new general plan update.

BACKGROUND

State law requires every city and county in California to prepare and maintain a planning document called a general plan. A general plan is a "constitution" or "blueprint" for the future physical development of a county or city. All future planning decisions and project approvals must be consistent with the general plan, including, but not limited to specific plans, subdivisions, public works projects, and zoning decisions.

A general plan has four defining features:

- General. As the name implies, a general plan provides general guidance for future land use, transportation, infrastructure, environmental, and resource decisions.
- Comprehensive. A general plan covers a wide range of social, economic, infrastructure, and natural resource issues. The City's existing General Plan, which was adopted in 2014, includes the following elements: land use, economic development, circulation, housing, public facilities and services, environmental safety, open space & conservation, and air quality.
- Long-Range. A general plan provides guidance on achieving a long-range vision of the
 future for a city or county. To reach this envisioned future, the general plan includes goals
 and policies that address both near-term and long-term needs. The Clovis General Plan
 seeks to address the question: How can Clovis continue to grow and sustain the values
 that make it special?
- Integrated and Coherent. The goals and policies in a general plan must present a
 comprehensive, unified program for development and resource conservation. A general
 plan uses a consistent set of assumptions and projections to assess future demands for
 housing, employment, public services, and infrastructure. A general plan has a coherent
 set of policies that enables citizens to understand the vision of the general plan, and
 enables landowners, businesses, and industry to be more certain about how future planning
 decisions will be made and implemented.

The City of Clovis adopted its current General Plan in August 2014, which represented the first major update to the City's General Plan since 1993. As part of the 2014 General Plan, the Clovis Development Code was also extensively updated. Although the existing General Plan is less than 10 years old, there have been several factors that have resulted in growing interest by City officials, the local Building Industry Association (BIA), and other stakeholders, to update the General Plan, such as those listed below.

- Changes to housing and transportation law;
- Housing density in relation to the Sixth Cycle Housing Element;
- Environmental and land use constraints:
- Increase in requests to expand the City's sphere of influence;
- Increase in requests for general plan amendments;
- Water and infrastructure planning; and
- Redevelopment of aging shopping centers.

FISCAL IMPACT

In conjunction with the preparation of the 2014 General Plan, the Council established a funding mechanism for long-term or strategic planning efforts whereby a fee is collected on all building permits in proportion to the value of the building being constructed. Adequate funding is available through this revenue source to pay for the cost of the current work effort by DeNovo and for a subsequent general plan update if the Council chooses to initiate one.

REASON FOR RECOMMENDATION

Staff recommends that the Commission and Council discuss the information presented by staff and DeNovo and provide feedback as it deems appropriate. This feedback will be coalesced with the feedback received by other stakeholders and presented to the Council later this spring with an outline of potential options and recommendations on next steps.

ACTIONS FOLLOWING APPROVAL

A report summarizing the evaluation completed by DeNovo and outlining potential options and recommendations on next steps will be brought back to the Council later this spring.
