IT WAS MOVED BY CHAIR HERNANDEZ AND SECONDED BY VICE CHAIR GONZALEZ TO APPROVE ZONING ORDINANCE AMENDMENT NO. 24-03 RECOMMENDING TO THE CITY COUNCIL AN ORDINANCE ESTABLISHING A HEALTHY FOOD TRUCK PERMIT PILOT PROGRAM FOR CERTAIN CITY PARKS, CERTAIN PARCELS IN THE DOWNTOWN (DT-PV) AND DOWNTOWN TRANSITION (TR-PV) ZONING DISTRICTS, AND AT DATE FARMS WITH THE FOLLOWING MODIFICATIONS:

- DEFINE “HEALHY FOOD TRUCK.”
- TO ALLOW FOOD TRUCKS AT THE ARMTEC PARK AT AVENUE 53 AND TYLER STREET.
- ALLOW MORE THAN THREE (3) FOOD TRUCKS AT DATE FARMS.
- ADD LANGUAGE TO ALLOW ACCESSIBLE STANDARD PORTABLE RESTROOMS IN THE DOWNTOWN AREA.
- ALLOW OPEN FLAME COOKING IN DATE FARMS.

- ESTABLISH AN AMNESTY PROGRAM FOR EXISTING UNPERMITTED DRIVEWAY CANOPIES CONSTRUCTED PRIOR TO DECEMBER 2022.
- SEPARATION BETWEEN STRUCTURES TO BE REDUCED FROM 10’ TO 5’.
- TO PERMIT AN RV SHADE STRUCTURE ON THE SIDE SETBACK.
