RESOLUTION NO. 2022-102

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COACHELLA, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD IN SAID CITY OF COACHELLA ON THE 8th DAY OF NOVEMBER 2022, DECLARING THE RESULT THEREOF AND SUCH OTHER MATTERS AS ARE PROVIDED BY LAW

WHEREAS a regular General Municipal Election was held and conducted in the City of Coachella, County of Riverside, State of California, on Tuesday, the 8th day of November 2022, as required by law; and

WHEREAS notice of said election was duly and regularly given in time, form and manner as provided by law; voting precincts were properly established; election officers were appointed and in all respects said election was held and conducted and the votes cast thereat, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in cities; and

WHEREAS pursuant to Resolution No. 2022-60, passed and adopted the 22nd day of June 2022, the Registrar was thereby authorized to canvass the returns of said election; and

WHEREAS the Registrar has canvassed the returns of said election and has certified the results to the City Council, said results are received, attached and made a part hereof as "Exhibit A."; and

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF COACHELLA, CALIFORNIA, DOES RESOLVE A FOLLOWS:

SECTION 1. That there were twelve (12) voting precincts established for the purpose of holding said election consisting (of consolidations) of the general elections precincts in the City of Coachella as established for the holding of state and county elections.

SECTION 2. That said general municipal election was "Consolidated" and was held for the purpose of:

- 1. Electing the following officers of said City as required by the laws relating to cities in the State of California to wit:
 - One (1) Mayor for the full term of two (2) years; and
 - Two (2) Members of the City Council for the full term of four (4) years.

SECTION 3. The whole number of votes cast in said City was 0,000; and

SECTION 4. That the names of persons voted for at said election for Mayor of the City of Coachella are as follows:

SECTION 5 That the number of votes given at each precinct and the number of votes given in the City to each of such persons and have named for the respective offices for which said persons were candidates were as listed in Exhibit "A" attached.

- Steven A. Hernandez was elected as Mayor of the City of Coachella for the full term of two years; and
- Frank Figueroa was elected as Member of the City Council of the City of Coachella for the full term of four years; and
- Stephanie Virgen was elected as Member of the City Council of the City of Coachella for the full term of four years.

SECTION 6. The City Clerk shall enter on the records of the City Council of said City, a statement of the results of said election, showing:

- 1. The whole number of votes cast in the City;
- 2. The names of the persons voted for;
- 3. For what office each person was voted for;
- 4. The number of votes given at each precinct in the City to each person.

SECTION 7. That the City Clerk shall immediately make and deliver to each of such persons so elected a Certificate of Election signed by the City Clerk and duly authenticated; that the City Clerk shall administer to each person elected, the Oath of Office prescribed in the State Constitution of the State of California and shall have them subscribe thereto and file the same in the office of the City Clerk. Whereupon, each and all said persons so elected shall be inducted into the respective office to which they have been elected.

SECTION 8. That the City Clerk shall certify to the passage and adoption of this resolution; shall enter the same in the book of original Resolutions of said City; and shall make a minute order of the passage and adoption thereof in the records of the proceeding of the City Council of said City, in the minutes of the meeting at which the same is passed and adopted.
