
There being no further business to come before the City Council and the Agencies, Mayor Hernandez adjourned the meeting at 10:10 p.m.





He attended the film program at Cal State University of Long Beach, and the lack of diversity in student films inspired him to embrace who he was and where he came from. Seeking representation in film, he felt an urgency to make films that his family and Spanish speaking audiences could see and feel included in. He began to write and direct films that showcased underrepresented and diverse characters. His Thesis Film, "La Paz" was screened nation wide on PBS and won the Cal Arts Rosebud Award for best Student Short Film.

Xiomara Castro is a published writer, independent film producer and paralegal currently living in Los Angeles.



BACKGROUND:

In conjunction with the fiscal year budget, each year the City of Coachella, Coachella Sanitary District and Coachella Fire Protection Districts are required to establish their appropriations limit by resolution. For fiscal year 2018-19 the appropriations limits were as follows:

City of Coachella - \$40,119,876 Coachella Fire Protection District - \$3,542,513 Coachella Sanitary District - \$6,553,903

The formula used to adjust the limit for fiscal year 2019-20 is the change in the California Per Capita Personal Income as calculated by the California Department of Finance (3.85%) multiplied by the City of Coachella's population growth factor (1.25%) again as published by the California Department of Finance. For the 2019-20 fiscal year the calculation results in an increase factor of 1.0515. Multiplying the 2018-19 appropriation limits by the increase factor increases the appropriations limit for the 2019-20 fiscal year as follows:

City of Coachella - \$42,185,297 Coachella Fire Protection District - \$3,724,886

CalRecycle Grants for Which the City of Coachella is Eligible

STAFF RECOMMENDATION:

It is recommended that the City Council adopt Resolution No. 2019-28 authorizing the submittal of application(s) for all CalRecycle grants for which the City of Coachella is eligible.

BACKGROUND:

The Department of Resources Recycling and Recovery (CalRecycle) offers the Tire- Derived Product Grant Program pursuant to Sections 42872, 42873, and 42889 of the Public Resources Code. The purpose of the grant is to decrease the adverse environmental impacts created by the unlawful disposal and stockpiling of waste tires. Funding available for individual grant awards is \$150,000 and it is a reimbursement grant.

DISCUSSION/ANALYSIS:

The City of Coachella is eligible to apply for grant funding from the Department of Resources, Recycling and Recovery (CalRecycle). The Parks Division requested to seek a CalRecycle Tire-Derived Product grant to purchase and install colorized "rubber mulch" for the Rancho De Oro Park and Dateland Park playgrounds to replace the current used shredded wood chips. The shredded bark compresses and dissipates each year and requires annual replenishment. The rubber mulch provides a superior fall surface and only slightly compresses and dissipates. Installing the rubber mulch will reduce maintenance costs and will increase safety. The product is considered environmentally friendly and has a minimum twelve (12) year lifecycle. Reducing the annual need for replacement mulch will save money each year in materials and labor costs.

FISCAL IMPACT:

The total projected cost for the rubber mulch installation at Rancho De Oro and Dateland parks is \$117,531. A grant application has been submitted to CalRecycle under its Tire-Derived Product grant program. The grant will help offset part of the costs associated with installing the recycled rubber mulch at the playgrounds. Notification of award will be issued in August 2019. In addition, the grant application has a secondary submission date of June 13, 2019 so that applicants have a chance to ask their governing bodies to adopt a resolution authorizing the submission of an application or to adopt an Environmentally Preferable Purchasing and Practices Policy (EPPPP), if they do not have them in place. If the resolution is adopted, City staff has until June 13th to send the adopted resolution to CalRecycle.

STAFF RECOMMENDATION:

Staff recommends the City Council adopt Resolution No. 2019-31, approving the application for Statewide Park Development and Community Revitalization Program Grant Funds for Central Park

BACKGROUND:

On November 6, 2018, the California voters approved Proposition 68, which created a grant program to fund the creation or renovation of parks in California. The grant is administered by the California Department of Parks and Recreation (CDP&R). An applicant will be considered for the grant if they satisfy one of two requirements. The applicant must have either a ratio of less than 3 acres of park space per 1,000 residents, or a median household income lower than \$51,026. Based on staff's review utilizing the CDP&R Community Factfinder (a tool used to determine eligibility), the City satisfies the requirements to apply for two new parks—one at Avenue 52/Education Way (for grant identification purposes, this park site is labeled, "Central Park") and the other would be the expansion of Rancho Las Flores Park (or Rancho Las Flores Park Phase II).

DISCUSSION/ANALYSIS:

The City of Coachella will be filing two grant applications under this program. The applications must be accompanied by an Authorizing Resolution approved by the City Council, which serves several purposes. First, the Authorizing Resolution acts as a form of proof to the State that the application is formally authorized by the entity. Second, it designates a staff member as the point person, to authorize different aspects of the application and to serve as a contact reference for the State. Finally, the Authorizing Resolution serves to show the State the City Council is aware of, and understands that, completion of the Grant requires the City enter into a contract with the State. Following the signing of the contract, the City will receive a deed restriction/grant notice to record on title to the property requiring the City to maintain the improvements made with the grant money for a period of 30 years, starting from the date of appropriation of grant funding.

ITEM 12.d.

To approve the Authorizing Resolution, the City Council must make the following findings:

- 1. The City has, or will have, available, prior to commencement of any work on the project, sufficient funds to complete the project; and
- 2. If the projects are awarded, then the City has, or will have, sufficient funds to operate and maintain the projects for the required 30 years; and
- 3. The City has reviewed, understands, and agrees to the General Provisions contained in the contract shown in the Grant Administration Guide. Staff recommends the City Council make the required findings and approve the Authorizing Resolution to apply for the grant funds.

STAFF RECOMMENDATION:

Staff recommends the City Council adopt Resolution No. 2019-31, approving the application for Statewide Park Development and Community Revitalization Program Grant Funds for Rancho Las Flores Park Phase II.

BACKGROUND:

On November 6, 2018, the California voters approved Proposition 68, which created a grant program to fund the creation or renovation of parks in California. The grant is administered by the California Department of Parks and Recreation (CDP&R). An applicant will be considered for the grant if they satisfy one of two requirements. The applicant must have either a ratio of less than 3 acres of park space per 1,000 residents, or a median household income lower than \$51,026. Based on staff's review utilizing the CDP&R Community Factfinder (a tool used to determine eligibility), the City satisfies the requirements to apply for two new parks—one at Avenue 52/Education Way (for grant identification purposes, this park is being labeled "Central Park") and the other would be the expansion of Rancho Las Flores Park Phase II.

DISCUSSION/ANALYSIS:

The City of Coachella will be filing two grant applications under this program. The applications must be accompanied by an Authorizing Resolution approved by the City Council, which serves several purposes. First, the Authorizing Resolution acts as a form of proof to the State that the application is formally authorized by the entity. Second, it designates a staff member as the point person, to authorize different aspects of the application and to serve as a contact reference for the State. Finally, the Authorizing Resolution serves to show the State the City Council is aware of, and understands that, completion of the Grant requires the City enter into a contract with the State. Following the signing of the contract, the City will receive a deed restriction/grant notice to record on title to the property requiring the City to maintain the improvements made with the grant money for a period of 30 years, starting from the date of appropriation of grant funding.

- 1. The City has, or will have, available, prior to commencement of any work on the project, sufficient funds to complete the project; and
- 2. If the projects are awarded, then the City has, or will have, sufficient funds to operate and maintain the projects for the required 30 years; and
- 3. The City has reviewed, understands, and agrees to the General Provisions contained in the contract shown in the Grant Administration Guide. Staff recommends the City Council make the required findings and approve the Authorizing Resolution to apply for the grant funds.

STAFF RECOMMENDATION:

It is recommended that the City Council approve the recommended mid-year budget adjustments and adopt Resolution No. 2019-33 amending the budget for Fiscal Year 2018-2019.

BACKGROUND:

As the City approached the middle of the fiscal year, City of Coachella finance staff evaluated the adopted budget, revenue projections, and economic conditions for the remainder of the fiscal year. It is standard procedure to perform a mid-year review of the City's budgetary and financial position to ensure any deviations from the initial budget projections are proactively addressed. Staff also reviews requests for appropriations to address new priorities that are unfunded or underfunded.

DISCUSSION/ANALYSIS:

Revenues

Recommended mid-year revenue budget increases:

- General Fund of \$252,099. The increase is expected in three revenue categories: Taxes \$125,000, Charge for Services \$100,000, and Public Safety Grants \$27,099.
- An increase in fund 961 JPA Waste Transfer Fund of \$3,500 for interest revenue.

Expenditures

- An increase to General Fund for the amount of \$452,073 to cover increases in professional and legal services and payroll benefits in various departments.
- An increase of \$300,000 to fund 126 Park Improvement DIF, a transfer out for the payment of the Project P-25 NE Cesar Chavez & Sixth Street. The transfer will be cover with available funds.
- An increase of \$148,293 to fund 182 Capital Improvements for the Senior Center Expansion.
- An increase of \$569 to fund 240 Fire Department to cover additional increase in CalFire contract.
- An increase of \$690,000 to fund 961 JPA Waste Transfer Station to stablish budget for Fiscal Year 2018-2019.

STAFF RECOMMENDATION:

DISCUSSION/ANALYSIS:

On April 10, 2019, the City of Coachella along with its component units (Sanitary District, Educational & Governmental Access Cable Corporation, Fire Protection District and Water Authority) approved and adopted the current "Statement of Investment Policy".

Pursuant to Section 16 of that policy, the City Treasurer shall provide to the City Council a monthly investment report which provides a clear picture of the status of the current investment portfolio. This report shall include, at a minimum, the following information for each type of investment held in the City's investment portfolio: the issuer; amount of investment; current market value; yield on investment; income generated from investments; dollar amount invested on all securities, investments and moneys held by the local agency; and shall additionally include a description of any of the local agency's funds, investments, or programs; and a description of unusual investment activity or developments during the month for which the report is prepared. This information shall be provided for all City and component unit pooled investments, as well as for bond accounts, which are managed by outside Fiscal Agents.

The interest rates presented are the most current rates available as of the date of these reports. The market values presented for pooled City investments are based on closing prices for the related investments as of the date of these reports. This information was obtained from the Wall Street Journal or other reliable sources of market prices.

The Market values presented for investments managed by contracted parties are based on amounts reported by the Fiscal Agent on the most recent bank statement to be market value as of the date of said bank statement. The purchase date and type of investment is not included for funds held by the fiscal agent.

Attached is the Treasurer's Report of Investments which includes an overview on investments which provides information on investment activity, withdrawals and deposits, interest earned, payment of interest and payment of principal as of the period ending February 28, 2019. In addition, this report includes detailed information and current activity on individual investments.

STAFF RECOMMENDATION:

Staff recommends that the City Council consider increasing the Community Based Grant Fund by \$5,000 in order to be able to support additional nonprofit funding requests.

BACKGROUND:

The Community Based Grant Program was established in 2010 and allows the City of Coachella to offer financial assistance to local nonprofit organizations, schools, youth-serving organizations, and other community-based organizations that provide essential services, programs and activities to residents in Coachella. Applicant organizations are only eligible to submit one application for consideration each fiscal year and must be legally established with non-profit or tax-exempt status, be based in the Coachella Valley, or provide direct service to Coachella residents. Approval of grant funds does not constitute a precedent for grant allocations in subsequent years. All CBG grants are reimbursement grants to ensure that applicants are meeting their stated goals. The FY 18-19 budget included an allocation of \$15,000 for the Community Based Grant Program.

DISCUSSION/ANALYSIS:

The fund balance for this program has been exhausted and staff was directed to request an additional \$5,000 dollars to support additional nonprofit requests received during the City Council meeting held on May 8, 2019.

ALTERNATIVES:

- 1. Authorize increasing the Community Based Grant Program Fund by \$5,000 in order to support additional nonprofit funding requests.
- 2. Do not authorize increasing the Community Based Grant Program Fund by \$5,000.

Annual Budget

STAFF RECOMMENDATION:

Adopt Resolution No. 2019-27 approving the annual budget, organizational structure, and policy changes for fiscal year 2019-20 for the City of Coachella and its component units.

BACKGROUND:

I am pleased to submit for your review the proposed budget for the City of Coachella for all funds and departments and its component units for the fiscal year beginning July 1, 2019 and ending June 30, 2020.

For 2019-20, the City of Coachella and all its component units have achieved a balanced budget. The budgeted revenues of \$25,893,251 are balanced to the appropriation of \$24,317,352 with restricted reserves of \$15,721,019 and unrestricted reserves of \$9,989,017. Details are provided in the general fund schedules and tables that follow.

HISTORY

During the prior two fiscal years, FY 2016/2017 and FY 2017/2018 the City of Coachella has seen a steady recovery for our community. The prolonged slow recovery from the recession continues to affect our local economy. The voters passed Measure U, a sales tax rate increase of 1% in November of 2014. These funds were critical in allowing us to finish the year within budget. However, the City during these two fiscal years incurred steep increases in our contracts with Riverside County Sheriff and Riverside County/Cal Fire for Police and Fire services. The Police Department expenditures increased by \$279,020 (3.41%) and the Fire Department Expenditures increased by \$45,940 (3.03%) for a combined total of \$324,960 or a 3.35% increase in Public Safety expenditures. The sales tax revenue will allow the City to cover the increase in FY 2018/2019 public safety costs with only limited reductions of service level but these Public Safety contracted service increases by Riverside County are not sustainable over time

In the 2009/10 budget, the Council further reduced general fund expenditures by \$1.6 million. The City eliminated 19 positions in public safety, code enforcement, finance, community development, fleet maintenance, City Clerk, and the City Manager's Office. Service levels were

cut due to mandatory furloughs and the associated reduction in hours at City Hall and other City locations. Many cities in the Coachella Valley and throughout California experienced similar shortfalls and severe reductions.

In January of 2010 a midyear series of cuts were necessary as the State and National economy continued to erode. The City Council reduced general fund expenditures by an additional \$1.16 million. A Utility Users Tax was placed on the June 8, 2010 ballot in order to forestall service reductions especially in the area of public safety. The Utility Users Tax, it was approved by the voters on June 8, 2010, by a 56% to 44% margin.

For FY 2019/20, the City of Coachella and all its component units have achieved a balanced budget due to the Council's passage of severe austerity measures during the past 6 years and the people of Coachella choosing to tax themselves to avoid further and more adverse service level reductions. While the City's contracted Public Safety services did go up by \$992,772 for the 2018/19 fiscal year due to increase in service cost it is anticipated that in FY 2019-20 expenditures will increase by \$575,313 due to Riverside County shifting more cost recovery on to its contract cities. We are ending the year under budget and it will increase our reserves by \$1,419,301 (see page 50 of the budget), which includes several funds. The general fund budgeted revenues of \$25,893,251 are above the appropriation of \$24,317,352. Details are provided in the general fund schedules and tables that follow.

ECONOMIC FORECASTS

California's diverse economy continues to expand as job creation remains strong and pushes the state towards pre-recession unemployment levels. In fact, California's economy slightly outpaced the nation's economy by 0.01 percent in the 2017 year and appears to be trending toward a year in which production of goods and services are above normally expected levels – a concept known as "full employment". This is expected to continue all the way through 2019.

Of the metropolitan areas in California, forecasters expect to see Riverside County increase across the board through the year 2022:

- 2% rise in salaries
- 3% employment gains, strongest in California
- 1.2% population increase, which includes migration from other counties
- 1.4% rise in real per capita income
- 2.5% increase in taxable sales
- 2.9% growth rate of industrial production

While dropping, unemployment in Coachella remains at just under 8.5%, as of March 2017. What has helped increase our employment has been the strength and growth of the hospitality and convention industry in the rest of the Coachella Valley. Hotel bookings are up considerably and the Palm Springs Airport has seen record highs in the number of flights and passengers. The fluctuating price of gasoline has made it difficult to accurately forecast sales tax revenues. The City relies heavily on Gas Tax revenues as it is the second largest contributors to the General Fund behind Sales Tax. Several new retail establishments are either in the process of opening or

are under construction and there has been a steady increase in the number of commercial building permits and general construction activity.

The elimination of the Redevelopment Program by the State of California had a devastating impact on our economic development programs and efforts. We had lost our economic development staff, housing program, downtown redevelopment program, business incentive programs and low and moderate income housing programs. In FY 2014, we added an Economic Development Manager and have established at least one business incentive program called Seismic Property Improvement Program to rehabilitate some of our older commercial buildings located downtown. We continue to explore ways to strengthen the local economy but are doing so without the financial resources or staff resources we previously relied upon.

We anticipate that there will not be a dramatic improvement in the condition of the local economy in the near term. The La Entrada project will have a significant impact on our community, but it is 12 to 24 months from commencement of construction. Commercial development will increase as capital becomes available and should provide some relief in the area of construction and real estate. Overall we anticipate a flat year with gradual relief in the area of unemployment and housing. However, the recovery in the financial industry is a positive sign, but this could be moderated if the Federal Reserve loosens restrictions on interest rates in the coming year.

The City of Coachella will endeavor to maintain a diversified and stable revenue base to minimize the effects of economic fluctuation. All estimates are conservative and based on historical perspectives.

General fund revenues are in seven broad categories: Taxes, Charges for Services, Fines and Forfeitures, Intergovernmental, Use of Money and Property, Other Revenues and Operating Transfers.

Intergovernmental revenues are substantial in comparison to other categories. The general fund's position as the originating fund for all service components, i.e., Water, Sanitary, Fire, Police, Streets, and Redevelopment efforts has resulted in the general fund now receiving service charges from all funds. The process of ending Redevelopment has resulted in a significant loss of administrative funds. There are funds available to perform administrative and legal activities required to dispose of assets and restructure financing but they are limited and do not cover the full cost of the dissolution. The City's 80 employees' salary costs are disbursed among 16 different departments and funds to be able to ascertain both direct and indirect costs from the family of employees to the City services rendered.

GENERAL FUND EXPENDITURES BY DEPARTMENT

The general fund is the main operating fund of the City of Coachella. It is used to account for all financial resources except where legal, administrative or Generally Accepted Accounting Principles (GAAP) requirements cause them to be accounted for in another fund.

The City's general fund activity includes departments that serve the general public as well as functions that provide administrative support to the various departments within the government and its agencies. The table shown below provides a summary list of the general fund Departments and their respective budgets.

OTHER FUNDS

The City has various funds and special districts which are designated subdivisions of the general fund or are classified as component units. These other funds all have the Coachella City Council as its governing body and these have their respective budgets approved by the Council for the fiscal year ended June 30, 2020.

SPECIAL REVENUE FUNDS

Special revenue funds are used to account for the proceeds of specific revenue sources that are legally restricted for specific purposes. Special Revenue funds include State and Federal grants and subventions, impact fees, funds to be used solely for capital projects, and the property taxes

and charges collected by the County Tax-Collector's Office for the Coachella Redevelopment Agency, the Coachella Sanitary District, and the Coachella Fire Protection District.

Capital Improvement Funds are used to account for project costs of permanent general or enterprise fund resources used for the building of infrastructure to attract business and expand capacities. The Capital Improvement Program found in the last tab is a listing of proposed and existing projects for the acquisition and construction of capital assets. These programs are outlined in the proposed five-year capital budget and existing capital projects. The five-year Capital Improvement Plan includes proposed financing for the 2019-20 fiscal year with projected revenue sources and project costs for the next four fiscal years. The Public Works, Engineering Department has provided a comprehensive capital improvements plan that utilizes bond proceeds from previous issuances, developer impact fees, grants, redevelopment funds and self-generated funds from the City's enterprise operations. Although the funds required for the proposed fiscal year projects are available, future year's projects may have a "To Be Determined" footnote if funds have not yet been identified.

GENERAL FUND

Individual general fund departments have included their accomplishments for the current fiscal year, their goals for the 2019-20 budget year and are presenting budget issues to the Council for your review and approval that will allow the Council to standardize future budget matters and keep the Council's policies in line with the City's priorities.

STAFF RECOMMENDATION:

BACKGROUND:

The Coachella Fire Protection District (the District) was created in December 1990 to provide fire protection services to the residents of the City of Coachella. The District is considered a component unit of the City of Coachella for financial reporting purposes. The Riverside County Fire Protection District provides all necessary services that are described in a contract between the two entities. Governance is provided by the City Council whose members also serve as the District's Board of Directors. The board funds the District through transfers from the City's general fund, property tax collected, interest earned on investments, and miscellaneous sources. Fixed assets include structures and equipment that existed prior to the contract with the County Fire Protection District.

The District utilizes the same Fiscal Control Ordinance, as adopted by the City, which provides for a system of fiscal and budgetary controls.

The District is currently staffed by one (1) engine company that staffs two (2) captains, two (2) engineers, one (1) engineer medic, two (2) firefighter II and three (3) firefighter II medic positions.

In addition to the staffed positions, an active volunteer program boasts a company that consists of a staff of approximately 20 volunteer firefighters.

BACKGROUND:

On July 11, 2011, the City Council adopted Resolution 2011-13, adopting the City's current user fees. On March 28, 2012, the City Council approved Resolution 2012-25 and Resolution 2013-18 modifying the existing user fees with a 50% reduction. As of July 9, 2013, this interim reduced user fee was extended until June 30, 2014 as per Resolution 2013-42. On May 28, 2014, this extension was again extended for park user fees per Resolution 2014-24 through June 30, 2015 and resolution 2017-26 was adopted in 2017 extending a 20% park use fee reduction for youth sports leagues in the City MOU.

DISCUSSION/ANALYSIS:

Current City of Coachella park user fees for youth sports leagues are: \$6.40/per field/hour and \$14.40/per field/per hour. Staff has surveyed various Coachella Valley cities and provided their rates below for sport league Park Field Use and Park Field Lighting Use.

Prior to 2011 the sports leagues did not pay for use of the city's facilities. Thus, the above extensions have been approved to allow the sports leagues to adjust to what has been a change of culture and standard operating procedures. All City user fees with the exception of park user fees had begun to be collected without reduction since July 1, 2013. On June 23, 2015, the Parks and Recreation Commission recommended amending the reduction percentage for City Park User Fees from 50% to 20%, excluding the Snack Bar and any Adult League use which was recommend be set to 0% reduction. Council action on July 8, 2015, supported the Commission's recommendation and the user fees were set at the below rates through June 30, 2017. On April 26, 2017, Council action approved a 20% park use fee reduction for youth sports leagues in the City MOU. Staff recommended retaining the 20% reduction for Park User Fees charged to Youth MOU Sport Leagues for Sport Field and Lighting use. At the April 16, 2019 Parks and Recreation Commission, the Commission recommended approval of a 50% reduction for youth sports leagues in the City MOU and charging all other park uses and users at the originally approved rate without reduction. Staff recommends approval of the attached resolution and recommends these changes be effective June 1, 2019 through June 30, 2020.

FISCAL IMPACT:

The proposed recommendation will have a negative financial impact on estimated general fund revenues in the amount of \$30,000.00.

In no case shall the fee exceed the old fee in place prior to May 11, 2011. All other fees described in Resolution 2011-13 shall remain in full force and effect.
- **Section 2. Effective Dates.** The interim fees established herein shall become effective on June 1, 2019 and shall expire on June 30, 2020.
 - **Section 3.** Certification. The City Clerk shall certify to the adoption of this Resolution.

SUBJECT: Resolution No. 2019-30 of the City Council of the City of Coachella, California,

Objecting to the Public Sale of a Developed Parcel of Land Located at 85-811 Grapefruit Boulevard (Assessor Parcel Number 778-061-001-4), and Authorizing the Purchase of the Parcel From the Riverside County Treasurer-Tax Collector.

STAFF RECOMMENDATION:

Staff recommends that the City Council approve Resolution 2019-30 with the findings of the attached draft resolution authorizing the City Manager to execute and deliver the Agreement of Sale and any other necessary documents to purchase the property at 85-811 Grapefruit Boulevard for public purposes.

BACKGROUND:

In October 2018 the City of Coachella was notified by the Riverside County Treasurer – Tax Collector of all the properties within Riverside County that are eligible for tax sale as of July 1, 2018. The City is periodically notified of these upcoming tax auctions because a local government agency, as well as any Non-Profit Organization, may purchase these parcels through a Chapter 8 Agreement of Sale with the County Board of Supervisors, consistent with regulations contained in §3351 through §3972 of the California Revenue and Taxation Code.

DISCUSSION/ANALYSIS:

Upon reviewing the list of properties sent to the City by the Riverside County Treasurer, staff found Assessor Parcel Number 778-061-001-4 which is the site of an older auto repair building located at 85-811 Grapefruit Boulevard (ARS Auto Repair). City senior staff recently inspected the site and surveyed existing conditions of the exterior of the building and parking lots which are in plain view from the streets.

After further internal discussions, staff notified the County Treasurer that the City has an interest in purchasing the parcel prior to the Tax Sale Auction in order to build public parking for the Pueblo Viejo area. The City has been working with existing business owners in light of new businesses proposing to occupy older buildings along 6th Street which have an inadequate amount of off-street parking. There is a need to address the need for more public parking due to the rehabilitee of these older buildings and the proposed property purchase could assist in providing public parking.

As such, the acquisition of the auto repair building can serve the City's growing needs for public parking needs, and presents an opportunity to create public parking within 600 feet of businesses in the vicinity of 6th Street and Grapefruit Boulevard.

In order for the City to enter into an Agreement of Sale for this parcel, the County Treasurer needs a resolution from the City Council stating that the City objects to the public sale of the parcel. The resolution should further show an offer to purchase the property, including the estimated purchase price, legal description, Assessor Parcel Number, and the public purpose for which the land is to be devoted. The resolution must state that the costs of giving notice shall be paid by the City. In addition to the resolution, the State requires a separate Mission Statement to be submitted as part of the agreement. This must be on official City Letterhead, and is attached to this staff report.

REQUESTED ACTION:

Staff has prepared the attached Resolution No. 2019-30 for Council's review and approval, making the necessary objection to the public sale of Assessor Parcel Number 778-061-001-4 and making a concurrent offer the parcel in question from the Riverside County Treasurer-Tax Collector. The attachment to the resolution identifies the property in question, with legal description and outstanding tax delinquency. The stated "5th Street Public Parking Lot" to be located at the southwest corner of Grapefruit Boulevard and 5th Street to serve as "public parking" for the "Pueblo Viejo" central business district and the Coachella Civic Center.

FISCAL IMPACT:

On May 1, 2019 the County Treasurer sent the City a quote for purchase of the parcel in question. The total outstanding taxes, plus the current taxes, is \$35,3283.69 for the parcel. However, if the owner or any trustee cures the tax deficiency prior to the tax sale, the City would be notified about any outstanding notes payable on the property and the City could then rescind its offer to purchase. Additionally, the City would be responsible for paying the costs of publication of notices and related administrative fees. Staff proposes to pay for the purchase of this property from the City's General Government Facilities - Development Impact Fee account.

SUBJECT: Roots Retail Cannabis Microbusiness and Café Project

1) Conditional Use Permit (CUP 306) to allow a 4,080 square foot retail cannabis microbusiness consisting of retail space, coffee shop, delivery office, conference rooms, offices, manufacturing space and a parking lot in a vacant building located at 791 Orchard Avenue.

2) Change of Zone (CZ 18-04) to add the RC (Retail Cannabis) overlay zone to the existing R-M (Multiple Family Residential) zone at 791 Orchard Avenue.

STAFF RECOMMENDATION:

Staff recommends that the City Council continue this item to the regular City Council meeting of June 12, 2019.

BACKGROUND AND UPDATE:

This item was continued from the May 8, 2019 City Council meeting, at the request of the applicant, who stated that the company shareholders are exploring the option of relocating the proposed business to a new location. Since the negotiations for the prospective new business location will require additional time, the owners have requested another continuance of this public hearing item, to allow them to make the necessary business decisions on whether to withdraw the pending applications for Change of Zone 18-04 and Conditional Use Permit No. 306.

STAFF CONCLUSIONS:

Staff is not opposed to allowing the applicant more time to be responsive to the public concerns registered at the May 8, 2019 public hearing by Mr. Daniel Gutierrez and some members of the City Council regarding the potential incompatibility of a proposed cannabis dispensary near Veterans Park and adjoining residences.

Accordingly, staff recommends that the City Council continue this item to the next regular meeting of June 12, 2019.
