













CITY OF LA QUINTA 10 YEAR EXPANSION PLAN (2022-2031)



~ 60% LOWER than SCE




Electric Rate Comparison


IID and State Averages

- IID's average system electric rate is 12.25¢/kWh
- IID's rates compare favorably to those of neighboring investor-owned utilities
- Residential electricity rates in California average 19.82¢/kWh, which ranks the state 7th highest in the nation


Medium Commercial (300 KW / 100,000 kWh)
